1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. Task force.** The Department of Labor, Department of Education, Department
3 of Health and Human Services and Maine State Housing Authority shall establish a task
4 force to develop a statewide plan to assist immigrants who need housing, job training,
5 language skills and transportation. The task force may invite the participation of other
6 stakeholders in the work of the task force.

7 **Sec. 2. Appropriations and allocations.** The following appropriations and
8 allocations are made.
