It also removes the funding source for the Municipal Grant Fund and replaces it with the ability for the fund to receive funds from appropriations, allocations, grants or gifts from any federal agency or governmental subdivision or the State or its agencies. Initial funding comes from the Federal Government through stimulus or relief funds received by the State in 2021 to counter the effects of the COVID-19 pandemic and eligible for the purposes of the Municipal Grant Fund. It also adds an appropriations and allocations section.
