18	PSYCHOLOGY INTERJURISDICTIONAL COMPACT
19	<u>§3841. Short title; legislative intent; declaration of purpose - Article 1</u>
20 21	<u>1.</u> Short title. This subchapter may be known and cited as "the Psychology Interjurisdictional Compact."
22 23 24 25 26 27	2. Legislative intent. This compact is the Maine enactment of the Psychology Interjurisdictional Compact, which is referred to in this subchapter as "the compact." The form, format and text of the compact have been changed minimally so as to conform to the Maine Revised Statutes. The changes to the compact are technical in nature, and this Act must be interpreted as substantively the same as the compact that is enacted by other compact states.
28 29 30	3. Purpose. The compact protects the public through the verification of education, training and experience and ensures accountability for the professional practice of psychology.
31	A. The compact:

1 2 3 4	(1) Regulates the day-to-day practice of telepsychology, that is, the provision of psychological services using telecommunications technologies by psychologists across state boundaries in the performance of their psychological practice as assigned by an appropriate authority;
5 6 7 8	(2) Regulates the temporary in-person, face-to-face practice of psychology by psychologists across state boundaries for 30 days within a calendar year in the performance of their psychological practice as assigned by an appropriate authority;
9 10 11	(3) Authorizes state psychology regulatory authorities to afford legal recognition, in a manner consistent with the terms of the compact, to psychologists licensed in another state;
12 13 14	(4) Recognizes that states have a vested interest in protecting public health and safety through their licensing and regulation of psychologists and that such regulation will best protect public health and safety;
15 16	(5) Does not apply when psychologists are licensed in both their home state and receiving states; and
17 18	(6) Does not apply to ongoing in-person, face-to-face practice but allows for authorization of a temporary psychological practice.
19	B. The compact is designed to achieve the following purposes and objectives:
20 21 22 23	(1) To increase public access to professional psychological services by allowing for telepsychological practice across state lines as well as temporary in-person, face-to-face services in a state in which the psychologist is not licensed to practice psychology;
24 25	(2) To enhance a state's ability to protect public health and safety, especially client safety;
26 27	(3) To encourage the cooperation of compact states in the areas of psychology licensure and regulation;
28 29	(4) To facilitate the exchange of information between compact states regarding psychologist licensure, adverse actions and disciplinary history;
30 31	(5) To promote compliance with the laws governing psychological practice in each compact state; and
32 33	(6) To invest all compact states with the authority to hold licensed psychologists accountable through the mutual recognition of compact states' licenses.
34	<u>§3842. Definitions - Article 2</u>
35 36	As used in this subchapter, unless the context otherwise indicates, the following terms have the following meanings.
37 38 39	1. Adverse action. "Adverse action" means any action taken by a state psychology regulatory authority that is identified by the state psychology regulatory authority as discipline for a violation of a statute or regulation and that is a matter of public record.
40 41	2. Association of State and Provincial Psychology Boards. "Association of State and Provincial Psychology Boards" means the recognized membership organization

6 7	4. Bylaws. "Bylaws" means the bylaws established by the commission pursuant to section 3850 for its governance or for directing and controlling its actions and conduct.
8 9 10	5. Client. "Client" means the recipient of psychological services, whether psychological services are delivered in the context of health care, corporate, supervision or consulting services.
11 12	<u>6. Commission.</u> "Commission" means the Psychology Interjurisdictional Compact Commission established by section 3850, which is the governing body of the compact.
13 14	7. Commissioner. "Commissioner" means the voting representative appointed by each state psychology regulatory authority pursuant to section 3850.
15 16 17	8. Compact state. "Compact state" means a state, the District of Columbia or a United States territory that has enacted the compact and that has not withdrawn pursuant to section 3850-C, subsection 3 or has not been terminated pursuant to section 3850-B, subsection 2.
18 19	9. Confidential. "Confidential" means the principle that data or information is not made available or disclosed to unauthorized persons or processes.
20 21 22 23	10. Coordinated database. "Coordinated database" means the coordinated licensure information system described in section 3849, which is an integrated process for collecting, storing and sharing information on psychologists' licensure and enforcement activities related to psychology licensure laws.
24 25	<u>11.</u> Day. "Day" means any part of a day in which psychological services are performed.
26 27 28	12. Distant state. "Distant state" means a compact state where a psychologist is physically present, not through the use of telecommunications technologies, to provide temporary in-person, face-to-face psychological services.
29 30 31 32	13. E-passport. "E-passport" means a certificate issued by the Association of State and Provincial Psychology Boards that promotes the standardization in the criteria of interjurisdictional telepsychology practice and facilitates the process for licensed psychologists to provide telepsychological services across state lines.
33 34 35	14. Executive board. "Executive board" means a group of directors elected or appointed to act on behalf of, and within the powers granted to them by, the commission pursuant to section 3850, subsection 5.
36 37 38 39 40 41 42	15. Home state. "Home state" means a compact state where a psychologist is licensed to practice psychology. If the psychologist is licensed in more than one compact state and is practicing under the authority to practice interjurisdictional telepsychology, the home state is the compact state where the psychologist is physically present when the telepsychological services are delivered. If the psychologist is licensed in more than one compact state and is practicing under the temporary authorization to practice pursuant to section 3845 the home state is any compact state where the psychologist is licensed.

"Interjurisdictional practice certificate" means a certificate issued by the Association of State and Provincial Psychology Boards that grants temporary authorization to practice based on notification to the state psychology regulatory authority of intention to practice temporarily and verifies the qualifications for such practice.
13 14	19. License. "License" means authorization by a state psychology regulatory authority to engage in the independent practice of psychology.
15 16	20. Non-compact state. "Non-compact state" means any state that is not a compact state.
17 18	21. Psychologist. "Psychologist" means an individual licensed for the independent practice of psychology.
19 20	22. Receiving state. "Receiving state" means a compact state where the client is physically located when telepsychological services are delivered.

"Rule" means a written statement by the commission, promulgated pursuant to section 3850-A, that is of general applicability, implements, interprets or prescribes a policy or provision of the compact or an organizational, procedural or practice requirement of the commission. A rule has the force and effect of statutory law in a compact state and includes the amendment, repeal or suspension of an existing rule.
26 27	24. Significant investigatory information. "Significant investigatory information" means either:

Investigative information that a state psychology regulatory authority, after a preliminary inquiry that includes notification and an opportunity to respond if required by state law, has reason to believe, if proven true, would indicate more than a violation of state statute or ethics code that would be considered more substantial than a minor infraction; or
33 34 35	B. Investigative information that indicates that a psychologist represents an immediate threat to public health and safety regardless of whether the psychologist has been notified and had an opportunity to respond.
36 37	25. State. "State" means a state, the District of Columbia or a territory of the United <u>States.</u>
38 39 40	26. State psychology regulatory authority. "State psychology regulatory authority" means the board, office or other agency with the legislative mandate to license and regulate the practice of psychology.
41 42	27. Telepsychology. "Telepsychology" means the provision of psychological services using telecommunications technologies.

26 27 28	5. Home state license; telepsychology practice. A home state's license authorizes a psychologist to practice in a receiving state under the authority to practice interjurisdictional telepsychology only if the compact state:

32 33	C. Notifies the commission, in compliance with the terms herein, of any adverse action or significant investigatory information regarding a licensed psychologist;

18 19 20	2. Conditions to exercise authority to practice interjurisdictional telepsychology. To exercise the authority to practice interjurisdictional telepsychology under the terms and provisions of this compact, a psychologist licensed to practice in a compact state must:

A psychologist practicing in a receiving state under the authority to practice interjurisdictional telepsychology is subject to the receiving state's scope of practice. A receiving state may, in accordance with that state's due process law, limit or revoke a psychologist's authority to practice interjurisdictional telepsychology in the receiving state and may take any other necessary actions under the receiving state's applicable law to protect the health and safety of the receiving state's citizens. If a receiving state takes action, the receiving state shall promptly notify the home state and the commission.

Participation in alternative program in lieu of adverse action. Nothing in this 24 compact overrides a compact state's decision that a psychologist's participation in an 25 alternative program may be used in lieu of adverse action and that such participation must remain nonpublic if required by the compact state's law. Compact states shall require 26 27 psychologists who enter any alternative program to not provide telepsychology services 28 under the authority to practice interjurisdictional telepsychology or not provide temporary 29 psychological services under the temporary authorization to practice in any other compact 30 state during the term of the alternative program. 31 7. No additional judicial or administrative remedies. No other judicial or 32 administrative remedies are available to a psychologist in the event a compact state imposes 33 an adverse action pursuant to subsection 3. 34 §3848. Additional authorities invested in compact state's psychology regulatory 35 authority - Article 8 36 1. Authority under compact. In addition to any other powers granted under state law, a state psychology regulatory authority has the authority under this compact to: 37 38 A. Issue subpoenas, for both hearings and investigations, that require the attendance 39 and testimony of witnesses and the production of evidence. Subpoenas issued by a 40 state psychology regulatory authority for the attendance and testimony of witnesses or 41 the production of evidence from another compact state are enforced in the latter state 42 by any court of competent jurisdiction, according to that court's practice and procedure 43 in considering subpoenas issued in its own proceedings.
