5. Bylaws. The members <u>commission</u> shall adopt bylaws within one year of the effective date of this section. The bylaws must <u>that</u> provide for <u>matters such as</u> the regulation and management of the affairs of the cemetery preservation commission and must establish, the terms of office, including staggering the initial terms, the method for selecting a chair and the method for filling a vacancy on the cemetery preservation commission. The bylaws may be amended at any time by the affirmative vote of a majority of members.

6. Executive director; staff; duties. The commission may select an individual to
serve as the executive director of the commission. The executive director may hire
appropriate staff to assist in carrying out the duties of the commission.

117. Cemetery Preservation Commission Fund. The Cemetery Preservation12Commission Fund, referred to in this section as "the fund," is established as a nonlapsing13account into which is deposited, on a quarterly basis, \$5 of the fee established by the14Department of Health and Human Services for a permit to transport and dispose of a dead15human body. The commission may use the money in the fund to carry out its duties.

16 8. Budget. The commission shall create a budget on an annual basis that includes its
17 estimate of expenditures and appropriations necessary to enable the commission to perform
18 its duties.

9. Funding. The commission is authorized to receive funds from the Federal
Government, from a political subdivision of the State or from an individual, foundation or
corporation and may expend these funds for purposes that are consistent with this section.

10. Report. By December 15th of each year, the commission shall submit a report to the joint standing committee of the Legislature having jurisdiction over state and local government matters. The report must include the commission's budget from the preceding fiscal year, an accounting of all income received and expenditures made by the commission, details on the work performed by the commission and the number of staff employed by the commission in the preceding 12-month period.

Sec. 4. Burial-transit permit fee. Notwithstanding any provision of law to the
contrary, the Department of Health and Human Services shall, by December 15, 2024,
amend its rule Chapter 1: Transportation and Final Disposition of Dead Bodies to increase
the fee charged for a burial-transit permit by \$5.

SUMMARY

4 This amendment replaces the bill. It changes the Maine State Cemetery Preservation Commission from an advisory board under the Maine Revised Statutes, Title 5, section 5 12004-I to an independent advisory board under Title 5, section 12004-J. It changes the 6 duties of the commission from optional to mandatory. It requires the commission to 7 investigate complaints of violations of laws governing burying grounds and cemeteries 8 9 reported to the commission. It permits the commission to hire an executive director to carry out the functions of the commission and authorizes the executive director to hire 10 additional staff as needed. It requires the commission to develop a budget for each year 11 12 and include the budget, income and expenses and details of the commission's activities in a report due to the joint standing committee of the Legislature having jurisdiction over state 13 14 and local government matters by December 15th of each year. It establishes the Cemetery Preservation Commission Fund for use by the commission to accomplish the duties of the 15 commission. The State Controller is required to deposit into the fund, on a quarterly basis, 16 17 \$5 of the burial-transit permit fee collected by the Department of Health and Human 18 Services. It requires the Department of Health and Human Services to amend its rules to 19 increase the fee for a burial-transit permit by \$5. The amendment also adds an appropriations and allocations section. 20
