1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24-A MRSA §4316, sub-§1, ¶C**, as enacted by PL 2019, c. 289, §2, is  
3 amended to read:

4 C. "Telehealth," as it pertains to the delivery of health care services, means the use of  
5 interactive real-time visual and audio or other electronic media for the purpose of  
6 consultation and education concerning and diagnosis, treatment, care management and  
7 self-management of an enrollee's physical and mental health and includes real-time  
8 interaction between the enrollee and the telehealth provider, synchronous encounters,  
9 asynchronous encounters, store and forward transfers, the use of audio-only telephone  
10 and telemonitoring. "Telehealth" does not include the use of ~~audio-only telephone~~,  
11 facsimile machine, e-mail or texting.

12 **Sec. 2. 24-A MRSA §4316, sub-§1, ¶E**, as enacted by PL 2019, c. 289, §2, is

14 **Sec. 3. 24-A MRSA §4316, sub-§5**, as enacted by PL 2019, c. 289, §2, is repealed.

15 **Sec. 4. 32 MRSA §2213** is enacted to read:

16 **§2213. Licensing of nurse licensed in another state; authorized actions**

17 Notwithstanding any provision of this chapter to the contrary, the following provisions  
18 apply.

19 **1. Issuance of license; provision of health care services in person or through**  
20 **telehealth.** The board shall issue a license to any nurse who seeks immediate licensure  
21 who is licensed in good standing in another state and has not been subject to a disciplinary  
22 or adverse action in the past 10 years involving loss of license, probation or practice  
23 restriction or limitation. A nurse licensed under this subsection may provide health care  
24 services within the scope of practice of the nurse's license through an in-person encounter  
25 in this State or across state lines into this State using telehealth, as defined in Title 24-A,  
26 section 4316, subsection 1, paragraph C. License application fees and renewal fees for  
27 licenses issued pursuant to this subsection must be established by the board.

28 **2. Issuance of license for retired nurse.** Upon request, the board shall immediately  
29 issue a license to a nurse who retired in good standing in this State within 2 years of the  
30 effective date of this section and who has not been subject to a disciplinary or adverse  
31 action in the past 10 years involving loss of license, probation or practice restriction or  
32 limitation and has no outstanding complaints or open investigations. The board may  
33 impose a fee for a license issued or renewed pursuant to this subsection.

34 **3. Permitted activity without license.** A nurse who is licensed in good standing in  
35 another state and who has patients residing in this State who travel to another state to  
36 receive ongoing health care from that nurse may provide those health care services to those  
37 patients through telehealth, as defined in Title 24-A, section 4316, subsection 1, paragraph  
38 C, without obtaining a license under this section or another provision of this chapter.

39 **4. Supervision or collaborative practice agreements suspended.** Any requirement  
40 related to mandatory supervision or collaborative practice agreements for an otherwise  
41 qualified advanced practice registered nurse licensed in good standing in another state and  
42 granted a license under this section is suspended.

1           **5. Telehealth services.** A nurse licensed in this State or authorized to perform services  
2 pursuant to this section may perform health care services through the use of all modes of  
3 telehealth, as defined in Title 24-A, section 4316, subsection 1, paragraph C, including  
4 video and audio, audio-only or other electronic media, to treat the residents of this State for  
5 all medically necessary services.

6           **Sec. 5. 32 MRSA §2571-B** is enacted to read:

7           **§2571-B. Licensing of osteopathic physician or physician assistant licensed in another**  
8           **state; authorized actions**

9           Notwithstanding any provision of this chapter to the contrary, the following provisions  
10 apply.

11           **1. Issuance of license; provision of health care services in person or through**  
12 **telehealth.** The board shall issue a license to any osteopathic physician or physician  
13 assistant who seeks immediate licensure who is licensed in good standing in another state  
14 and has not been subject to a disciplinary or adverse action in the past 10 years involving  
15 loss of license, probation or practice restriction or limitation. A physician or physician  
16 assistant licensed under this subsection may provide health care services within the scope  
17 of practice of the physician's or physician assistant's license through an in-person encounter  
18 in this State or across state lines into this State using telehealth, as defined in Title 24-A,  
19 section 4316, subsection 1, paragraph C. License application fees and renewal fees for  
20 licenses issued pursuant to this subsection must be established by the board.

21           **2. Issuance of license for retired physician or physician assistant.** Upon request,  
22 the board shall immediately issue a license to an osteopathic physician or physician  
23 assistant who retired in good standing in this State within 2 years of the effective date of  
24 this section and who has not been subject to a disciplinary or adverse action in the past 10  
25 years involving loss of license, probation or practice restriction or limitation and has no

40 care services through the use of all modes of telehealth, as defined in Title 24-A, section  
41 4316, subsection 1, paragraph C, including video and audio, audio-only or other electronic  
42 media, to treat the residents of this State for all medically necessary services.

43           **Sec. 6. 32 MRSA §3278-A** is enacted to read:

1 **§3278-A. Licensing of physician or physician assistant licensed in another state;**  
2 **authorized actions**

3 Notwithstanding any provision of this chapter to the contrary, the following provisions  
4 apply.

5 **1. Issuance of license; provision of health care services in person or through**  
6 **telehealth.** The board shall issue a license to any physician or physician assistant who  
7 seeks immediate licensure who is licensed in good standing in another state and has not  
8 been subject to a disciplinary or adverse action in the past 10 years involving loss of license,  
9 probation or practice restriction or limitation. A physician or physician assistant licensed  
10 under this subsection may provide health care services within the scope of practice of the  
11 physician's or physician assistant's license through an in-person encounter in this State or  
12 across state lines into this State using telehealth, as defined in Title 24-A, section 4316,  
13 subsection 1, paragraph C. License application fees or renewal fees for licenses issued  
14 pursuant to this subsection are waived must be established by the board.

15 **2. Issuance of license for retired physician or physician assistant.** Upon request,  
16 the board shall immediately issue a license to a physician or physician assistant who retired  
17 in good standing in this State within 2 years of the effective date of this section and who  
18 has not been subject to a disciplinary or adverse action in the past 10 years involving loss  
19 of license, probation or practice restriction or limitation and has no outstanding complaints  
20 or open investigations. The board may impose a fee for a license issued or renewed  
21 pursuant to this subsection.

22 **3. Permitted activity without license.** A physician or physician assistant who is  
23 licensed in good standing in another state and who has patients residing in this State that  
24 travel to another state to receive ongoing health care from that physician or physician  
25 assistant may provide those health care services to those patients through telehealth, as

33 authorized to perform services pursuant to this section may perform health care services  
34 through the use of all modes of telehealth, as defined in Title 24-A, section 4316, subsection  
35 1, paragraph C, including video and audio, audio-only or other electronic media, to treat  
36 the residents of this State for all medically necessary services.

37 **SUMMARY**

38 This bill makes permanent the authorization for licensing out-of-state and recently  
39 retired doctors, physician assistants and nurses that was provided through executive order  
40 during the declared state of civil emergency related to COVID-19. The bill also expands  
41 the scope of health care services that can be provided though telehealth to include the use  
42 of audio-only telephone.
