The report must include, but is not limited to, an assessment of the resource needs associated with the public information 12 campaign and identification of any anticipated resource needs not currently available 13 14 within the existing budgeted resources of Maine Emergency Medical Services necessary for successful implementation of the campaign. After reviewing the report, the committee 15 may report out legislation relating to the report to the 132nd Legislature in 2025. 16
