That notice must include an agenda or statement of purpose of the meeting. That notice may be combined with any other notice of the meeting required by law.

(3) The advisory council determines that the public may participate through telephonic, video, electronic or other similar means of remote participation; and
(4) All votes taken during the public meeting are taken by roll call vote.
Amend the bill by striking out all of section 12.
Amend the bill by striking out all of section 16.
Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
SUMMARY
This amendment makes the following changes to the bill:
1. It adds a new section that allows the Inland Fisheries and Wildlife Advisory Council to conduct public meetings using telephonic, video, electronic or other means of remote participation if certain requirements are met;
2. It strikes the section of the bill that amended law governing foreign watercraft obtaining a certificate of number; and
