| 3 | SUMMARY |
| 4 | This bill is a concept draft pursuant to Joint Rule 208. |
| 5 6 | This bill proposes to enact the Social Work Licensure Compact to facilitate the interstate practice of regulated social workers by improving public access to competent |
| 7 | social work services. The compact preserves the regulatory authority of a state to protect |
| 8 9 | public health and safety through that state's current system of state licensure and promote mobility and address workforce shortages by eliminating the necessity for licenses in |
| 10 | multiple states by providing for the mutual recognition of other member state licenses. |
| 11 | The verbatim text of the Social Work Licensure Compact, which has not been edited |
| 12 13 | to make necessary, nonsubstantive changes to conform to Maine legislative drafting standards, reads as follows. |
| 14 | SECTION 1: PURPOSE |
| 15 | The purpose of this Compact is to facilitate interstate practice of Regulated Social |
| 16 17 | Workers by improving public access to competent Social Work Services. The Compact preserves the regulatory authority of States to protect public health and safety through the |
| 18 | current system of State licensure. |
| 19 | This Compact is designed to achieve the following objectives: |
| 20 | A. Increase public access to Social Work Services; |
| 21 22 | B. Reduce overly burdensome and duplicative requirements associated with holding multiple licenses; |
| 23 | C. Enhance the Member States' ability to protect the public's health and safety; |
| 24 | D. Encourage the cooperation of Member States in regulating multistate practice; |
| 25 26 27 | E. Promote mobility and address workforce shortages by eliminating the necessity for licenses in multiple States by providing for the mutual recognition of other Member State licenses; |
| 28 | F. Support military families; |
| 29 30 | G. Facilitate the exchange of licensure and disciplinary information among Member States; |
| 31 32 33 | H. Authorize all Member States to hold a Regulated Social Worker accountable for abiding by a Member State's laws, regulations, and applicable professional standards in the Member State in which the client is located at the time care is rendered; and |
| 34 35 | I. Allow for the use of telehealth to facilitate increased access to regulated Social Work Services. |
| 36 | SECTION 2. DEFINITIONS |
| 37 38 | As used in this Compact, and except as otherwise provided, the following definitions shall apply: |

| 1 2 3 | A. "Active Military Member" means any individual with full-time duty status in the active armed forces of the United States including members of the National Guard and Reserve. |

"Adverse Action" means any administrative, civil, equitable or criminal action permitted by a State's laws which is imposed by a Licensing Authority or other authority against a Regulated Social Worker, including actions against an individual's license or Multistate Authorization to Practice such as revocation, suspension, probation, monitoring of the Licensee, limitation on the Licensee's practice, or any other Encumbrance on licensure affecting a Regulated Social Worker's authorization to practice, including issuance of a cease and desist action. |
| 11 12 13 | C. "Alternative Program" means a non-disciplinary monitoring or practice remediation process approved by a Licensing Authority to address practitioners with an Impairment. |
| 14 15 16 | D. "Charter Member States" - Member States who have enacted legislation to adopt this Compact where such legislation predates the effective date of this Compact as described in Section 14. |
| 17 18 19 20 | E. "Compact Commission" or "Commission" means the government agency whose membership consists of all States that have enacted this Compact, which is known as the Social Work Licensure Compact Commission, as described in Section 10, and which shall operate as an instrumentality of the Member States. |
| 21 | F. "Current Significant Investigative Information" means: |

Investigative information that a Licensing Authority, after a preliminary inquiry that includes notification and an opportunity for the Regulated Social Worker to respond has reason to believe is not groundless and, if proved true, would indicate more than a minor infraction as may be defined by the Commission; or |
| 26 27 28 29 | 2. Investigative information that indicates that the Regulated Social Worker represents an immediate threat to public health and safety, as may be defined by the Commission, regardless of whether the Regulated Social Worker has been notified and has had an opportunity to respond. |
| 30 31 32 33 | G. "Data System" means a repository of information about Licensees, including, continuing education, examination, licensure, Current Significant Investigative Information, Disqualifying Event, Multistate License(s) and Adverse Action information or other information as required by the Commission. |
| 34 35 | H. "Domicile" means the jurisdiction in which the Licensee resides and intends to remain indefinitely. |
| 36 37 38 | I. "Disqualifying Event" means any Adverse Action or incident which results in an Encumbrance that disqualifies or makes the Licensee ineligible to either obtain, retain or renew a Multistate License. |
| 39 40 41 | J. "Encumbrance" means a revocation or suspension of, or any limitation on, the full and unrestricted practice of Social Work licensed and regulated by a Licensing Authority. |
| 42 43 | K. "Executive Committee" means a group of delegates elected or appointed to act on behalf of, and within the powers granted to them by, the compact and Commission. |

| 1 | L. "Home State" means the Member State that is the Licensee's primary Domicile. |

| 2 | M. "Impairment" means a condition(s) that may impair a practitioner's ability to |

| 7 | N. "Licensee(s)" means an individual who currently holds a license from a State to practice as a Regulated Social Worker. |
| 8 9 | O. "Licensing Authority" means the board or agency of a Member State, or equivalent, that is responsible for the licensing and regulation of Regulated Social Workers. |
| 10 11 | P. "Member State" means a state, commonwealth, district, or territory of the United States of America that has enacted this Compact. |
| 12 13 14 | Q. "Multistate Authorization to Practice" means a legally authorized privilege to practice, which is equivalent to a license, associated with a Multistate License permitting the practice of Social Work in a Remote State. |
| 15 16 17 | R. "Multistate License" means a license to practice as a Regulated Social Worker issued by a Home State Licensing Authority that authorizes the Regulated Social Worker to practice in all Member States under Multistate Authorization to Practice. |
| 18 19 | S. "Qualifying National Exam" means a national licensing examination approved by the Commission. |
| 20 21 | T. "Regulated Social Worker" means any clinical, master's or bachelor's Social Worker licensed by a Member State regardless of the title used by that Member State. |
| 22 | U. "Remote State" means a Member State other than the Licensee's Home State. |
| 23 24 25 | V. "Rule(s)" or "Rule(s) of the Commission" means a regulation or regulations duly promulgated by the Commission, as authorized by the Compact, that has the force of law. |
| 26 27 28 | W. "Single State License" means a Social Work license issued by any State that authorizes practice only within the issuing State and does not include Multistate Authorization to Practice in any Member State. |
| 29 | X. "Social Work" or "Social Work Services" means the application of social work |
| 30 | theory, knowledge, methods, ethics, and the professional use of self to restore or |
| 31 32 | enhance social, psychosocial, or biopsychosocial functioning of individuals, couples, families, groups, organizations, and communities through the care and services |

| 39 | SECTION 3. STATE PARTICIPATION IN THE COMPACT |
| 40 | A. To be eligible to participate in the compact, a potential Member State must currently |
| 41 | meet all of the following criteria: |

| 18 19 | 2. Participate fully in the Commission's Data System, including using the Commission's unique identifier as defined in Rules; |
| 20 21 22 | 3. Notify the Commission, in compliance with the terms of the Compact and Rules, of any Adverse Action or the availability of Current Significant Investigative Information regarding a Licensee; |
| 23 24 25 26 27 28 | 4. Implement procedures for considering the criminal history records of applicants for a Multistate License. Such procedures shall include the submission of fingerprints or other biometric-based information by applicants for the purpose of obtaining an applicant's criminal history record information from the Federal Bureau of Investigation and the agency responsible for retaining that State's criminal records. |
| 29 | 5. Comply with the Rules of the Commission; |
| 30 31 32 | 6. Require an applicant to obtain or retain a license in the Home State and meet the Home State's qualifications for licensure or renewal of licensure, as well as all other applicable Home State laws; |

| 6 | SECTION 4. SOCIAL WORKER PARTICIPATION IN THE COMPACT |
| 7 8 | A. To be eligible for a Multistate License under the terms and provisions of the Compact, an applicant, regardless of category must: |
| 9 | 1. Hold or be eligible for an active, Unencumbered License in the Home State; |
| 10 | 2. Pay any applicable fees, including any State fee, for the Multistate License; |
| 11 12 13 14 | 3. Submit, in connection with an application for a Multistate License, fingerprints or other biometric data for the purpose of obtaining criminal history record information from the Federal Bureau of Investigation and the agency responsible for retaining that State's criminal records. |
| 15 16 17 | 4. Notify the Home State of any Adverse Action, Encumbrance, or restriction on any professional license taken by any Member State or non-Member State within 30 days from the date the action is taken. |
| 18 | 5. Meet any continuing competence requirements established by the Home State; |
| 19 20 | 6. Abide by the laws, regulations, and applicable standards in the Member State where the client is located at the time care is rendered. |
| 21 22 | B. An applicant for a clinical-category Multistate License must meet all of the following requirements: |
| 23 | 1. Fulfill a competency requirement, which shall be satisfied by either: |
| 24 | a. Passage of a clinical-category Qualifying National Exam; or |

Licensure of the applicant in their Home State at the clinical category, beginning prior to such time as a Qualifying National Exam was required by the Home State and accompanied by a period of continuous Social Work licensure thereafter, all of which may be further governed by the Rules of the Commission; or |
| 30 31 | c. The substantial equivalency of the foregoing competency requirements which the Commission may determine by Rule. |
| 32 | 2. Attain at least a master's degree in Social Work from a program that is: |

| 35 36 | b. Accredited, or in candidacy that subsequently becomes accredited, by an accrediting agency recognized by either: |
| 37 | i. the Council for Higher Education Accreditation or its successor; or |

| 18 | 2. Attain at least a master's degree in Social Work from a program that is: |
| 19 20 | a. Operated by a college or university recognized by the Licensing Authority; and |
| 21 22 | b. Accredited, or in candidacy that subsequently becomes accredited, by an accrediting agency recognized by either: |
| 23 | i. the Council for Higher Education Accreditation or its successor; or |

| 3 4 5 6 | E. The Multistate License for a Regulated Social Worker is subject to the renewal requirements of the Home State. The Regulated Social Worker must maintain compliance with the requirements of Section 4(A) to be eligible to renew a Multistate License. |
| 7 8 9 10 11 12 | F. The Regulated Social Worker's services in a Remote State are subject to that Member State's regulatory authority. A Remote State may, in accordance with due process and that Member State's laws, remove a Regulated Social Worker's Multistate Authorization to Practice in the Remote State for a specific period of time, impose fines, and take any other necessary actions to protect the health and safety of its citizens. |
| 13 14 15 | G. If a Multistate License is encumbered, the Regulated Social Worker's Multistate Authorization to Practice shall be deactivated in all Remote States until the Multistate License is no longer encumbered. |

| 19 | SECTION 5: ISSUANCE OF A MULTISTATE LICENSE |
| 20 21 22 | A. Upon receipt of an application for Multistate License, the Home State Licensing Authority shall determine the applicant's eligibility for a Multistate License in accordance with Section 4 of this Compact. |
| 23 24 25 26 | B. If such applicant is eligible pursuant to Section 4 of this Compact, the Home State Licensing Authority shall issue a Multistate License that authorizes the applicant or Regulated Social Worker to practice in all Member States under a Multistate Authorization to Practice. |
| 27 28 29 | C. Upon issuance of a Multistate License, the Home State Licensing Authority shall designate whether the Regulated Social Worker holds a Multistate License in the Bachelors, Masters, or Clinical category of Social Work. |
| 30 31 32 33 | D. A Multistate License issued by a Home State to a resident in that State shall be recognized by all Compact Member States as authorizing Social Work Practice under a Multistate Authorization to Practice corresponding to each category of licensure regulated in each Member State. |
| 34 35 | SECTION 6: AUTHORITY OF INTERSTATE COMPACT COMMISSION AND MEMBER STATE LICENSING AUTHORITIES |

Nothing in this Compact, nor any Rule of the Commission, shall be construed to limit, restrict, or in any way reduce the ability of a Member State to enact and enforce laws, regulations, or other rules related to the practice of Social Work in that State, where those laws, regulations, or other rules are not inconsistent with the provisions of this Compact. |
| 41 42 | B. Nothing in this Compact shall affect the requirements established by a Member State for the issuance of a Single State License. |

C. Nothing in this Compact, nor any Rule of the Commission, shall be construed to
 limit, restrict, or in any way reduce the ability of a Member State to take Adverse
 Action against a Licensee's Single State License to practice Social Work in that State.

- D. Nothing in this Compact, nor any Rule of the Commission, shall be construed to
 limit, restrict, or in any way reduce the ability of a Remote State to take Adverse Action
 against a Licensee's Multistate Authorization to Practice in that State.
- E. Nothing in this Compact, nor any Rule of the Commission, shall be construed to
 limit, restrict, or in any way reduce the ability of a Licensee's Home State to take
 Adverse Action against a Licensee's Multistate License based upon information
 provided by a Remote State.

11 SECTION 7: REISSUANCE OF A MULTISTATE LICENSE BY A NEW HOME12 STATE

- A. A Licensee can hold a Multistate License, issued by their Home State, in only one
 Member State at any given time.
- 15 B. If a Licensee changes their Home State by moving between two Member States:
- The Licensee shall immediately apply for the reissuance of their Multistate
 License in their new Home State. The Licensee shall pay all applicable fees and
 notify the prior Home State in accordance with the Rules of the Commission.
- 192. Upon receipt of an application to reissue a Multistate License, the new Home20State shall verify that the Multistate License is active, unencumbered and eligible21for reissuance under the terms of the Compact and the Rules of the Commission.22The Multistate License issued by the prior Home State will be deactivated and all23Member States notified in accordance with the applicable Rules adopted by the24Commission.

- 4. If required for initial licensure, the new Home State may require completion of
 jurisprudence requirements in the new Home State.
- 5. Notwithstanding any other provision of this Compact, if a Licensee does not
 meet the requirements set forth in this Compact for the reissuance of a Multistate
 License by the new Home State, then the Licensee shall be subject to the new Home
 State requirements for the issuance of a Single State License in that State.
- C. If a Licensee changes their primary State of residence by moving from a Member
 State to a non-Member State, or from a non-Member State to a Member State, then the
 Licensee shall be subject to the State requirements for the issuance of a Single State
 License in the new Home State.
- D. Nothing in this Compact shall interfere with a Licensee's ability to hold a Single
 State License in multiple States; however, for the purposes of this Compact, a Licensee
 shall have only one Home State, and only one Multistate License.

E. Nothing in this Compact shall interfere with the requirements established by a
 Member State for the issuance of a Single State License.

3 SECTION 8. MILITARY FAMILIES

An Active Military Member or their spouse shall designate a Home State where the individual has a Multistate License. The individual may retain their Home State designation during the period the service member is on active duty.

7 SECTION 9. ADVERSE ACTIONS

- A. In addition to the other powers conferred by State law, a Remote State shall have the authority, in accordance with existing State due process law, to:
- 10 1. Take Adverse Action against a Regulated Social Worker's Multistate Authorization to Practice only within that Member State, and issue subpoenas for 11 12 both hearings and investigations that require the attendance and testimony of witnesses as well as the production of evidence. Subpoenas issued by a Licensing 13 Authority in a Member State for the attendance and testimony of witnesses or the 14 production of evidence from another Member State shall be enforced in the latter 15 State by any court of competent jurisdiction, according to the practice and 16 17 procedure of that court applicable to subpoenas issued in proceedings pending before it. The issuing Licensing Authority shall pay any witness fees, travel 18 expenses, mileage, and other fees required by the service statutes of the State in 19 20 which the witnesses or evidence are located.
- 21 2. Only the Home State shall have the power to take Adverse Action against a
 22 Regulated Social Worker's Multistate License.
- B. For purposes of taking Adverse Action, the Home State shall give the same priority
 and effect to reported conduct received from a Member State as it would if the conduct
 had occurred within the Home State. In so doing, the Home State shall apply its own
 State laws to determine appropriate action.
- C. The Home State shall complete any pending investigations of a Regulated Social
 Worker who changes their Home State during the course of the investigations. The
 Home State shall also have the authority to take appropriate action(s) and shall
 promptly report the conclusions of the investigations to the administrator of the Data
 System. The administrator of the Data System shall promptly notify the new Home
 State of any Adverse Actions.
- D. A Member State, if otherwise permitted by State law, may recover from the affected
 Regulated Social Worker the costs of investigations and dispositions of cases resulting
 from any Adverse Action taken against that Regulated Social Worker.
- E. A Member State may take Adverse Action based on the factual findings of another
 Member State, provided that the Member State follows its own procedures for taking
 the Adverse Action.

 41 Work practice act or other applicable State law, any Member State may participate
 42 with other Member States in joint investigations of Licensees.

1 2. Member States shall share any investigative, litigation, or compliance materials 2 in furtherance of any joint or individual investigation initiated under the Compact. 3 G. If Adverse Action is taken by the Home State against the Multistate License of a Regulated Social Worker, the Regulated Social Worker's Multistate Authorization to 4 Practice in all other Member States shall be deactivated until all Encumbrances have 5 been removed from the Multistate License. All Home State disciplinary orders that 6 7 impose Adverse Action against the license of a Regulated Social Worker shall include a statement that the Regulated Social Worker's Multistate Authorization to Practice is 8 deactivated in all Member States until all conditions of the decision, order or agreement 9 10 are satisfied. H. If a Member State takes Adverse Action, it shall promptly notify the administrator 11 of the Data System. The administrator of the Data System shall promptly notify the 12 Home State and all other Member State's of any Adverse Actions by Remote States. 13 14 I. Nothing in this Compact shall override a Member State's decision that participation in an Alternative Program may be used in lieu of Adverse Action. 15 16 J. Nothing in this Compact shall authorize a Member State to impose discipline against 20 a Regulated Social Worker who holds a Multistate Authorization to Practice for lawful 21 actions within another Member State. SECTION 10. ESTABLISHMENT OF SOCIAL WORK LICENSURE COMPACT 22 23 COMMISSION 24 A. The Compact Member States hereby create and establish a joint government agency whose membership consists of all Member States that have enacted the compact known 25 26 as the Social Work Licensure Compact Commission. The Commission is an instrumentality of the Compact States acting jointly and not an instrumentality of any 27 one State. 14 SECTION 16. CONSISTENT EFFECT AND CONFLICT WITH OTHER STATE15 LAWS

- A. A Licensee providing services in a Remote State under a Multistate Authorization
 to Practice shall adhere to the laws and regulations, including laws, regulations, and
 applicable standards, of the Remote State where the client is located at the time care is
 rendered.
- B. Nothing herein shall prevent or inhibit the enforcement of any other law of a
 Member State that is not inconsistent with the Compact.
- C. Any laws, statutes, regulations, or other legal requirements in a Member State in conflict with the Compact are superseded to the extent of the conflict.
- D. All permissible agreements between the Commission and the Member States are
 binding in accordance with their terms.
