Resolved: That the Maine Indian Tribal-State Commission, established in the Maine Revised Statutes, Title 30, section 6212 and referred to in this resolve as "the commission," shall identify state-owned lands and waterways that have sacred, traditional or other significance to the Wabanaki Tribes consisting of the Passamaquoddy Tribe, the Penobscot Nation, the Houlton Band of Maliseet Indians and the Mi'kmaq Nation.
33 34	Sec. 2. Formalized process for transfer or enhanced access. Resolved: That the commission shall determine whether a process to transfer ownership of or provide

enhanced access to identified state-owned lands and waterways under section 1 to the 1 Wabanaki Tribes should be formalized, and, if so, what that process should be. 2

3 Sec. 3. Report; legislation. Resolved: That the commission shall submit a report 4 to the Joint Standing Committee on Judiciary by December 1, 2022 detailing the lands and waterways identified pursuant to section 1 and recommendations relating to a formalized 5 process to transfer ownership of or provide enhanced access to the identified lands and 6 7 waterways. The joint standing committee of the Legislature having jurisdiction over judiciary matters may report out legislation related to the report to the 131st Legislature in 8 9 2023.

10 **Emergency clause.** In view of the emergency cited in the preamble, this legislation takes effect when approved.' 11

12 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section 13 number to read consecutively.

SUMMARY 14 15 This amendment replaces the bill with a resolve directing the Maine Indian Tribal-State Commission to identify state-owned lands and waterways that have sacred, traditional or 16 other significance to the Wabanaki Tribes, which are the Passamaquoddy Tribe, the 17 Penobscot Nation, the Houlton Band of Maliseet Indians and the Mi'kmaq Nation. The 18 commission is required to determine whether a formalized process should be adopted to 19 20 transfer ownership of or to provide enhanced access to the lands and waterways to the 21 Wabanaki Tribes. The commission is required to submit a report by December 1, 2022 to 22 the Joint Standing Committee on Judiciary. The joint standing committee of the Legislature having jurisdiction over judiciary matters may report out legislation to the 131st 23 24 Legislature in 2023. 25 FISCAL NOTE REQUIRED (See attached)
