The amendment allows for an 9 elver fishing license holder to request a temporary medical transfer of that license holder's quota at any point during the year and that the license holder receiving the transferred quota 10 receives the amount of the transferor's quota that remains at the time the request is made. 11 12 The amendment also provides that the Commissioner of Marine Resources may adopt rules 13 that allow for a transferor to choose whether the transferor retains the income and tax burden from the transferror's transferred quota or whether it is transferred to the license 14 15 holder receiving the quota.
