This amendment allows school bus drivers 3 employed in school administrative units on or after January 1, 2022 to be eligible for unemployment benefits regardless of whether the school bus driver receives annual written 4 reasonable assurance that the school bus driver will perform the services in the 2nd 5 6 academic year or term of 2 successive academic years or terms. It requires the State to 7 fund the costs of unemployment benefits for any school bus driver in a school administrative unit who elects to apply for and is eligible for benefits under the 8 Employment Security Law. It also adds an appropriations and allocations section. 9
