An Act to Make Permanent the Submission of Certain Reports to the Legislature Concerning Child Welfare

Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. 22 MRSA §4004, sub-§1,** ¶**E,** as amended by PL 2021, c. 550, §1, is further amended to read:
 - E. Establishing a child death and serious injury review panel for reviewing deaths and serious injuries to children. The panel consists of the following members: the Chief Medical Examiner, a pediatrician, a public health nurse, forensic and community mental health clinicians, law enforcement officers, departmental child welfare staff, district attorneys, criminal or civil assistant attorneys general and the ombudsman pursuant to section 4087-A or a designee of the ombudsman.

The purpose of the panel is to recommend to state and local agencies methods of improving the child protection system, including modifications of statutes, rules, policies and procedures. Beginning January 1, 2023 and every 2 years thereafter, the department shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters.

The panel shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters at least every 3 months. The panel may submit a combined report with the child welfare advisory panel established in section 4010-D. Any presentation of the report to the committee must be presented by the citizen members of the panels to the extent possible. Each quarterly report must contain, at a minimum, the following:

- (1) A summary of generalized and anonymized observations in the prior 3-month period regarding efforts by the Office of Child and Family Services to improve the child welfare system;
- (2) A summary of the collaboration between the child welfare advisory panel and the child death and serious injury review panel as well as the judicial branch's Maine justice for children task force; and
- (3) Any recommendations on how to further protect the State's children through department policy and rulemaking and through legislation;
- Sec. 2. 22 MRSA §4010-D, as enacted by PL 2019, c. 28, §1, is repealed and the following enacted in its place:

§4010-D. Child welfare advisory panel; reports

- 1. Department annual reports. The department shall submit a report annually to the joint standing committee of the Legislature having jurisdiction over health and human services matters on the activities of and reports produced by the child welfare advisory panel formed pursuant to the federal Children's Justice Act, 42 United States Code, Section 5106a to make policy and training recommendations for system improvements in the investigative, administrative and judicial handling of child abuse, neglect and exploitation cases and child maltreatment-related fatalities.
- 2. Child welfare advisory panel quarterly reports. The child welfare advisory panel shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters at least every 3 months. The advisory panel may submit a combined report with the child death and serious injury review panel established in section 4004, subsection 1, paragraph E. Any presentation of the report to the committee

- must be presented by the citizen members of the panels to the extent possible. Each quarterly report must contain, at a minimum, the following:

 A. A summary of generalized and anonymized observations in the prior 3-month period regarding efforts by the Office of Child and Family Services to improve the
 - B. A summary of the collaboration between the child welfare advisory panel and the child death and serious injury review panel as well as the judicial branch's Maine justice for children task force; and
 - C. Any recommendations on how to further protect the State's children through department policy and rulemaking and through legislation.

Sec. 3. 22 MRSA §5308-A is enacted to read:

child welfare system;

§5308-A. Office of Child and Family Services reports

The Office of Child and Family Services shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters at least every 3 months. Each quarterly report must address the progress in implementing the recommendations of the report, "Collaborative Safety Review, Maine Office of Child and Family Services, Summary and Recommendations," completed for the department in October 2021, responses to recommendations from the child welfare advisory panel formed pursuant to section 4010-D and progress in efforts described in the department's annual report on child welfare under section 4010-D, subsection 1. The report must address, at minimum, the following:

- 1. Prevention services. Efforts to further coordinate and advance child welfare services in primary, secondary and tertiary prevention, as those prevention services are described by the Office of Child and Family Services;
- **2. Family team meetings.** Efforts to expand the use and value of family team meetings;
- 3. Policy development. Efforts to expand the use of participation of people with lived experience in the development of policy regarding and operation of the child welfare system;
- 4. Domestic violence and custody. A review of the department's policies and practices regarding domestic violence and the ability of the nonoffending parent to assume custody of a child;
- 5. Guardians ad litem. Efforts to work with a guardian ad litem review board under the Board of Overseers of the Bar, the judicial branch and other interested parties to improve the training and support of guardians ad litem; and
- <u>6. Recommendations.</u> Any recommendations on how to further protect the State's children through department policy and rulemaking and legislation.

38 SUMMARY

Resolve 2021, chapter 142 required the child welfare advisory panel and the child death and serious injury review panel to submit reports to the joint standing committee of the Legislature having jurisdiction over health and human services matters on the child welfare

system and efforts to collaborate between the citizen review panels required by the federal Child Abuse Prevention and Treatment Act. It also required the Department of Health and Human Services, Office of Child and Family Services to submit quarterly reports to the joint standing committee of the Legislature having jurisdiction over health and human services matters regarding progress in implementing the recommendations of the Casey Family Programs and Collaborative Safety report completed for the department in October 2021, responses to recommendations from the child welfare advisory panel established pursuant to the Maine Revised Statutes, Title 22, section 4010-D and progress in efforts described in the department's annual report on child welfare. The reports are required until June 30, 2024; this bill makes the reporting requirements permanent.
