1           **Emergency preamble. Whereas,** acts and resolves of the Legislature do not  
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3           **Whereas,** the federal American Rescue Plan Act of 2021, Public Law 117-2, provides  
4 funding for the Homeowner Assistance Fund; and

5           **Whereas,** amounts identified for the Homeowner Assistance Fund will be provided  
6 to the State for distribution before the expiration of the 90 days; and

7           **Whereas,** according to the federal American Rescue Plan Act of 2021, the funds are  
8 intended to prevent mortgage delinquencies and defaults, foreclosures, loss of utilities or  
9 home energy services and displacements of homeowners experiencing financial hardship;  
10 and

11           **Whereas,** in the judgment of the Legislature, these facts create an emergency within  
12 the meaning of the Constitution of Maine and require the following legislation as  
13 immediately necessary for the preservation of the public peace, health and safety; now,  
14 therefore,

15 **Be it enacted by the People of the State of Maine as follows:**

16           **Sec. 1. Appropriations and allocations.** The following appropriations and  
17 allocations are made.

18 **PROFESSIONAL AND FINANCIAL REGULATION, DEPARTMENT OF**  
19 **American Rescue Plan Act of 2021 - Homeowner Assistance Fund NEW**

20 Initiative: Provides one-time allocations necessary to distribute funds from the  
21 Homeowner Assistance Fund authorized in the federal American Rescue Plan Act of 2021.

28           **Emergency clause.** In view of the emergency cited in the preamble, this legislation  
29 takes effect when approved.

33 and distribute funds received pursuant to the federal American Rescue Plan Act of 2021.
