16 17	' Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
18 19 20 21	Whereas, the Commission To Develop a Paid Family and Medical Leave Benefits Program established in Resolve 2021, chapter 122 was required to submit a report relating to the commission's duties by February 1, 2022 but was unable to complete the duties required of it; and
22 23 24	Whereas, the commission must be reestablished before the 90-day period expires in order that the commission's work may be completed and a report submitted in time for submission to the next legislative session; and
25 26 27 28	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it
29 30 31	Sec. 1. Commission reestablished. Resolved: That the Commission To Develop a Paid Family and Medical Leave Benefits Program, referred to in this resolve as "the commission," originally established in Resolve 2021, chapter 122 is reestablished.
32 33	Sec. 2. Commission membership. Resolved: That, notwithstanding Joint Rule 353, the commission consists of 12 voting members as follows:

1 2	1. Two members of the Senate appointed by the President of the Senate, including a member from each of the 2 parties holding the largest number of seats in the Legislature;

6	3. Two members appointed by the President of the Senate as follows:

Notwithstanding Joint Rule 353, the chairs may appoint, as nonvoting members, individuals with expertise in paid family and medical leave, social insurance programs or related state infrastructure.
26 27 28 29 30 31 32 33	Sec. 4. Appointments; convening of commission. Resolved: That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been completed. After appointment of all members, the chairs shall call and convene the first meeting of the commission. If 30 days or more after the effective date of this resolve a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the commission to meet and conduct its business.

35 36 37	1. Develop a plan to implement a paid family and medical leave benefits program by consulting with other states that have established paid family and medical leave benefits programs;

- 6 Sec. 6. Staff assistance. Resolved: That, notwithstanding Joint Rule 353, the Legislative Council shall provide necessary staffing services or may contract for necessary 7 staffing services for the commission, except that Legislative Council staff support is not 8 9 authorized when the Legislature is in regular or special session. Upon request, the Office of Policy Innovation and the Future, the Department of Labor, the Department of Health 10 11 and Human Services and the Department of Administrative and Financial Services, Office 12 of Information Technology and Bureau of Revenue Services shall provide additional staffing assistance to the commission. 13
- 14 Sec. 7. Report. Resolved: That, no later than November 2, 2022, the commission 15 shall submit a report that includes its findings and recommendations, including suggested legislation, for presentation to the First Regular Session of the 131st Legislature. 16
- 17 Sec. 8. Additional funding sources. Resolved: That the commission may apply for and receive funds, grants or contributions from public and private sources to support its 18 19 activities. All funding is subject to approval by the Legislative Council in accordance with 20 its policies.
- 21 Sec. 9. Funds carried forward. Resolved: That funds appropriated or allocated pursuant to Resolve 2021, chapter 122 do not lapse but must be carried forward into the 22 next fiscal year to be used for the purpose for which the funds were provided. 23
- 24 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or 25 section number to read consecutively.

SUMMARY

27 This amendment replaces the resolve. The amendment reestablishes the Commission To Develop a Paid Family and Medical Leave Benefits Program, which was established in 28 29 Resolve 2021, chapter 122, and requires the commission to submit a report for presentation 30 to the First Regular Session of the 131st Legislature no later than November 2, 2022. The 31 amendment retains the provision in the resolve that provides that funds appropriated or 32 allocated pursuant to Resolve 2021, chapter 122 do not lapse but must be carried forward into the next fiscal year to be used for the purpose for which the funds were provided. The 33 34 amendment requires the appointing authorities, to the greatest extent practicable, to 35 reappoint the persons they appointed to the former commission.
