1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 7 MRSA c. 8-A, sub-c. 4** is enacted to read:

3 **SUBCHAPTER 4**

4 **POTATO FARMERS DISASTER RELIEF GRANT PROGRAM**

5 **§220-A. Potato Farmers Disaster Relief Grant Program**

6 **1. Grant program established.** The Potato Farmers Disaster Relief Grant Program,  
7 referred to in this section as "the program," is established in the department to assist potato  
8 farmers in the State to overcome the adverse effects of drought conditions by providing  
9 grants in accordance with this section.

10 **2. Eligibility.** A potato farmer in the State may apply for a grant under the program if,  
11 as a result of drought conditions, the farmer's potato yield is significantly lower than that  
12 farmer's expected crop yield as determined by the most recent agricultural yield survey  
13 conducted by the United States Department of Agriculture's National Agricultural Statistics  
14 Service.

15 **3. Potato Farmers Disaster Relief Grant Program Fund.** The Potato Farmers  
16 Disaster Relief Grant Program Fund is established as a nonlapsing fund to provide funding  
17 to achieve the purposes of the program. The fund consists of any funds received from  
18 private and public sources. The fund must be held separate and apart from all other money,  
19 funds and accounts. Any balance remaining in the fund at the end of any fiscal year must  
20 be carried forward to the next fiscal year.

21 **4. Rules.** The department shall adopt rules to implement the program. The rules must  
22 include grant eligibility requirements, grant application and award procedures and grant  
23 funding limits. Rules adopted pursuant to this subsection are routine technical rules as  
24 defined in Title 5, chapter 375, subchapter 2-A.

25 **SUMMARY**

26 This bill establishes the Potato Farmers Disaster Relief Grant Program to assist potato  
27 farmers in the State to overcome the adverse effects of drought conditions by providing  
28 grants.
