PUBLIC COMMENT: Governor's Change Package to LD 258

The Joint Standing Committee on Appropriations and Financial Affairs is soliciting public comment on the **Biennial Budget** <u>CHANGE PACKAGE</u> to LD 258 ("An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2024 and June 30, 2025").

When reviewing the Part A initiatives, be aware of the information at the top of the page which states whether the change is a deletion, an addition or a change.

In any of the Blocks, the committee will hear testimony <u>only</u> on the initiatives and language parts listed in the Change Package (additions, deletions or changes). The committee is <u>not</u> soliciting testimony on: **Part I** (the proposed change corrects a typo); **Part J** (which is identical to LD 1918 referred to the Innovation, Development, Economic Advancement and Business Committee); **Part LL** (the proposed change corrects a typo); **Part ZZZ** (which has been heard by the Taxation Committee as LD 7); **Part AAAA** (a similar proposal has already been heard by the Housing Committee as LD 2); or **Part EEEE** (which has already been heard by the Agriculture, Conservation and Forestry Committee as LD 1612) or any Language Parts deleted in the CP.

The Commissioner of the Department of Administrative and Financial Services is scheduled to present the entire Change Package to the AFA Committee on Monday, May 15th starting at 10:00 am. There is no scheduled departmental or agency presentation of the change package initiatives or language parts <u>during</u> the Public Testimony Blocks.

Due to the very tight timetable, the Chairs ask that you limit your testimony to three (3) minutes.

Testimony within each Block will be taken in the order of sign-ups (whether to testify in person or on zoom) <u>or</u> at the discretion of the Chairs. Depending on how crowded the hearing blocks are, in-person testimony sign-ups sheets may be located either in the committee room or at a table in the hall outside the room. If the committee room is full, you may be asked to wait in an "overflow" room where you can watch the proceedings and wait for your name to be called.
