The General Fund portion is funded by salary savings and the Other Special Revenue Funds portion is funded through the Cost Allocation Process. This position started on August 28, 2022 and will end on August 27, 2024.

#### Statement of Fact

This financial order allots a portion of the anticipated unencumbered balance forward to fund transition planning services to ensure community provider supports are in place to meet individual consumer needs prior to discharge from a nursing facility. Examples of supports include personal care assistance, home health care, home modifications for safety accessibility, and personal emergency response systems. The Consolidated Appropriations Act (CAA) of 2021 extends the Money Follows the Person program. Revenue is earned from the Federal Medical Assistance Percentage (FMAP). Failure to allot these funds will result in funds earned not having a mechanism in place to use generated revenue to support community-based long-term care for Maine's elderly and disabled population resulting in a failure to meet related grant requirements.
