Re: Criminal Justice and Public Safety committee report back with recommendations to Appropriations and Financial Affairs Committee on LD 2214, An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds and to Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2024 and June 30, 2025

On behalf of the Joint Standing Committee on Criminal Justice and Public Safety ("CJPS"), we write to convey to the Joint Standing Committee on Appropriations and Financial Affairs ("AFA") the initial recommendations of CJPS on items within its jurisdiction in the Governor's proposed supplemental budget for fiscal years 2024 and 2025, LD 2214 (the "Supplemental Budget"). Please find attached: (1) the report forms applicable to CJPS, pages 1 - 13, which contain the votes of CJPS on all relevant initiatives in the Budget; and (2) the votes for language on Parts O, P, Q, EEE, and FFF

Voting Process

CJPS held two work sessions on the Supplemental Budget to vote on recommendations to AFA on Tuesday March 5 and Wednesday March 6. At its first work session, the committee received additional information from the Maine Emergency Management Agency regarding Initiative 0214, which CJPS then voted. CJPS then voted on several other individual initiatives proposed by the Department of Public Safety and Department of Corrections. For the several initiatives that were not voted on at the first meeting, CJPS followed up with the departments for additional information. This additional information was received and presented by the departments at the

second work session. CJPS then voted the remainder of the initiatives individually. CJPS also voted for proposed language in one ballot.

Department of Corrections Initiatives Z177, Z366, and Part P

CJPS raised only one concern for the report back memo. According to testimony from the Department of Corrections, a major initiative in the Supplemental Budget is funding for the implementation of its Offender Management System. The department proposed \$4,800,000 beginning in FY 2024-25 to implement this system. To cover additional costs for required subscriptions related to the system, the department also proposed Initiatives Z177 and Z366, and Part P, which together removes \$900,000 from the Corrections Food and Corrections Fuel program and transfers this funding for these subscription costs.

The committee raised the issue that the language in Part P is unclear. Specifically, while Part P authorizes the department to "carry forward up to \$900,000 appropriated for the subscription costs," it does not clearly articulate: (1) that the funding already exists in the department's budget and is merely being re-appropriated within the department for another purpose; and (2) the existing programs from where the money is being transferred.

Thus, CJPS recommends Part P is amended to more clearly reflect and articulate the reappropriation scheme used to fund subscription costs for the Offender Management System.

State Police Funding

In addition to initiatives and language under the jurisdiction of CJPS, CJPS also reviewed and voted on recommendations on initiatives presented by the Bureau of State Police. While policy considerations concerning State Police are typically handled by CJPS, budget matters are under the policy committee jurisdiction of the Transportation Committee. Thus, while not directly responsible for submitting recommendations to AFA regarding State Police funding, CJPS felt it appropriate to vote on State Police initiatives.

Status of Public Law 2021, chapter 732

At the public hearing on LD 2214, Senator Bennett requested an update on the implementation of Public Law 2021, chapter 732, "An Act to Stabilize State Funding For County Corrections" and information concerning how the proposals in this law related to the \$4,000,000 requested in medication assisted treatment ("MAT") funding for county jails in the Supplemental Budget.

P.L. 2021, ch. 732 established the County Jail Operations Fund, which provided State funding for county and regional jails and established a scheme to distribute this funding. Specifically, the law requires the State to fund \$20,342,104, plus any additional amount the Legislature may appropriate. The Department of Corrections has implemented a formula for distribution of these funds to each county. *See* 03-201 C.M.R. Ch. 3.

This law also requires the department to establish detention and correctional standards for counties and municipalities. *See* 34-A M.R.S.A. 1208. These standards, adopted by the department through the rulemaking process, require county jails to provide for "the clinical management of chemically dependent inmates," which includes access to substance use disorder screening, assessment, medication, and treatment for the duration of the person's incarceration at

a county jail. This standard is manifested by each county jail through an individualized treatment plan for each eligible incarcerated person, which plan includes MAT.

Initiative Z227 provides \$4,000,000 in funding to the department as a pass through to county jails to fund these MAT programs.

CJPS thanks AFA for its time and consideration of these notes and recommendations, and of all materials concerning the Supplemental Budget within the jurisdiction of CJPS.

Justification:

This initiative provides one-time funding the Disaster Recovery Fund to meet state funding requirements for emergency declarations. As of October 11, 2023, the existing \$3.3 million balance has been committed to existing state cost share obligations (15% of disaster costs). It should be noted that, per Maine Revised Statutes, Title 37-B, chapter 13, sub-chapter 2, section 745, the Disaster Recovery Fund must be the first resource used when an Emergency Proclamation or a Presidential Major Disaster is declared. Based on the increased frequency and intensity of disasters over the last several years, MEMA anticipates that Maine will experience additional major disasters before the end of fiscal year 2024-25, each of which requiring a state cost share. The December 2023 storm resulted in a disaster declaration; we are still waiting for determination of the two January 2024 storms. In order to meet the State's cost share obligations and avoid delays in reimbursements to Maine's municipalities and other eligible applicants, the Disaster Recovery Fund requires sufficient funding.

Justification:

In the 131st Maine Legislature, First Special Session, LD 1100 carried as final passed in the latest House action and carried on appropriation table in the latest Senate action as a Resolve to direct the commissioner to commence screening all visitors to the Cross Office Building in the same manner as the State House. Justification:

Maine Emergency Medical Services (EMS) is currently collaborating with the Maine Departments of Health and Human Services (DHHS) and Department of Labor to create learning opportunities for young persons (16-24) throughout the State of Maine to learn about and get involved with emergency medical services. Through this collaborative, DHHS was able to locate limited funding to support the creation of a position within Maine EMS to support these efforts.

Unfortunately, the sustainability of that funding source is likely not viable; however, the need for this staff person will continue to persist. Creating the infrastructure and support mechanisms for Explorer Programs throughout the state will require ongoing support, refinement, education, training, and outreach. A dedicated staff person will be essential to maintaining this opportunity for young persons throughout Maine.

Justification:

Since the creation of the Maine Emergency Medical Service (EMS) system in 1986, it was built on a regionalized structure intended to facilitate communications, programming, and collaboration between the state-level and local services. Maine EMS has paid contractors to help provide this critical conduit within the EMS regions; however, funding for these contractors has dwindled over the past 30 years. The original funding amounts have vastly declined to approximately \$50K per year for each region. The current labor market does not account for a single contracted staff person dedicated to these efforts. Putting a regional administrator position in four regions will drastically increase the local collaboration with EMS entities across the State of Maine. It will also increase the state's bandwidth to facilitate quality improvement efforts, coordinate greater cooperation with other healthcare partners, and deliver resources locally for the EMS system.

In the absence of such an order, any amount, including interest, that accrues in excess of <u>\$15,000,000</u> \$3,000,000 must be transferred by the State Controller to the Maine Budget Stabilization Fund, established in Title 5, section 1532. Beginning July 1, 2010, the fund's maximum allowable balance must be adjusted annually on July 1st by any percentage change in the Consumer Price Index from January 1st to December 31st of the previous year, but only to a maximum increase of 2%.

PART Q

SUMMARY

This Part amends the maximum amount of funding that may be held in the Disaster Recovery Fund, Other Special Revenue Fund account in the Department of Defense, Veterans and Emergency Management to address the existing obligations of the fund and plan for the increasing frequency of disaster declarations. This Part also removes the CPI factor from the statute. This Part also transfers \$15,000,000 from the unappropriated surplus of the General Fund to the Disaster Recovery Fund, Other Special Revenue Funds account within the Department of Defense, Veterans and Emergency Management to fund the State's share of estimated disaster recovery costs.

Notwithstanding any provision of law to the contrary, on or before June 30, 2025, the State Controller shall transfer \$200,000 from the unappropriated surplus of the General Fund to the Department of Public Safety, Safe Homes Program, Other Special Revenue Funds account to provide one-time funding to support the safe storage of prescription drugs, firearms and dangerous weapons in homes or public spaces.

PART EEE SUMMARY

This Part requires the transfer of \$200,000 in fiscal year 2024-25 from the unappropriated surplus of the General Fund to the Department of Public Safety, Safe Homes Program, Other Special Revenue Funds account to provide one-time funding to support the safe storage of prescription drugs, firearms, and dangerous weapons in homes or public spaces.

PART FFF

Sec. FFF-1. Promotion adjustments in Department of Public Safety, Office of the State Fire Marshall. A person employed by the office as a Fire Investigator may be promoted to a Senior Fire Investigator if they become certified as a Fire Investigator by the International Association of Arson Investigators (IAAI) or equivalent certification body. The effective date of the promotion would be the date the employee officially became certified.

When a Senior Fire Investigator position is vacated, that position reverts to the Fire Investigator position.

Sec. FFF-2. Costs to General Fund for promotion adjustments. Costs to the General Fund due to section 1 of this Part must be provided from the Salary Plan program, General Fund account in the Department of Administrative and Financial Services in an amount up to \$10,000 for the fiscal year ending June 30, 2024 and in an amount up to \$13,000 for the fiscal year ending June 30, 2025 to implement the initiative in section 1.

PART FFF SUMMARY

This Part authorizes employees in a Fire Investigator position to immediately progress to a Senior Fire Investigator position upon successful completion of the Fire Investigator certification by the International Association of Arson Investigators (IAAI) or equivalent certification body. The changes will approve the ability of the Office of the State Fire Marshall to attract and retain capable investigators.
