All Other expenses include necessary minor equipment, transportation of the tree-length logs cut in Baxter State Park's Scientific Forest Management Area for peeling and delivery to Daicey Pond, land storage for logs during the off-season, rental of construction material debris containers and disposal, waste pumping and removal.
