The SSMI position is responsible for the planning, coordination, and implementation of the High-Fidelity Wraparound Maine Evidence Based Practice (EBP) pilot for children prioritized with the most acute needs and longest wait times for community-based services. Other responsibilities include contract development and management, outcome data assessment, and MaineCare policy recommendations. This position is split funded between the Home and Community Based Services Admin - ARP Savings account, Other Special Revenue Funds and the Office of MaineCare Services account, Federal Expenditures Fund. The Other Special Revenue Funds portion is funded by anticipated unencumbered balance forward and the Federal Expenditures Fund portion is funded by an existing entitlement grant. Failure to allot these funds would result in the lack of program oversight. This position started on August 15, 2022 and will end August 14, 2024.
