LD 17 An Act to Designate the Warden of the Maine State Prison as Chief Administrative Officer of the Bolduc Correctional Facility

ENACTED LAW SUMMARY

Public Law 2025, chapter 4 designates the warden of the Maine State Prison as the chief administrative officer of the Bolduc Correctional Facility and removes the power to appoint an assistant director. The law also changes the provision of law allowing the warden to appoint deputy wardens to clarify that any deputies appointed by the warden are responsible when the warden is absent or unable to perform the duties of the office rather than specifically absent from the Maine State Prison or unable to perform the duties of the office.

LD 28 Resolve, to Rename the Twin Rivers Fire Academy in Fairfield the Duane Bickford Fire Training Facility

ENACTED LAW SUMMARY

Resolve 2025, chapter 28 directs the Town of Fairfield to designate the firefighter training facility in Fairfield as the Duane Bickford Fire Academy.

LD 42 An Act Regarding the Bind-over and Detention of Juveniles

ENACTED LAW SUMMARY

Public Law 2025, chapter 361 amends the law regarding the Juvenile Court binding over a juvenile for prosecution as an adult and introduces provisions governing a juvenile's stay of detention in an adult section of a jail pending indictment in the following ways.

- 1. It allows the Department of Corrections to request and the Juvenile Court to order that a juvenile that would otherwise be detained in an adult section of a jail be detained in a department detention facility operated exclusively for juveniles. In making that determination, the Juvenile Court must consider whether the juvenile's behavior at the juvenile facility creates a risk of harm to others, whether the juvenile has behavioral health needs that would be better served at the juvenile facility and whether the juvenile is engaged in education or treatment programs at the juvenile facility that would be disrupted by detention in the adult section of a jail.
- 2. It requires a Juvenile Court to include in its order for the bind-over hearing its decision regarding the stay of detention in an adult section of a jail if the request is made prior to the bind-over hearing.
- 3. It allows for the department to request that the Juvenile Court rescind an order granting stay of detention at an adult facility if it is no longer appropriate for the juvenile.

4. It clarifies that a person may not be detained in a detention facility approved or operated by the department exclusively for juveniles if the person has attained 18 years of age and an indictment has been returned or if the person attains 21 years of age.

LD 45 An Act Allowing the Department of Corrections to Offset Some of the Costs of Technology Provided to Residents of Correctional Facilities

ENACTED LAW SUMMARY

Public Law 2025, chapter 352 allows the Commissioner of Corrections to establish fees for the use of technology by residents of correctional facilities. The commissioner may not charge a technology fee to a resident who is using technology for the purpose of research related to a criminal case or civil lawsuit in which the resident is involved. Additionally, the commissioner may not charge a technology fee that exceeds 7% of a resident's earnings for the calendar month after accounting for certain deductions from the resident's earnings. If a resident's earnings are less than \$100 in a month after any deductions are applied, the commissioner may not charge the resident for the use of technology.

Funds from the technology fee must be deposited into the Resident Technology Fund, which is established in the law. The fund may be used by the department to offset the cost of buying and maintaining technology provided to residents of correctional facilities.

LD 97 An Act to Facilitate the Improvement of Credit Scores of Residents of Department of Corrections Facilities

ENACTED LAW SUMMARY

Public Law 2025, chapter 6 allows a juvenile or adult client of a correctional facility to obtain a loan from a financial institution or credit union if the loan is designed to improve a client's credit score, the funds are deposited in the client's savings account at the financial institution or credit union, the loan is secured in full by funds disbursed by the client after any collections required by law and the loan is required to be repaid in full using those secured funds or other funds disbursed by the client. The loan funds are prohibited from being used for restitution or the client's telephone call account.

LD 120 An Act to Expand the Membership of the Homeland Security Advisory Council

ENACTED LAW SUMMARY

Public Law 2025, chapter 195 changes the membership of the Homeland Security Advisory Council by including the designee of any ex officio member and by adding to the council the Chief Information Officer within the Department of Administrative and Financial Services, Office of

Information Technology and the director of the Maine School Safety Center established within the Department of Education or their designees.

LD 121 An Act to Amend the Maine Litter Control Act

ENACTED LAW SUMMARY

Public Law 2025, chapter 176 amends the Maine Litter Control Act by adding brush and yard debris to the definition of "litter." Brush and yard debris do not include slash as defined by the Maine Revised Statutes, Title 12, section 9331 that is generated by or on behalf of a public entity. The law also requires that a person have an intentional state of mind to be found liable for littering.

LD 172 An Act to Require the Maine State Police to Create a Statewide List of Missing Persons and Study Improvements for Investigating Missing Persons Cases

ENACTED LAW SUMMARY

Public Law, chapter 447 requires the Department of Public Safety, Bureau of State Police to establish and maintain a publicly accessible website that lists all open missing persons cases in the State. The website must be updated, at a minimum, once every month to include any new missing person's information.

The law also directs the bureau to convene a working group to review best practices for investigating missing persons cases, determine the feasibility of implementing those best practices in the Maine Criminal Justice Academy's curriculum, review the effectiveness of the Silver Alert Program and identify ways to improve the program. The law directs the bureau to submit a report by December 3, 2025 to the Joint Standing Committee on Criminal Justice and Public Safety, which may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 176 An Act to Authorize the Formation of Emergency Medical Services Districts

ENACTED LAW SUMMARY

Public Law 2025, chapter 334 authorizes municipalities, in cooperation with one or more other municipalities, to form emergency medical services districts.

LD 224 An Act to Expand the Definition of "Terrorism" in the Laws Governing the Maine Emergency Management Agency

ENACTED LAW SUMMARY

Public Law 2025, chapter 77 updates the definition of "terrorism" in the laws governing the Department of Defense, Veterans and Emergency Management, Maine Emergency Management Agency to include the unlawful use of force or violence against persons or property to intimidate or coerce a government or civilian population. "Terrorism" includes conduct that constitutes a cyberattack on information and communications technology infrastructure, systems or services affecting the State.

The law also adds a definition for "cyberattack," which means activity targeting information and communications technology infrastructure, systems or services affecting the State or the State's critical infrastructure, whether physical or non-physical, for the purpose of disrupting, disabling, destroying or maliciously controlling such infrastructure, systems or services or destroying the integrity of the data or stealing the information residing thereon.

LD 405 An Act to Require Reporting on the Uses of Prisoner Segregation

ENACTED LAW SUMMARY

Public Law 2025, chapter 259 requires the Commissioner of Corrections to report instances of segregation in which a prisoner is segregated and not allowed to leave their cell for a minimum of 22 hours within a 24-hour period in a correctional facility, county jail or regional jail, to the joint standing committee of the Legislature having jurisdiction over criminal justice and public safety matters. This report must include the total number of prisoners who were segregated, the total amount of time a prisoner was segregated for each instance of segregation and the reason why the prisoner was segregated. After reviewing the report, the law authorizes the committee submit legislation to address issues raised by the report.

LD 583 An Act to Support Informed Community Self-determination in Emergency Medical Services Planning

ENACTED LAW SUMMARY

Public Law 2025, chapter 457 provides a one-time appropriation of \$100,000 for the Maine Emergency Medical Services Community Grant Program.

LD 626 An Act to Explicitly Allow the Department of Corrections to Charge Room and Board to Residents Who Perform Remote Work in Detention and Correctional Facilities and to Amend the Laws Governing Rehabilitative Programs

ENACTED LAW SUMMARY

Public Law 2025, chapter 234 allows the Commissioner of Corrections to charge room and board to correctional facility residents who perform remote work in a facility under the commissioner's control and amends the laws governing rehabilitative programs to add references to education release, public service release and remote work. The commissioner may charge up to 10% of a resident's work release earnings for transportation for residents participating in work release and up to 10% of a resident's work release or remote work earnings for the cost of room and board for residents participating in work release or remote work.

LD 719 Resolve, to Direct the County Corrections Professional Standards Council to Examine Funding of and Compliance by County and Regional Jails

ENACTED LAW SUMMARY

Resolve 2025, chapter 73 directs the County Corrections Professional Standards Council to examine county and regional jail compliance with financial reporting requirements and examine state funding for county and regional jails, including reviewing the status of county and regional jail compliance with financial auditing requirements; reviewing the status of county and regional jail reporting of operating expenses to the Department of Corrections; reviewing any unfunded mandates related to county and regional jails; examining improvements to the operations of the County Corrections Professional Standards Council; and examining future needs for state support for county and regional jail operations.

The law requires the County Corrections Professional Standards Council to submit a report by January 15, 2026 to the Joint Standing Committee on Criminal Justice and Public Safety, which may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 786 An Act to Promote Public Safety and Retain Essential First Responders by Converting the Maine Length of Service Award Program Trust Fund to a Nonlapsing Fund

ENACTED LAW SUMMARY

Public Law 2025, chapter 202 amends the law establishing the Maine Length of Service Award Program trust fund to convert the trust fund to a nonlapsing fund.

LD 841 Resolve, to Study the Delivery of Emergency Medical Services to and Ferry Service Effects on Unbridged Island Communities in the State

ENACTED LAW SUMMARY

Resolve 2025, chapter 93 directs the Department of Public Safety, Maine Emergency Medical Services to convene a working group to study the delivery of emergency medical services to and ferry service implications on unbridged island communities in the State. The department is required by January 1, 2026 to submit a report on its study to the Joint Standing Committee on Transportation and the Joint Standing Committee on Criminal Justice and Public Safety. Either committees may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

Resolve 2025, chapter 93 was finally passed as an emergency measure effective June 20, 2025.

LD 930 An Act to Amend the Law Governing Items Identified as Prison Contraband

ENACTED LAW SUMMARY

Public Law 2025, chapter 355 amends the laws governing prison contraband as follows. The law provides that a person commits a class C crime if the person intentionally obtains, possesses or makes electronic prison contraband that is intended to commit a separate crime. A person commits a class D crime if the person intentionally obtains, possesses or makes electronic prison contraband that is not intended to be used to commit a separate crime. The law also provides that a person commits a class D crime if the person traffics prison contraband that is an unauthorized vaping device.

LD 931 An Act to Amend the Law Allowing Individuals Subject to Pretrial or Presentence Incarceration to Be Credited Time for Participation in Work Projects Within a Jail

ENACTED LAW SUMMARY

Public Law 2025, chapter 341 provides that an inmate who is detained at a county jail or regional jail pretrial or presentence and who voluntarily participates in work projects within the jail is eligible to have the inmate's sentence to the jail prorated at the rate of up to one day removed from the sentence for every 16 hours of participation in the work project.

LD 1005 Resolve, to Study Authorization for Municipal Fire Departments with Trained Personnel to Conduct Fire Sprinkler System Plan Reviews

ENACTED LAW SUMMARY

Resolve 2025, chapter 103 directs the Department of Public Safety, Office of the State Fire Marshal to convene a working group of stakeholders to study allowing the office to authorize municipal fire departments with trained personnel to conduct fire sprinkler system plan reviews. The office is required to submit a report by December 3, 2025 to the Joint Standing Committee on Criminal Justice and Public Safety and the Joint Standing Committee on Housing and Economic Development. The law authorizes the Joint Standing Committee on Criminal Justice and Public Safety to submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 1074 An Act to Remove the Limit on the Length of Probation That May Be Served for Aggravated Attempted Murder

ENACTED LAW SUMMARY

Public Law 2025, chapter 207 amends the Maine Criminal Code to provide that the period of probation for a person sentenced for aggravated attempted murder may be any term of years.

LD 1135 Resolve, to Convene a Working Group to Study the Use of Oral Fluid Testing in Determining Intoxication of Drivers, Aircraft Operators and Hunters

ENACTED LAW SUMMARY

Resolve 2025, chapter 87 directs the Department of Public Safety, Bureau of Highway Safety to convene a working group to study the use of oral fluid testing to determine the intoxication of drivers, aircraft operators and hunters. The bureau is required to submit a report by January 1, 2026 to the Joint Standing Committee on Criminal Justice and Public Safety. The law authorizes the committee to submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 1146 An Act Regarding the Required State of Mind Relating to Robbery

ENACTED LAW SUMMARY

Public Law 2025, chapter 327 amends the robbery statute in response to the new federal standard set by *Counterman v. Colorado*, 600 U.S. 66 (2023). The law requires that an actor must intentionally or knowingly threaten a person while committing theft to have the culpable state of mind to be found criminally liable for robbery.

LD 1150 An Act to Require Reporting of Sheltering or Aiding Missing Children

ENACTED LAW SUMMARY

Public Law 2025, chapter 63 requires that if a person knowingly shelters or aids in obtaining shelter for a missing child for more than 24 hours without the consent of the missing child's parent, guardian or legal custodian, the person must provide information regarding the missing child's location and condition to a law enforcement officer who has contacted that person. A person who violates this provision is subject to a civil penalty not to exceed \$250.

LD 1366 An Act to Amend Certain Provisions of the Drug Laws Related to Cocaine Base

ENACTED LAW SUMMARY

Public Law 2025, chapter 326 eliminates possession of cocaine in the form of cocaine base in a quantity of more than four grams from the list of schedule W drugs for which a person who has prior convictions for drug crimes may be charged with the Class B crime of unlawful possession of scheduled drugs. The law also amends the provision of law that establishes a Class A crime for aggravated illegal importation of cocaine by removing language that allows a person to be charged under this provision for importation of cocaine in the form of cocaine base in a quantity of 32 grams or more.

LD 1607 An Act to Require Law Enforcement Agencies to Adopt Written Policies Regarding Compliance with Certain Constitutional Obligations Related to Disclosure of Evidence

ENACTED LAW SUMMARY

Public Law 2025, chapter 219 requires that, by January 1, 2026, law enforcement agencies adopt written policies regarding procedures to deal with assisting a prosecuting agency in complying with the prosecuting agency's constitutional obligations under *Brady v. Maryland*, 373 U.S. 83 (1963) and *Giglio v. United States*, 405 U.S. 150 (1972) and regarding the requirement to comply with mandatory disclosures to the Maine Criminal Justice Academy.

LD 1684 An Act to Implement Additional Criteria and Processes for the Supervised Community Confinement Program

ENACTED LAW SUMMARY

Public Law 2025, chapter 360 requires that the process and criteria for determining a Department of Corrections prisoner's eligibility in the supervised community confinement program includes considering input from the Office of Victim Services within the department and further requires that a prisoner's supervised community confinement program plan is responsive to reasonable community and victim concerns.

The law also requires that the process and criteria must include review and consideration of any validated, evidence-based domestic violence risk assessment for a prisoner who is incarcerated for a crime committed against a family or household member or dating partner and also requires a prisoner who is released to the supervised community confinement program to continue paying any victim restitution similar to what the prisoner would have paid if the prisoner had stayed in a department correctional facility.

LD 1695 An Act to Require Law Enforcement Agencies to Adopt Written Policies Regarding Sex Trafficking and Commercial Sexual Exploitation

ENACTED LAW SUMMARY

Public Law 2025, chapter 344 requires law enforcement agencies to adopt written policies regarding procedures to deal with persons who are believed to be experiencing commercial sexual exploitation or sex trafficking.

LD 1710 An Act Regarding the Authority to Transport Prisoners Confined in Jail and the Use of Physical Force with Respect to Prisoners and Persons Who Have Been Arrested

ENACTED LAW SUMMARY

Public Law 2025, chapter 429 makes the following changes to the laws governing the authority to transport prisoners confined in jail, the use of physical force with respect to prisoners and persons who have been arrested and the use of certain devices.

- 1. It authorizes corrections officers and transport officers to transport prisoners to and from court and to provide custody at the court.
- 2. It requires that for a corrections officer or supervisor to be justified in using force against a prisoner, they must have received additional certifications through in-service training requirements.
- 3. It repeals the current provisions of law referring to the use of force in the corrections context.
- 4. It enacts a provision of law to clarify the use of physical force in the corrections context.
- 5. It extends the prohibitions on using deadly force against a law enforcement officer to transport officers, corrections officers and corrections supervisors.
- 6. It extends the prohibitions on using laser pointers against a law enforcement officer to transport officers, corrections officers and corrections supervisors.
- 7. It extends the exception to the prohibition on using electronic weapons to transport officers.

LD 1725 An Act to Require Reporting Regarding County Jail Boards of Visitors

ENACTED LAW SUMMARY

Public Law 2025, chapter 345 requires that, by December 3, 2025, the sheriff for each county must submit a report to the Joint Standing Committee on Criminal Justice and Public Safety regarding the membership status of the board of visitors of each jail or other county correctional facility under the sheriff's supervision. The law authorizes the committee to submit legislation based on the report to the Second Regular Session of the 132nd Legislature. The law also makes a technical change regarding the sharing of board of visitors annual reports with other boards of visitors.

LD 1836 An Act to Implement the Recommendations of the Sex Offender Management and Risk Assessment Advisory Commission Regarding Tier II Offenses

ENACTED LAW SUMMARY

Public Law 2025, chapter 153 designates unlawful sexual contact based on lack of consent by an unconscious person to sexual contact that includes penetration as a Tier II offense under the Sex Offender Registration and Notification Act of 2013.

Public Law 2025, chapter 153 was enacted as an emergency measure effective May 30, 2025.

LD 1844 An Act to Expand the State's Workforce by Supporting the Transition from Incarceration to Employment

ENACTED LAW SUMMARY

Public Law 2025, chapter 485 directs the Commissioner of Corrections to establish and maintain reentry services for residents of correctional facilities. Reentry services must include services related to health and wellness, financial literacy and planning, employment preparation, community and family integration and technology training.

LD 1849 An Act to Establish a Minimum Age at Which Conduct Constitutes a Juvenile Crime and to Confer Jurisdiction to the Juvenile Courts Over Any Criminal Offense Under Maine Law Committed by a Juvenile

ENACTED LAW SUMMARY

Public Law 2025, chapter 431 modifies provisions of the Maine Juvenile Code as follows.

The law changes the definition of "juvenile" to mean a person who had attained 11 years of age but not 18 years of age at the time the person committed an alleged juvenile crime, except that, for

the crimes of murder, felony murder and manslaughter and the criminal attempt of those crimes, there is no minimum age.

Previously, the definition of "juvenile crime" limited which crimes established under the Maine Revised Statutes, Title 12 and Title 29-A that a juvenile may be charged with, providing that only specifically named crimes within those Titles are considered juvenile crimes. Public Law 2025, chapter 431 removes that language establishing these limitations so that any crime under Title 12 and Title 29-A is considered a juvenile crime if committed by a juvenile. The Maine Juvenile Code provides for the disposition following adjudication for certain juvenile crimes. The law adjusts the provisions related to the disposition following adjudication for violations of Title 12 and Title 29-A.

LD 1886 An Act to Include Serious Bodily Injury in the Law Governing Motor Vehicle Violations Resulting in Death

ENACTED LAW SUMMARY

Public Law 2025, chapter 302 amends the provision of law related to penalties applicable when a person commits a motor vehicle violation that results in the death of another person to provide that those penalties also apply to a person who commits a motor vehicle violation that results in serious bodily injury to another person.

LD 1933 Resolve, to Study Pathways for Tribal Law Enforcement Officers to Receive a Waiver for the Maine Criminal Justice Academy Basic Law Enforcement Training Requirement

ENACTED LAW SUMMARY

Resolve 2025, chapter 83 directs the Director of the Maine Criminal Justice Academy to convene a working group that includes representatives from each federally recognized Indian nation, tribe or band in the State that has law enforcement officers to study the eligibility of certain tribal law enforcement officers to receive waivers for the academy's basic law enforcement training requirements. The law requires the academy to submit a report by January 1, 2026 to the Joint Standing Committee on Criminal Justice and Public Safety, which may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 1979 Resolve, Directing the Department of Corrections to Convene a Working Group to Examine the Establishment of a Program to Award Earned Time Credit for Educational Achievement to Persons Who Are Incarcerated

ENACTED LAW SUMMARY

Resolve 2025, chapter 81 directs the Department of Corrections to convene a working group to examine the establishment of a program to award earned time credit for educational achievement to persons who are incarcerated and report the working group's findings to the Joint Standing Committee on Criminal Justice and Public Safety no later than December 3, 2025. The law authorizes the committee to report out legislation based on the report to the Second Regular Session of the 132nd Legislature.

LD 1981 An Act to Implement the Recommendations of the Emergency Medical Services' Board and the Blue Ribbon Commission to Study Emergency Medical Services in the State

ENACTED LAW SUMMARY

Public Law 2025, chapter 491 directs the Emergency Medical Services' Board, by majority vote and in consultation with the Commissioner of Public Safety or the commissioner's designee, to appoint the Emergency Medical Services Licensing Board to carry out the licensing of emergency medical services persons and emergency medical services training centers and carry out the investigation of and adjudication of complaints.
