## LD 8 An Act Regarding the Term of Appointment of Judicial Officers

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 124 clarifies that the term of appointment of a judicial officer appointed pursuant to the Constitution of Maine begins on the date of swearing in and that the requirement in the Maine Revised Statutes, Title 5, section 6 that all public officers must qualify to perform the duties of their office within 30 days after being commissioned does not apply to such a judicial officer.

# LD 20 An Act Regarding the First Judicial District and the District Court Locations in the Judicial Divisions of Androscoggin and Western Aroostook

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 436 amends the statute establishing the judicial divisions of the District Court to require the District Court for the division of Androscoggin to be held in Lewiston, not in either Lewiston or Auburn, and to require the District Court for the division of Western Aroostook to be held only in Fort Kent, not also in Madawaska. The law also authorizes the Chief Judge of the District Court to issue an order, which must be made publicly available, reallocating any municipality or unorganized territory between the Western Aroostook and Eastern Aroostook judicial divisions. Finally, the law directs the Chief Judge to submit a report by January 15, 2026 to the Joint Standing Committee on Judiciary with recommendations for redrawing the geographic boundaries between any of the judicial divisions in the State and authorizes the committee to report out legislation based on the report.

# LD 83 An Act Concerning the Filing of Marriage Licenses and the Recording of Intentions as Part of the Electronic Vital Records System

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 130 clarifies the requirements for parties applying for and filing marriage licenses, including by requiring the attachment of electronic copies of marrying parties' intentions and all completed marriage licenses in the State's vital records system. The law also clarifies that, when a completed marriage license is returned more than 15 working days after the date of solemnization, it must be marked as a late filing. By contrast, if the parties to a marriage apply for a certificate of marriage for a marriage that occurred more than one year previously but for which no record can be found, it must be marked as a delayed marriage registration. Finally, the law specifies that municipal clerks are no longer required to give to all marrying parties the Department of Health and Human Services' brochure about the effects of alcohol and drugs on a fetus.

## LD 122 An Act to Update Certain Laws Regarding Extended Care and Adoption

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 272 makes the following changes to the State's child protection laws.

- 1. It provides that, if the child who is the subject of the child protection proceeding is at least 14 years of age, the child must be given written notice of all judicial review hearings and the opportunity to be heard at the judicial review hearing.
- 2. It provides that, if the individual who was the subject of the child protection proceeding chooses to participate in the extended care program, the court must conduct an annual judicial review while the individual is age 18, 19 or 20 but is not required to conduct an annual judicial review while the individual is age 21 or 22. Regardless of whether an annual judicial review is required, however, either the individual who is part of the extended care program or the Department of Health and Human Services may file a motion for judicial review at any time.
- 3. It provides that the transition grant program, which provides financial support and navigator services to individuals ages 23 to 26 who were formerly part of the extended care program, is available not only to students enrolled in postsecondary education institutions but also to students enrolled in postsecondary education training programs. It also removes the statutory requirement that the advisory committee established by the department to oversee the transition program must include employers.

Finally, Public Law 2025, chapter 272 amends the Maine Uniform Probate Code to remove a provision authorizing the department to share with a court considering a petition for adoption the results of criminal background checks conducted by the department but retains the provision authorizing the court, in its discretion, to conduct its own criminal background check for any prospective adoptive parent who is not already a parent of the child.

# LD 141 An Act to Provide Limited Immunity to Maine Human Rights Commission Mediators

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 80 amends the Maine Human Rights Act to provide limited immunity to Maine Human Rights Commission mediators while acting as mediators for the commission's third-party neutral mediation program.

## LD 246 An Act to Establish the Option of Sentencing Alternatives for Primary Caregivers

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 402 requires a court, in sentencing a defendant convicted of an offense, to consider a sentencing alternative other than imprisonment due to the defendant's being a primary caregiver of a minor, dependent person or incapacitated adult.

# LD 248 An Act to Rename the Administrator of the Office of Chief Medical Examiner the Director of Medical Examiner Operations

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 13 renames the office administrator of the Office of Chief Medical Examiner within the Department of the Attorney General the Director of Medical Examiner Operations.

## LD 250 An Act Regarding the Disposal of Abandoned Human Remains

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 14 provides that the Chief Medical Examiner may dispose of unidentified human remains of a deceased resident of the State that are the subject of a medical examiner case if no one takes custody and control of the remains within 15 days after the Chief Medical Examiner completes the autopsy and all necessary examinations and makes a reasonable inquiry but is unable to locate the next of kin or a person or governmental unit legally responsible for or willing to assume responsibility for the human remains. Previously, the Chief Medical Examiner was required to wait 30 days before disposing of unidentified remains in these circumstances.

# LD 251 An Act to Protect the Confidentiality of Information of Individual Customers of a Public Utility

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 99 excludes from the Freedom of Access Act's definition of "public records" information pertaining to an individual customer of a public utility regulated by the Public Utilities Commission that is designated as confidential in rules adopted by the commission. The law also excludes from the definition of "public records" information pertaining to an individual customer of a public sewer system not regulated by the commission to a similar extent that information pertaining to an individual customer of a public utility would be considered confidential under rules adopted by the commission.

# LD 267 An Act Regarding the Remote Appearance of Counsel in Pretrial Nontestimonial Criminal Matters

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 178 requires a court to schedule pretrial nontestimonial criminal matters in a manner that permits the appearance of counsel by remote methods, to the greatest extent possible, unless the court orders otherwise in the interests of justice.

# LD 284 An Act to Update Major Policy-influencing Positions Within the Maine Human Rights Commission

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 450 designates the position of Commission Counsel as a major policy-influencing position within the Maine Human Rights Commission. The law also eliminates a reference to the position of Chief Compliance Officer, which is a position that no longer exists.

# LD 353 Resolve, to Establish the Commission to Recommend Methods for Preventing Deed Fraud in the State

### **ENACTED LAW SUMMARY**

Resolve 2025, chapter 104 establishes the Commission to Recommend Methods for Preventing Deed Fraud in the State. The commission is required to make findings and recommendations for preventing deed fraud in the State, including recommendations for enhanced public awareness of deed fraud and any suggested legislation for enhancing identity verification requirements for real estate transactions in the State and for improving the civil and criminal remedies available in the State. The law requires the commission to report to the Joint Standing Committee on Judiciary by December 3, 2025 and the joint standing committee is authorized to report out legislation related to the report to the Second Regular Session of the 132nd Legislature.

Resolve 2025, chapter 104 was finally passed as an emergency measure effective July 1, 2025.

# LD 385 An Act to Protect Communications by Alleged Victims Regarding Sexual Assault, Sexual Harassment, Sexual Misconduct, Cyberbullying or Discrimination from Litigation

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 403 amends the Uniform Public Expression Protection Act by protecting from causes of action a communication made by a person without malice regarding an incident of sexual assault, sexual harassment, sexual misconduct, cyberbullying or discrimination experienced by the person, who has or at any time had a reasonable basis to file a complaint concerning the

sexual assault, sexual harassment, sexual misconduct, cyberbullying or discrimination, whether the complaint was filed or not. For purposes of this law, "discrimination" includes subjecting to harassment; failing to prevent an act of discrimination; aiding, abetting, inciting, compelling or coercing an act of discrimination; or retaliating against a person for reporting an act of discrimination.

# LD 386 An Act Regarding Information That May Be Shared by Law Enforcement Entities with a School Superintendent or a Principal

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 73 amends the Maine Juvenile Code to authorize a law enforcement officer or criminal justice agency to share otherwise confidential information pertaining to a juvenile that is credible and indicates a substantial danger involving the use of a firearm or dangerous weapon to the safety of students or school personnel on school grounds or at a school function.

## LD 403 An Act to Protect Holders of Distressed Mortgages from Fraud

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 275 requires that the written notice of a mortgagor's right to cure sent by a mortgagee must warn distressed borrowers of potential fraudulent actors who may offer their assistance in negotiating with the mortgagee and requires that the notice recommend instead that the mortgagor seek the assistance of a licensed Maine attorney or a housing counseling agency approved by the United States Department of Housing and Urban Development.

# LD 412 An Act to Prohibit the Sale of Self-administered Sexual Assault Forensic Evidence Collection Kits

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 138 prohibits the sale or offering for sale of materials advertised or marketed as a means for a person other than a licensed hospital or licensed health care practitioner to collect physical evidence of a sexual assault and establishes a rebuttable presumption that a violation of this prohibition is a violation of the Maine Unfair Trade Practices Act.

## LD 458 An Act Regarding the Domestic Violence Advocate Privilege

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 139 modifies the statute governing privileged communications between victims of domestic violence and domestic violence advocates by extending the privilege to an employee of or volunteer for a domestic violence services provider who has received a minimum of 40 hours of training on state and federal laws, rules and regulations governing confidentiality for victims of domestic violence, mandated reporting, civil and criminal legal processes, advocacy skills and local resources for victims of domestic violence.

# LD 530 An Act to Eliminate a Rebuttable Presumption Against the Admission of Certain Applicants to the Bar

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 182 eliminates the statutory rebuttable presumption that an applicant who has been convicted as an adult of a crime punishable by at least one year of imprisonment does not have the good moral character required for admission to the bar.

# LD 537 An Act to Prohibit the Doxing of a Minor and to Authorize a Related Civil Action

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 417 prohibits a person from engaging in conduct that constitutes doxing of a minor, which is defined as intentionally, knowingly or recklessly disclosing specific personal identifying information of a minor, when the person making the disclosure consciously disregards a substantial risk that the disclosure will cause, and in fact the disclosure either directly or indirectly causes, certain types of harm to the minor or a close relation of the minor, including stalking, physical harm, serious damage to the minor's or a close relation's property or that the minor or a close relation of the minor reasonably fears for the minor's physical safety or the physical safety of a close relation.

A minor may bring a civil action for injunctive relief, actual damages, compensatory damages, attorney's fees and costs and any other appropriate relief against a person who engages in doxing of a minor, except that it is a defense to such an action that the person's sole purpose for disclosing the minor's personally identifying information was reporting to law enforcement conduct that the defendant reasonably believed to be unlawful; reporting conduct by a public official or law enforcement that the defendant reasonably believed to be unlawful; or engaging in constitutionally protected activity pertaining to freedom of speech, assembly press or petition. In addition to or in lieu of bringing a civil action, the minor may obtain a protection from harassment order against a person who doxes the minor.

LD 586 An Act to Provide a Court Authority to Issue Proximity Restrictions in Protection from Abuse Orders

### **ENACTED LAW SUMMARY**

Beginning January 1, 2026, Public Law 2025, chapter 22 authorizes a court to issue a final protection order directing a defendant to refrain from knowingly being within a specified distance of a plaintiff or from being present at a specific location.

LD 640 An Act Requiring That Certain Fees Charged by the Courts for Court-ordered Payments Be Capped and Paid by the Defendant

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 260 requires a court to inform all prospective parties to a court judgment or decree that a 5% fee will be assessed on all accrued interest whenever a court receives any money to be held by the court, to be paid by the nonprevailing party of the action.

#### LD 654 An Act to Increase the Maximum Small Claim Limit

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 261 raises the maximum small claim limit from \$6,000 to \$10,000. The law takes effect January 1, 2026.

#### LD 670 An Act to Address Coercive Control in Domestic Abuse Cases

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 379 amends the definition of "abuse" for purposes of the protection from abuse laws to include compelling a person by coercion to engage in conduct from which the person has a right or privilege to abstain or to abstain from conduct in which the person has a right to engage.

LD 753 An Act to Authorize the Use of Funds Resulting from the Issuance of Securities by the Maine Governmental Facilities Authority for the Purpose of Developing or Improving New or Existing Court Facilities in Penobscot County

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 462 authorizes the use of securities issued for the purpose of planning, purchasing, financing, acquiring, constructing, renovating, furnishing, equipping, improving,

extending, enlarging and consolidating new and existing facilities and projects relating to the judicial branch to include such facilities in Penobscot County.

## LD 779 An Act to Fund the Aroostook County Drug Treatment Court

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 463 provides funds in fiscal year 2026-2027 related to the creation of a drug treatment court in Aroostook County.

# LD 809 An Act to Allow a Motion to Extend a Protection from Abuse Order After Expiration of the Original Order

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 157 authorizes a court to reinstate an expired final protection from abuse order pending a hearing on the plaintiff's motion to extend the expired order if the court finds that the plaintiff has shown good cause for filing the motion to extend after expiration of the protection order and if the motion was filed within a reasonable amount of time based on the underlying circumstances.

# LD 922 An Act to Amend the Procedure for Filing a Petition to Terminate Parental Rights and Responsibilities

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 20 amends the law authorizing a parent to file a petition to terminate another parent's parental rights and responsibilities by removing the requirement that the petition be filed in the same case as any prior adjudication of parental rights and responsibilities.

# LD 950 An Act to Increase Access to Protection from Abuse Orders by Allowing Children to File Protection from Abuse Orders on Their Own Behalf

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 158 authorizes a child to file a complaint for a protection from abuse order on the child's own behalf.

LD 966 An Act Allowing Access by State Agencies and Hospitals to Certain Confidential Probate Court Records

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 18 amends the provisions of the Maine Uniform Probate Code regarding the confidentiality of probate proceedings in the following ways.

- 1. It provides that an authorized employee or legal counsel of the Department of Health and Human Services, the Office of the Attorney General, an agency designated by the Governor to provide protection and advocacy for persons with disabilities, a private mental hospital or a hospital may access confidential probate court records in adult or minor guardianship, conservatorship and protective arrangement proceedings if the access is to carry out an official function, duty or responsibility in the public interest.
- 2. It permits an authorized employee or legal counsel of a nonprofit organization that provides civil legal services to elderly residents of the State and that receives funding from the Maine Civil Legal Services Fund to access confidential probate court records in adult guardianship, conservatorship and protective arrangement proceedings if the access is to carry out an official function, duty or responsibility in the public interest.
- 3. It delays the April 1, 2025 effective date of the statutes governing the confidentiality of records in adult and minor guardianship, conservatorship and protective arrangement proceedings. Under Public Law 2025, chapter 18, these statutes take effect on January 15, 2026 or on the effective date of amendments to the Maine Rules of Probate Procedure incorporating the substantive requirements of the law, whichever is earlier.
- 4. It directs the Supreme Judicial Court when it adopts amendments to the Maine Rules of Probate Procedure to carry out the provisions of this law to specify how an entity described in this law may designate an employee who must have the ability to access and to review probate court records to carry out an official function, duty or responsibility in the public interest; the process by which a register of probate shall ensure that an individual seeking access to probate court records is authorized to access those records; and the process by which the register shall provide access to those records.
- 5. It requires the Supreme Judicial Court to submit reports by May 1, 2025 and by June 1, 2025 to the Joint Standing Committee on Judiciary describing the progress made toward adopting amendments to the Maine Rules of Probate Procedure to carry out the provisions of this law and identifying the estimated date by which those amended rules will take effect.

Public Law 2025, chapter 18 was enacted as an emergency measure effective April 1, 2025.

# LD 983 An Act Regarding Service of Notice of Restricted Person Status to Hospitalized Patients

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 104 amends the law governing hospital cooperation with law enforcement agencies to allow a law enforcement agency to request that a hospital provide access to a patient for purposes of notification of restricted person status for a person taken into protective custody by a law enforcement officer due to likelihood of foreseeable harm.

# LD 1027 An Act to Strengthen the Law Regarding Relief for Improvident Transfers of Title

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 279 requires a court to award attorney's fees in a case where it has been demonstrated that a person exerted undue influence over an elderly dependent person with respect to a property transfer.

# LD 1101 An Act to Address the Limited Availability of Counsel in Courts to Represent Indigent Parties in Matters Affecting Their Fundamental Rights

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 40 requires the Maine Commission on Public Defense Services to compensate a private attorney appointed by a court to represent a person who is eligible to receive indigent legal services if the court finds that no public defender, assigned counsel, contract counsel or employed counsel is available to represent the person; the private attorney is willing to undertake the representation; the private attorney has not been disqualified by the commission; and, if the private attorney is appointed by the trial court, the attorney has least three years of relevant legal experience or, if the private attorney is appointed by the Supreme Judicial Court, the private attorney has either three years of relevant legal experience or previously served as a law clerk analyzing relevant cases. The provision is repealed on February 1, 2026.

Public Law 2025, chapter 40 also provides funding to the commission to compensate private attorneys that this law authorizes the courts to appoint. In addition, it establishes five new Public Service Manager III positions, also known as Assistant District Defender positions, two Paralegal positions and one Legal Administrator position. The new positions are primarily responsible for providing indigent legal services to criminal defendants and parties in child protective proceedings for whom another public defender, assigned counsel, contract counsel or employed counsel is not available to represent the defendant or party and, to the extent there is additional capacity, these positions may also represent other individuals who are eligible for indigent legal services but for whom another public defender, assigned counsel, contract counsel or employed counsel is not available to represent the person.

Finally, Public Law 2025, chapter 40 requires the commission and the judicial branch to submit reports to the Joint Standing Committee on Judiciary by January 1, 2026, with an update on the status of the *Robbins v. Billings, et al.*, No. CV-22-054 (Me. Superior Court) litigation, including information on any defendants who have been granted habeas corpus relief by the court and with specific information about the implementation of the provisions of this legislation. The law authorizes the committee to report out legislation in response to these reports to the Second Regular Session of the 132nd Legislature.

Public Law 2025, chapter 40 was enacted as an emergency measure effective April 23, 2025.

# LD 1113 An Act Regarding Fairness in Sentencing for Persons Based on Age

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 420 requires that, when sentencing an individual for a Class A, Class B or Class C crime, a court consider the age of the individual at the time the conduct forming the basis for the conviction occurred, in addition to the other sentencing factors considered by the court.

# LD 1129 An Act to Clarify Standards for Defendants' Post-judgment Motions for Relief from Protection from Abuse Orders

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 159 provides that a defendant may not file a motion to extinguish a final protection from abuse order and that a court may dismiss any such motion without hearing and before opposition is filed by the plaintiff.

# LD 1133 An Act to Allow Electric Vehicle Charging Stations by Condominium and Residential Associations

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 280 makes any provision of bylaws or the declaration of an association of unit owners that places an unreasonable restriction on the installation or use of an electric vehicle charging station void and unenforceable beginning January 1, 2026. The law also allows a unit owner to apply to the executive board of an association of unit owners to gain approval to install an electric vehicle charging station in a unit parking space or limited common element parking space. The law requires the unit owner to comply with any bylaws, provide a certificate of insurance and pay for any costs associated with, and electricity usage related to, the electric vehicle charging station. A prevailing party in an action to seek compliance with these provisions must be awarded reasonable attorney's fees.

## LD 1174 An Act to Limit the Liability of Gun Shops That Provide Firearm Hold Agreements

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 357 allows a gun shop to take possession of a firearm owned by a person if the gun shop enters into a written firearm hold agreement with the owner and contacts the owner every six months. The firearm hold agreement must indicate a family member or other individual who may lawfully possess a firearm and will take possession of the firearm upon proof of the death of the owner of the firearm during the pendency of the firearm hold agreement. The law prohibits an action from being brought against a person for refusing to enter into a firearm hold agreement.

## LD 1185 An Act to Prohibit Persons Under 18 Years of Age from Marrying

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 47 repeals the provision of law that authorizes a marriage license to be issued to a minor who is 17 years of age with the written consent of the minor's parent or guardian or the judge of probate in the county where the minor resides. The law further provides that a marriage license may not be issued to a person who has not attained 18 years of age.

# LD 1189 An Act to Allow an Attorney for the State to Determine Whether to Charge Certain Class E Crimes as Civil Violations

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 496 directs the attorney for the State to determine whether to charge a defendant for a civil violation in place of a Class E crime that is not eligible for probation, a crime in Maine's election statutes or a crime that would result in a mandatory driver's license suspension, based upon a variety of factors and with a penalty of no more than \$1,000. The factors involved in the determination are not elements of the criminal offense or civil violation and the determination is not subject to judicial review. The law requires the court to inform the Secretary of State of any Class E crime involving motor vehicles that the attorney for the State elected to charge as a civil violation if the defendant is adjudicated as having committed the civil violation.

LD 1266 Resolve, Directing the Department of Health and Human Services, Office of Behavioral Health to Convene a Working Group to Propose a Plan for Expanding the Reach of Treatment Courts

#### **ENACTED LAW SUMMARY**

Resolve 2025, chapter 98 directs the Department of Health and Human Services, Office of Behavioral Health to establish a working group comprised of a multidisciplinary group of stakeholders to develop a plan for expanding the availability of adult drug treatment courts, family

treatment courts and veterans treatment courts across the State by ensuring that defendants in each prosecutorial district and county have access to these specialty court dockets. The Department of Health and Human Services, Office of Behavioral Health is required to submit a report, including any recommendations from the working group for expanding the scope and geographic location of treatment courts, to the Joint Standing Committee on Judiciary no later than January 1, 2026. The law authorizes the committee to report out legislation related to the report to the Second Regular Session of the 132nd Legislature.

# LD 1427 An Act Extending the Statute of Limitations on Criminal Actions Involving Aggravated Sex Trafficking

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 479 extends the statute of limitations for prosecution of a Class A or Class B crime involving sex trafficking from six years to 20 years following commission of the crime. This change applies only to those crimes committed on or after the effective date of the law or for which the prosecution has not yet been barred by the statute of limitations in force immediately prior to the effective date of this law.

Public Law 2025, chapter 479 also directs the Criminal Law Advisory Commission to review and analyze the statutes of limitation within the Maine Criminal Code pertaining to sexual offenses committed against both adult and minor victims and to submit a report, including any recommendations, to the Joint Standing Committee on Judiciary no later than December 15, 2025. The law authorizes the committee to report out legislation related to the report to the Second Regular Session of the 132nd Legislature.

#### LD 1440 An Act to Amend the Maine Uniform Probate Code

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 168 makes several modifications proposed by the Probate and Trust Law Advisory Commission to the Maine Uniform Probate Code and related provisions of law related to marriage and domestic partnerships, personal representatives, termination or modification of adult guardianships and the process for surrender and release of parental rights and consent for adoption when the parent resides in another state. The law also acknowledges comments submitted by the commission describing these changes as Maine Comments that should be submitted for inclusion in the publication of the Maine Revised Statutes Annotated.

LD 1471 An Act to Require Energy Efficiency Disclosure Statements for Certain Rental Housing in the State

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 411 allows a tenant, beginning January 1, 2030, to terminate the tenant's lease if the landlord fails to provide a signed energy efficiency disclosure statement required to be provided by landlords by law. A landlord may not retain any fee, in addition to a security deposit or a portion of a security deposit, for a lease or tenancy at will terminated as a result of a failure to provide a signed energy efficiency disclosure statement.

LD 1545 An Act to Clarify the Maximum Value That a Small Estate May Be Under the Maine Uniform Probate Code to Permit Collection of Personal Property by Affidavit

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 76 amends the provision of law within the Maine Uniform Probate Code governing collection of personal property by affidavit from estates with values that do not exceed \$40,000 to clarify that the \$40,000 figure must be adjusted for inflation pursuant to the cost-of living adjustment provision of the Maine Uniform Probate Code. The law also requires each county probate court to annually publish the value of the inflation-adjusted figure on the court's publicly accessible website.

### LD 1598 An Act to Provide Relocation Assistance to Crime Victims

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 171 provides that a crime victim is eligible to receive compensation from the Victims' Compensation fund for the victim's actual and reasonable relocation expenses, not just security deposits as in current law.

LD 1651 An Act to Remove the Term "Alleged" When Referring to Victims of Sexual Assault in the Provisions of the Maine Revised Statutes Pertaining to Forensic Examinations

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 109 removes the term "alleged" when referring to victims of sexual assault in the provisions of the Maine Revised Statutes pertaining to forensic examinations.

# LD 1750 An Act to Require the Attorney General to Create and Update Biennially a Model Residential Lease

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 426 requires the Attorney General to, within existing resources, create and post on its publicly accessible website a model residential lease that complies with current law, including any disclosure and any document required to be attached to a residential lease, and to update the model lease biennially.

# LD 1778 An Act to Update Provisions of the Maine Administrative Procedure Act

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 384 updates certain provisions of the Maine Administrative Procedure Act and related provisions by making the following changes.

- 1. It clarifies provisions relating to rule-making public hearings conducted by boards.
- 2. It revises and reorganizes the current provisions regarding rule basis statements, comments on proposed rules and agency responses to those comments, consistency of the text of proposed rules with the text of rules revised during the rule-making process and maintenance by agencies of rule files for each rule that is adopted.
- 3. It adjusts provisions relating to rule-making notices and the public availability of proposed rules to ensure that the time frames stated in those notices and rules are consistent with each other and other provisions of the Maine Administrative Procedure Act.
- 4. It updates the provision that lists the information that must be included in rule-making proposal public notices to ensure consistency with current practices.
- 5. It updates the provision pertaining to agencies' obligation to make copies of proposed rules available to the public.
- 6. It repeals the provision regarding fees that agencies may charge to provide notices of rule-making proposals and copies of proposed rules, as such information is now readily available online at no cost.
- 7. It updates the provision that requires the Secretary of State to arrange for weekly newspaper publication of agency rule-making proposal notices and requires online posting of the notices.
- 8. It requires agencies to post their proposed rules on their publicly accessible websites, as well as to post their adopted rules on those websites or provide a link to their rules that are posted on a website maintained by the Secretary of State.

- 9. It updates and clarifies the provision that requires the Secretary of State to post agency rule-making notices regarding adoption online.
- 10. It requires the Secretary of State to post online a brief explanation of the rule-making process, including an explanation of how a public hearing on a proposed rule may be requested if such a hearing has not been scheduled.
- 11. It revises the provision regarding agencies' filing of adopted rules to:
  - A. Account for technological updates, including the availability of rules and rule-making information and notifications online:
  - B. Account for the fact that the Secretary of State does not compile and publish a formal code or registry of state agency rules;
  - C. Relocate and revise the provision regarding the incorporation of materials by reference by agencies into their rules;
  - D. Update and clarify the provision regarding certification of adopted rules by the Secretary of State; and
  - E. Strengthen the provision that authorizes minor errors in rules to be corrected by the Secretary of State without agency rulemaking having to occur.
- 12. It revises current provisions concerning annual reports that are provided by the Secretary of State to the Governor and to the joint standing committee of the Legislature having jurisdiction over state and local government matters.
- 13. It removes the provision that requires agencies to include a fiscal impact note at the end of each rule, as such information is now collected in other documents that accompany proposed and adopted rule filings with the Secretary of State.
- 14. It makes various technical corrections.

# LD 1797 An Act to Implement the Recommendations of the Right to Know Advisory Committee Concerning Denials of Public Records Requests

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 186 provides that a public body, agency or official that denies a request for inspection or copying of a public record must include in the written notice of denial a citation to the statutory authority used as the basis for the denial.

LD 1801 An Act to Make Technical Changes to the Laws Governing the Maine Commission on Public Defense Services

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 415 makes the following changes to the laws governing the Maine Commission on Public Defense Services.

- 1. It makes technical amendments to the definitions of "employed counsel" and "public defender."
- 2. It provides that training materials prepared or obtained by the commission in connection with providing or preparing to provide training and evaluation programs for attorneys who are or may seek to become assigned counsel, employed counsel, public defenders or contract counsel are confidential, even if those materials are disseminated in the furtherance of the commission's duties, for example at a commission-offered training.
- 3. It provides that a court must, on request, disclose otherwise confidential records associated with child protection actions to the commission for purposes of assigning, evaluating or supervising counsel.

LD 1813 An Act to Implement the Recommendations of the Right to Know Advisory Committee Concerning State Boards and Commissions

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 187 requires members of state boards and commissions established under the Maine Revised Statutes, Title 5, chapter 379 to complete a course of training on the requirements of the laws relating to public records and proceedings. The law also requires a board or commission established under Title 5, chapter 379 to designate a public access officer. The public access officer may serve as the contact person for more than one board or commission if the boards or commissions are within the same office or agency.

LD 1826 An Act to Protect the Confidentiality of Personally Identifiable Information in Records of the Permanent Commission on the Status of Racial, Indigenous and Tribal Populations

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 188 provides that personally identifiable information obtained by the Permanent Commission on the Status of Racial, Indigenous and Tribal Populations in furtherance of its statutory duty to carry out research necessary to determine the status of historically disadvantaged racial, indigenous and tribal populations is confidential, except that the executive director of the commission may authorize disclosure of the information if the executive director

has obtained the consent of the individual to whom the personally identifiable information applies. The law also provides that, notwithstanding the Maine Revised Statutes, Title 5, section 95-C, this personally identifiable information remains confidential until the relevant records have been in existence for 100 years.

# LD 1827 An Act to Implement the Recommendations of the Right to Know Advisory Committee Concerning Public Records Requests

### **ENACTED LAW SUMMARY**

By law, a public body, agency or official may deny a request for inspection or copying of a public record on the basis that the request is unduly burdensome or oppressive by filing an action for an order of protection in the Superior Court for the county where the request was made within 60 days of the date of the request.

Public Law 2025, chapter 175 additionally permits a public body, agency or official to deny a series of public records requests on the basis that the series of requests is unduly burdensome or oppressive by filing an action for protection in Superior Court within 60 days of the point at which a body, agency or official determines that the series of requests is unduly burdensome or oppressive.

# LD 1828 An Act to Implement the Recommendations of the Right to Know Advisory Committee Concerning Public Records Exceptions

## **ENACTED LAW SUMMARY**

Public Law 2025, chapter 111 implements statutory changes recommended by the Right to Know Advisory Committee following its review of certain existing public records exceptions in the Maine Revised Statutes, Titles 25, 26, 27, 30-A, 31 and 32.

- 1. It amends the public records exceptions in Title 30-A related to applicants for county and municipal jobs to clarify that personal contact information of applicants is confidential.
- 2. It amends an existing public records exception in Title 32 to clarify that information included in Board of Nursing consent agreements or other written settlements that identifies or could reasonably lead to identification of a patient is confidential.
- 3. It amends an existing public records exception in Title 32 to clarify that email addresses of applicants to or licensees of the Board of Licensure in Medicine are confidential, and that the personal residence address and telephone number of the applicant or licensee are not confidential if this information is provided as the public contact.
- 4. It makes other amendments to the language of existing public records exceptions in these titles to better conform with current drafting standards.

## LD 1832 An Act to Clarify Available Relief for the Protection of At-risk Children

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 347 clarifies that an at-risk noncitizen child may request that a court enter an order making special findings necessary for the at-risk noncitizen child to apply to the federal government for Special Immigrant Juvenile Status by either filing a petition in District Court or by filing a motion in an existing action before the District Court or a county probate court under the Maine Revised Statutes, Title 18-C, Title 19-A or Title 22 or in any other action before the juvenile court. The law also updates certain language and definitions in the statutes governing petitions and motions for special findings to better align those statutes with the language used in other state statutes and in federal law.

## LD 1877 An Act to Increase Penalties for Human Trafficking Offenses

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 387 increases from \$2,000 to \$6,000 the amount that a person convicted of aggravated sex trafficking must pay to the Victims' Compensation Fund and increases from \$1,000 to \$3,000 the amount that a person convicted of sex trafficking must pay to the Victims' Compensation Fund.

## LD 1898 An Act to Correct Outdated References Regarding the Maine Human Rights Act

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 269 modifies provisions of the Maine Human Rights Act to correct references to protection orders that were sought or received under the Maine Revised Statutes, Title 19-A, former section 4007, which was repealed effective January 1, 2023. The law clarifies that it remains unlawful to discriminate against an individual on the basis of that individual's previous actions seeking or receiving an order of protection under the former law and that it is unlawful to discriminate against an individual on the basis of that individual's previous actions seeking or receiving a final protection order under the current law or under a substantially similar provision of the law of another state or nation.

LD 1900 An Act to Bring Parity to the State's Recognition of the Wabanaki Nations' Authority to Provide Electric Power Districts and Child Support Enforcement

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 303 recognizes the authority of the Houlton Band of Maliseet Indians and the Mi'kmaq Nation to develop tribal power districts to provide electric power within their respective trust lands to the same extent that the Penobscot Nation and the Passamaquoddy Tribe

may develop tribal power districts to provide electric power within their respective reservation and trust lands.

Public Law 2025, chapter 303 also extends to the Houlton Band of Maliseet Indians and the Maliseet Tribal Court certain child support enforcement tools recognized for the Penobscot Nation and the Penobscot Nation Tribal Court.

LD 1944 An Act to Protect Individuals from the Threatened Unauthorized Dissemination of Certain Private Images, Including Artificially Generated Private Images

### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 400 expands the crime of unauthorized dissemination of certain private images to provide that a person commits this crime if the person, without the consent of a depicted person and with the intent to harass, torment or threaten the depicted person or another person, intentionally or knowingly disseminates, displays or publishes an image that has been created or modified so that it appears to show the depicted person in a state of nudity or engaged in a sexual act or sexual contact.

Public Law 2025, chapter 400 also expands the definition of "harassment" under the protection from harassment laws and the definition of "abuse" under the protection from abuse laws to allow a person to seek a protection order against another person who threatens to commit the crime of unauthorized dissemination of certain private images if the natural and probable consequence of the threat is to place the person who is depicted or who appears to be depicted in the image in reasonable fear that the crime will be committed.

LD 1984 An Act to Correct Inconsistencies, Conflicts and Errors in the Laws of Maine

#### **ENACTED LAW SUMMARY**

Public Law 2025, chapter 390 corrects technical inconsistencies, conflicts and errors in the laws of Maine, including by removing outdated, gender-specific language and outdated terminology.

Public Law 2025, chapter 390 was enacted as an emergency measure effective June 20, 2025.

## LD 249 An Act to Update Certain Medical Examiner Fees

Though this bill was not enacted, the substance of the bill was incorporated into the budget. See Appropriations and Financial Affairs, Enacted Law Summary, LD 210, Public Law 2025, chapter 388, Section A-4 and Part X.

# LD 1022 An Act to Protect and Increase Access to Justice in Civil Legal Matters for Persons with Low Incomes

Though this bill was not enacted, the budget included a one-time appropriation of \$3,000,000 above the baseline to the Maine Civil Legal Services Fund in fiscal year 2025-26. See Appropriations and Financial Affairs, Enacted Law Summary, LD 210, Public Law 2025, chapter 388, Section A-22.

## LD 1139 An Act to Provide Funding for Essential Services for Victims of Crimes

Though this bill was not enacted, the budget included an ongoing appropriation of \$3,000,000 per year beginning fiscal year 2025-26 and a one-time appropriation of an additional \$3,000,000 for each year of the 2025-2026 biennium to replace current and anticipated reductions in grants under the federal victim assistance formula grant program administered by the U.S. Department of Justice, Office of Justice Programs, Office for Victims of Crime pursuant to the federal Victims of Crime Act of 1984. # LD 1378 An Act to Protect Maine Communities by Enacting the Extreme Risk Protection Order Act (Initiated Bill)

Though this bill was not enacted or finally disposed of during the First Special Session of the 132nd Legislature, the citizens' initiative will appear on the November 2025 ballot. While the Legislative Document was carried over to the Second Regular Session by the Judiciary Committee, under the Maine Constitution the measure shall be submitted to the electors if it was not enacted without change during the legislative session in which it was presented.
