

The three structures require jacking and leveling due to foundation settling caused by freeze-thaw cycles and soil expansion and contraction. Additionally, each building needs a new roof, replacement of wood framing on porches and decks, new windows and doors, insulation, and interior trims. Failure to allot these funds will negatively impact the ability of the Baxter State Park Authority to provide critical building rehabilitation and updates to ensure public safety and enhance the visitor experience.


