The Education & Cultural Affairs Committee (EDU Committee) is pleased to submit our recommendations related to the Governor's proposals in the FY 2019 supplemental budget bill (LR 2406). The following is a summary of votes of EDU Committee members present.

- A majority of EDU Committee members voted in favor of the initiative on Page A-3 which provides one-time funding for staff support and other expenses associated with the planning of the State of Maine bicentennial celebration. Seven committee members voted in support of the initiative and one member voted in opposition to the initiative.
- The EDU Committee voted unanimously to support the passage of the initiative on Page A-8 relating to the Maine Historic Preservation Commission.
- The EDU Committee voted unanimously to support passage of the initiatives on Page A-10 relating to the Maine State Library.

The Joint Standing Committee on Energy, Utilities and Technology has reviewed those portions of the Governor's Proposed Supplemental Budget (LR 2406) that fall within the committee's jurisdiction.

<u>Part E</u> - The committee does not recommend acceptance of Part E, which proposes to transfer remaining funds in the Public Utilities Commission Cost Recovery Fund to the unappropriated surplus of the General Fund. The committee recommends that these funds remain in the cost recovery fund at this time to be considered for use to support pending proposals that have a nexus with the original intent of the fund, which was to support biomass resources. The committee voted unanimously "do not approve" (12-0) with respect to Part E.

Part G - The committee recommends acceptance of Part G regarding the Office of the Public Advocate, with a technical amendment to change the word "telecommunications" to "electric" on lines 3 and 7 of the paragraph that makes up Sec.G-1 (LR2406, Part G) to correct an error. This correction is also shown in the testimony presented by Barry Hobbins, Public Advocate on February 20, 2019 (see page 5). The committee voted unanimously "approve w/amendment" (12-0) with respect to Part G.
