The Nuclear Regulatory Commission and the Federal Emergency Management Agency regulate emergency planning for radiological emergencies within the Ingestion Exposure Pathway Zone of the Seabrook Station in New Hampshire, which includes most towns in York County. Failure to approve this financial order will have a detrimental impact on the ability of the Maine Emergency Management Agency to fund these activities.
