SUBJ:	Supplemental budget recommendations

The Joint Standing Committee on Environment and Natural Resources on February 27, 2020 reviewed the budget items pertaining to the agencies under our jurisdiction in LR 3206, An Act Making Supplemental Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2020 and June 30, 2021.

As described below, the 10 members present at the February 27, 2020 review voted to recommend acceptance of the budget proposals and language parts pertaining to the agencies under our jurisdiction in LR 3206. The Environment and Natural Resources Committee strongly supports the inclusion of those budget proposals and language parts in the final supplemental budget document.

As also described below, the 10 members present unanimously and strongly support an additional inclusion in the final supplemental budget document of the funding provisions in LD 450, as amended, which, as described below, currently sits on the Special Appropriations Table.

# **Department of Administrative and Financial Services**

The 10 members voting recommend acceptance of the budget proposal for the Department of Administrative and Financial Services as presented in OFPR Worksheet page 1.

# Department of Environmental Protection

The 10 members voting recommend acceptance of the Department of Environmental Protection's budget proposals as presented in OFPR Worksheet pages 2 through 5

# Language Parts U and V

The 10 members voting also recommend inclusion of the unallocated provisions presented in Parts U and V in the final budget amendment (last page of OFPR Worksheet).

As a technical correction, we would also support the amendment of language parts U and V to change reference from the "Department of Environmental <u>Services</u>" to the "Department of Environmental <u>Protection</u>."

Attached is the OFPR Worksheet indicating the Committee's vote on each initiative. Please let us know if we can provide any additional information or assistance in connection with above described budget items.

# Additional Recommendation - Funding for St. Croix International Waterway Commission

During the joint public hearing with your Committee regarding those portions of the budget proposal pertaining to the agencies under our Committee's jurisdiction, Sen. Marianne Moore urged support for inclusion of the funding proposal set forth in LD 450, An Act To Increase Funding for the St. Croix International Waterway Commission, which currently sits on the Special Appropriations Table (bill, committee amendment and fiscal note attached).

LD 450 was considered and unanimously supported by our Committee last session before its placement on the Table. We affirm our unanimous support for the substance of LD 450, as amended, and, as suggested by Sen. Moore at the joint hearing, we strongly urge your Committee to consider including that funding as part of the final supplemental budget document.

In the alternative, we would also support the removal of LD 450, as amended, from the Table so that it may be considered for enactment by the Legislature.
