(U) COVID-19 (Update 120): Worldwide (Phase 2- Concern 0051-20):

(U//FOUO) A daily update from the Department of Homeland Security regarding the impact of COVID-19.

(U//FOUO) Command and Coordination Center (CCC) Daily Coronavirus (COVID-19) Monitoring:

(U//FOUO) A daily update from Interpol Command and Coordination Center regarding the impact of COVID-19 worldwide.

(U//FOUO) Free Training: N95 Respirators: Use and Limitations and Respiratory Protection Policy Template:

(U//FOUO) During the COVID-19 Pandemic, law enforcement agencies are issuing N95 Respirators. Dirigo Safety has created a FREE online training course for all law enforcement agencies. The course covers all the OSHA recommended guidelines and provides a course completion certificate to users who successfully complete the criterion exam. An account is needed to access the training.

(U//FOUO) OTHER NOTABLE INFORMATION:

(U//LES) Scams and Fraud Campaigns Exploiting COVID-19 Likely to Continue:

(U//LES) The COVID-19 pandemic has created an environment ripe for fraudulent activity, with threat actors leveraging fears of the virus to perpetrate a variety of malicious and criminal exploitation. Observed scams and fraud have included selling fraudulent personal protective equipment (PPE), hawking fake cures and tests, spreading disinformation, phishing campaigns, and other related scams. The New York City Police Department Intelligence Bureau (IB) assesses that this activity will continue, and it will potentially pivot to leverage changing government responses to the pandemic and shifting needs for supplies. Additionally, the IB assesses that cyber-enabled crime will also evolve to prey upon the public's need to remain updated on the stream of ever-changing COVID-19-related information and may shift from COVID-19 themed outbreak to recovery lures.

(U//FOUO) Incarcerated Gang Members Granted Early Release Due to COVID-19 Likely Will Engage in Criminal Activity on Streets, Endangering Public Safety:

(U//FOUO) The Federal Bureau of Investigation assesses that incarcerated gang members granted early release due to coronavirus disease 19 (COVID-19) concerns likely will engage in criminal activity in the area of their release, endangering public safety.

(U//LES) COVID-19 Almost Certainly Impeding Transnational Criminal Organization Drug Operations, Resulting in Higher Prices and Disrupted Flow into the United States:

(U//LES) The FBI assesses the COVID-19 virus almost certainly is impeding transnational criminal organization (TCO) drug operations, resulting in higher prices and disrupted flow into the United States. As the COVID-19 virus continues to significantly impact global travel and commerce, TCOs are unable to import Chinese precursor chemicals to produce methamphetamine; this began after the first COVID-19 case in China in December 2019, and already it has affected the availability and price of Mexican-produced methamphetamine. Drug trafficking operations have been impeded by commercial restrictions, quarantines, and infected TCO members, resulting in cocaine stockpiles in Colombia.

(U) FBI Public Service Announcement: Online Extortion Scams Increasing During the COVID-19 Crisis:

(U) The Internet Crime Complaint Center (IC3) has seen an increase in reports of online extortion scams during the current "stay-at-home" orders due to the COVID-19 crisis. Because large swaths of the population are staying at home and likely using the computer more than usual, scammers may use this opportunity to find new victims and pressure them into sending money.
