Committee Amendment " " to LD 1984, An Act To Eliminate Waiting Lists for Home and Community-based Services for Adults with Intellectual Disabilities, Autism, Brain Injury and Other Related Conditions

New Title: An Act To Eliminate Waiting Lists for Support Services for Adults with Intellectual Disabilities or Autism and Reduce Waiting Lists for Home and Community Benefits for Adults with Intellectual Disabilities or Autism

Replace the emergency preamble paragraph on lines 8-10 and insert the following:

'Whereas, as of December 2019, more than 180 persons on the MaineCare Section 21 waiver wait lists were receiving no services at all; and

Whereas, providing and increasing services for all MaineCare members eligible for Section 29 ensures dignity and safety; and'

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

'Sec. 1. Department of Health and Human Services to increase Section 29 funding cap; limitations. The Department of Health and Human Services shall increase the annual cap for services provided under the MaineCare Benefits Manual, Chapters II and III, Section 29: Support Services for Adults with Intellectual Disabilities or Autistic Disorder to \$70,000 until June 30, 2024. On July 1, 2025, the annual cap for services shall revert to the annual cap of \$58,168.50 although the department may increase this cap through rulemaking.

Sec. 2. Appropriations and allocations. The following appropriations and allocations are made.

Federal Expenditures Fund allocations are also included for the FMAP match and Other Special Revenue Funds allocations are included for the Service Provider Tax.
