- 2. The Commissioner of Corrections or the commissioner's designee;
- 3. One member representing the Statewide Homeless Council;
- 4. One member representing the Maine Sheriffs' Association;
- 5. One member representing providers of emergency health services;
- 6. One member representing municipal officers; and
 - 7. Any other members with relevant expertise as determined by the director.
- Amend the resolve by striking out all of section 4 and inserting the following:

'Sec. 4. Report. Resolved: That, no later than January 1, 2022, the collaborative shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters. The report must include the collaborative's plan to provide stable housing and community services developed pursuant to section 3, including the cost savings that could be achieved by reductions in the use of high-cost services and any recommendations developed by the collaborative on providing stable housing and community services to persons consuming high-cost services. The joint standing committee of the Legislature having jurisdiction over health and human services matters may report out a bill to the Second Regular Session of the 130th Legislature related to the report.'
