Statement of Fact

Schools across the state have been unable to fully reopen and maintain the safety requirements set forth by the Maine Center for Disease Control and Prevention. Schools have developed a hybrid strategy that allows for the student body to be divided into cohorts, with one cohort attending school, and the other cohort doing remote learning. Additionally, there are many students who are learning 100% remotely as a result of COVID-19. The challenge to this strategy is that many students lack access to adequate broadband connections and cannot participate in class fully, or sometimes at all. This program will utilize the structure of the existing ConnectMaine program to provide funding to internet service providers to connect these students to a high-quality service. Funds are from the Coronavirus Relief Fund as provided through the Coronavirus Aid, Relief, and Economic Security Act.
