Be it further ordered, that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2021", for which this shall be our sufficient warrant.

Statement of Fact

This financial order provides for the transfer of \$3,500,000 in funds from the Reserve for General Fund Operating Capital to the Department of Health and Human Services, Maine Center for Disease Control and Prevention to provide funding to contract for the administration of COVID-19 response activities, including testing, contact tracing and case investigation, and support for vaccine implementation and distribution. Public Law 2019, Chapter 618, An Act To Address Funding Needs Related to COVID-19, authorized the use of up to \$11,000,000 from the Reserve for General Fund Operating Capital to address funding needs related to the novel coronavirus, known as COVID-19.
