


DVEM Organizational Chart





- Continue to support the Maine National Guard tuition waiver program
- Mitigate state code violations & increase energy efficiency. Provide funding to support facility upgrades to provide units with their authorized space.
- Endorse programs and initiatives that support families and employers of Maine National Guard Service Members.
- When appropriate, encourage young Mainers and veterans returning from active duty to consider service in the Maine Army National Guard as a way to serve community, state and nation while remaining stationed close to home.



MEARNG FACILITIES SUMMARY

- MEARNG has facilities located in over 25 communities spread out across the State from Sanford to Limestone
- Over 200 Buildings
- Over 1.5 M square feet
- 10 Training Sites, 366K Acres
- Properties are: State owned, Federal owned, Leased or License
- Federal/State cost share, depending on property ownership and facility type/use, ranges from 100% federal, 75/25% fed/state, 50/50% fed/state to 100% state



MEARNG Facility Capital Improvement Plan

- 2014 -2019
 - State share supported by \$11,000,000 bond
 - Matched with more than \$16,500,000 in Federal funds
 - Allowed us to execute over 30 projects
- 2020-2021
 - No Capital Improvement funds received.
 - Annual Sustainment funds ~ \$685.5K for maintenance and repairs
- **2022 2026**
 - No state funds have been committed for Capital Improvements
 - To sustain the MEARNG Plan we have projected the need for the following State Funds
 - **2022 = \$2,952,000**
 - **2023 = \$2,603,000**
 - **2024 = \$3,109,000**
 - **2025 = \$1,484,000**
 - **2026 = \$2,604,000**



Facilities Sustainment

Based on the DoD cost factor (IAW UFC 3-701-01 for Reserve Facilities)

- Total 75/25 supported space 790,366 SF: (0.25 x 790,366 = 197,592 State share)
- Total 50/50 supported space 636,124 SF: (0.50 x 687,120 = 318,062 State share)

Total State share space: 197,592 + 318,062 = <u>515,654 SF</u>

- The DoD Cost factor is: \$5.81/SF * 1.03 (area cost factor) = \$5.98/SF
- Total State yearly sustainment cost requirement: \$5.98/SF x 515,654 SF = \$3,083,611

Currently receive \$548,815 (\$1.33/sf) for sustainment; we require an additional \$2,534,796

What's included in sustainment?

 Sustainment provides for maintenance and repair activities necessary to keep a typical inventory of facilities in good working order over their expected service life.






Unit Missions



Enduring Issues

- Meeting the continued challenge of deployments is and will remain a challenge as the operational tempo for aerial refueling continues throughout the world.
- Balancing the deployment cycle along with maintaining home station mission requirements to include scheduled unit inspection requirements is a difficult task.
- Pilot retention concerns are due to deployment operations tempo, involuntary mobilizations, operational exercises, and additional duties; all of which affect quality of life. Competitive hiring from commercial carriers and airlines are other potential retention concerns; as they don't require any of the aforementioned factors.



*§512. Maine Veterans' Memorial Cemetery System Care Fund

1. Maine Veterans' Memorial Cemetery System Care Fund establishment; purpose. The Maine Veterans' Memorial Cemetery System Care Fund, known in this section as "the fund," is established for the purpose of ensuring ongoing care and maintenance of veterans' graves within the Maine Veterans' Memorial Cemetery System after plot interment allowances for burials within the system are no longer received from the United States Department of Veterans Affairs. The fund is established from deposits of 1/3 of the funds received from the United States Department of Veterans Affairs for plot interment allowances and from annual deposits from the Coordinated Veterans Assistance Fund established by section 514. The fund may also accept private and public donations. The fund is separate from other perpetual care or cemetery maintenance funds that support veterans' cemeteries and were established prior to the effective date of this section.

1. Legislative Updates

In FY19, the Veterans' Emergency Financial Assistance Program was founded, which has allowed us to distribute up to \$2000 grants for veterans in need.

Similarly, in FY20, the Bureau rolled out LD 184, which provides funding for the Homeless Prevention Coordination Program.

2. National Recognition

The Bureau was awarded its third straight Pillar of Excellence Award from the Veterans Administration (VA) in FY20 for the creation of an Innovative State Program. Co-founding the Maine Justice Action Committee (MJAC) with the Maine Department of Corrections (MDOC) Veterans' Pod staff, VA Incarcerated Veterans Coordinator, VA Veteran Justice Outreach Specialist, Easterseals Maine, and Preble Street. The Committee had three goals: 1.) Improve communications between agencies; 2.) Standardize intake procedures for veterans who are justice involved; and 3.) Utilize Skype technology to improve incarcerated veterans' access to MBVS' Veterans Service Officers.

The Bureau was awarded the VA's Pillars Excellence in FY19 for its Homeless Veterans Initiatives and in FY18 for its Veterans Suicide Prevention efforts.

3. Special Initiatives

The Bureau was awarded a \$10,000 grant from the Maine Health Access Foundation to conduct a sixmonth needs assessment of veterans' access to dental care in Maine and created the first-ever Oral Health Access for Maine Veterans Report.

The Southern Maine Veterans' Cemetery Expansion has concluded with over 500 new double-depth crypts and 240 green burial sites.

4. Outreach/Communication

The Bureau recently created the Fourth Edition of the Maine Veterans' Benefits and Resource Guide. The Guide is a 97-page book listing resources across the State of Maine that veterans can access.

The Bureau has increased its social media following immensely reaching an average of 15,000 people each month. Our monthly newsletter has 10,000 subscribers with an average open rate of over 30%.

Our Director of Strategic Partnerships has helped facilitate the development of new partnerships with the Maine Tribal Community and the LGBTQ Community. These partnerships have allowed the Bureau to assist previously underserved members of the veteran community.

5. Claims

In the midst of the pandemic, the Bureau successfully shifted their work to meet the needs of Maine's veterans remotely via Teams and tele-appointment. Although we have not been able to meet with veterans face-to-face, our team of VSOs have been holding telephone and Teams appointments with veterans in need of assistance.
