# LD 100 An Act To Establish the General Election Date in United States Presidential Election Years as a State Holiday LD 286 An Act to Make Election Day a State Holiday

### SUMMARY

<u>LD 101</u> designates the first Tuesday after the first Monday in November, as a state holiday in any year in which the President of the United States is elected.

LD 286 designates the first Tuesday after the first Monday in November, as a state holiday.

Both bills amend the following sections of statute:

- Title 4, Judicial Branch, legal holidays adds to list and cleans up section (n=12)
- Title 9-B Banks and Financial Institutions, adds to list of nonbusiness days (n=12)
- Title 20-A, Elementary and Secondary Education, adds to list of "Unconditional holiday" (excludes include Presidents Day)

This bill expands the list of holidays for the Judicial Branch, Schools and Banks and Financial Institutions. Business and local unit of government are not bound to provide the same holidays.
