Statement of Fact

This financial order allots a portion of the unencumbered balance forward to establish one limited-period Public Service Coordinator I position to identify, coordinate, and solve financial, contract, and system management issues. This position will lead in the development, implementation, and monitoring of financial and administrative policies and controls for Baxter State Park. The position will begin on March 29, 2021 and will end on March 28, 2023. This financial order covers the funding for fiscal year 2020-21. Failure to allot these funds will have a negative impact on the ability of the Baxter State Park Authority to effectively maintain internal controls and policies, and ensure compliance with financial standards.

Statement of Fact

This position will help maintain and improve Baxter State Park's over 225-mile foot trail system and associated footbridges. The position will begin on May 2, 2021 and will end on October 30, 2021. The position will return on May 1, 2022 and will end on October 29, 2022. This financial order covers funding for fiscal year 2020-21. Failure to allot these funds will have a negative impact on the ability of the Baxter State Park Authority to efficiently maintain the trails and ensure the safety of Park visitors.

that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2021", for which this shall be our sufficient warrant.

Statement of Fact

This financial order allots a portion of the unencumbered balance forward to increase All Other in the Maine Solid Waste Management Fund to process operational invoices for the investigation and remediation of sites, encumber contracts for the Maine Solid Waste Diversion Grant Program and administer the landfill closure and remediation cost-sharing program, in which 100% of construction demolition debris fees collected are passed through to municipalities for reimbursement of past closure costs. Investigation and remediation include sampling and analysis for per-and polyfluoroalkyl substances (PFAS). Failure to approve this order will result in the department's inability to meet statutory obligations for the program.

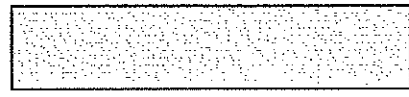

Statement of Fact
