SUBJ:	Biennial budget recommendations

On March 17, 2021, the Joint Standing Committee on Environment and Natural Resources reviewed the budget items in the Governor's proposed biennial budget pertaining to those agencies under the committee's jurisdiction. As described in this memorandum, those members present and voting at that meeting unanimously recommend acceptance of all budget items as presented in the attached OFPR worksheet with the exception of one initiative related to the Finance Authority of Maine.

Department of Administrative and Financial Services

The 10 members voting¹ recommend acceptance of the budget proposal for the Department of Administrative and Financial Services as presented in OFPR Worksheet pages 1 through 3.

Department of Environmental Protection

The 10 members voting² recommend acceptance of the Department of Environmental Protection's budget proposals as presented in OFPR Worksheet pages 4 through 17.
