Amendment:

This Change Order amends the SOW identified above. Except as expressly amended by this Change Order, the terms of the SOW shall remain in full force and effect.

Change Order Reason(s):

- Additional project management services
- Additional post-production support services
- Additional Test Cycle for Payroll Parallel Simulation
- Scope addition: Data conversion

Changes to Tasks in Scope:

• This Change Order adds new tasks and consulting activities.



- Workday support for an additional full Data Conversion build will be added to scope for a Payroll Parallel Simulation process. The conversion for Payroll Parallel Simulation will be a full prototype tenant build and will include the migration of configurations from the End-to-End tenant and loading of all new data files provided by the customer. This conversion will also include additional EIBs (Payroll History EIB and Import Payroll Input EIB)to support running payroll for 100 employees.
- An additional testing cycle will be added to scope for Payroll Parallel Simulation testing. The testing cycle will be utilized to validate payroll results for 100 employees between Workday and the customer's legacy payroll system. This Change Order assumes the testing cycle will be conducted over a two-week period and completed within that time frame. Configurations across Payroll, Benefits, HCM, Comp, Absence and Time Tracking may be adjusted to account for differences in payroll results generated for the 100 employees.
- The conversion of legacy Customer Quarterly Payroll History will be required for Payroll Parallel Testing and the Gold build to support this change order's revised quarter end Go-Live. Quarterly balances for Payroll History will need to extracted from in-scope legacy Customer data sources to load earnings and deductions to support the quarter end Go-Live.
- The division of responsibilities between Workday and Customer for the new Payroll Parallel Simulation will be the same as identified for the Payroll Parallel activities in SOW Appendix A, Section 3.4 Methodology/Test Stage (see Payroll Parallel: Testing responsibilities) Agreement #00162752.0 appropriately abbreviated for both parties and effective for the reduced scope of the 100 employee pay simulation scope.
- Notwithstanding the addition of the Payroll Parallel Simulation prototype tenant build as identified by this change order, all provisions and assumptions as specified in SOW Appendix A, Section 5.4 Data Conversion in Agreement #00162752.0 and Change Order Agreement #181977 (Removal of Job Requisitions and Candidates from data conversion) in effect for all conversion and tenant build activities. This Change Order will also make the following changes SOW Appendix A, Section 5.4 Data Conversion in Agreement #00162752.0:
 - Scope of Termination Population: the population for Terminated employees will now be for calendar year 2019 and 2020. There will be 2018 people where a payment was settled in 2019.
 - One year of Compensation Changes: this is not required for data conversion and will be removed from scope
- Workday support of Organizational Change Management and Training activities will continue at current levels for the extended timeline from February 1, 2020 to the Go-Live on March 23, 2020 with the timing of those activities adjusted as appropriate per the revised project plan for a March 23, 2020 Go-live.
- A third knowledge transfer assessment will be conducted by each Customer workstream lead. If a workstream's assessment score is still below "intermediate" level in any area from the second and third assessment, the Workday workstream lead will facilitate a review of the third assessment with the Customer workstream lead to determine next steps. The knowledge transfer sessions will continue to be conducted for each of the functional workstreams and will be conducted onsite and remote.

Changes to Project Schedule:

- This Change Order modifies the project schedule set forth in the current plan as follows:
 - End-to-End Testing will be extended from 10 weeks to 14 weeks
 - Payroll Parallel Simulation Build and Test Cycle will be added to the schedule for a total duration of 8 weeks

Production Support will be extended from 4 weeks to 7 weeks

Changes to Go Live Date:

• This Change Order shall extend the Go-Live Date of the Original SOW from January 1, 2020 to March 23, 2020.
