Statement of Fact

This financial order will increase Capital Expenditures allotment to allow the Division of Forest Protection to upgrade and modernize the Aviation Branch fleet of aircraft. Funding for this upgrade was authorized in Public Law 2021, chapter 398. The allotment was received in the All Other line category. Funds are no longer required in the All Other line category because the upgrades should be recognized as Capital Expenditures. Failure to allot these funds will result in the inability to upgrade the fleet.

Statement of Fact

This financial order transfers All Other to Capital Expenditures for the purchase of one evidence locker and 10 night vision binoculars for use by the State Police. The binoculars are necessary for low light and no-light situations where lighting conditions are not ideal, but law enforcement response is required. The evidence locker is essential to ensuring the security and safety of all evidence items that enter the custody of the State Police. The funds being transferred from All Other are no longer needed for the purpose for which they were intended, and remaining resources will meet existing operational needs.


ORDERED,
