Thank you for reading this late-in-the-game comment on apportionment for North Haven. I didn't hear about this change in our district until this morning, too late to comment yesterday by 4 pm and too late to participate in today's meeting except by Youtube. While I have seen the written description of the new apportionment for North Haven and Viinalhaven, as yet I haven't been able to access a map of this change.

I appreciate the commission delaying their vote until tomorrow on this important issue and call for you to appeal for even more time to gather comments from the affected communities before taking a final vote.

North Haven and Vinalhaven are two adjacent islands in the middle of Penobscot Bay, separated only by a half mile wide channel, the Fox Islands Thorofare. The Fox Islands are indeed solely comprised of North Haven and Vinalhaven, and for a variety of reasons should be represented, as they are now, by the same person in the Legislature. In spite of long standing sports rivalries and a certain competitiveness over fishing grounds, these two islands work together on many, many issues and increasingly so in recent years.

First and foremost as a very common, very important interest, especially right now, is the Maine State Ferry Service (MSFS). Both communities are served by the MSFS, using the same mainland terminal, sharing each other's boats when one or the other breaks down, and striving to present a unified front when dealing with Coast Guard issues, how best to transport medical samples, parking, line-up procedures, and a myriad of other complications inherent with the ferry service, including legislative issues. Unless you ride the ferries, it's hard to appreciate those complications and I am doubtful that North Haven being put in with Rockland will be a good fit, especially when it comes to understanding the ferry service...*from an islander's point of view*. The MSFS is crucial to our existence, and having our two communities represented together only makes sense when dealing with what is essentially our lifeline, day in and day out.

Dear Apportionment Commission:

I live in Sullivan. Due to my own inattention I only learned this evening about the live session today and the deadline for public comments.

So even though this comment probably arrives too late I would like go on record with an objection to your proposed redistricting of Sullivan.

I understand the logic of putting Sullivan in a House district with inland towns, rather than keep it in its current district alongside the coastal towns of Sorrento, Winter Harbor, Gouldsboro, and Steuben. I get it that most of the population of Sullivan lives on the inland side of Route 1, unlike the population of those neighboring towns, who live on the shoreland side.

But I still think you are making a mistake in separating Sullivan from its coastal neighbors.

For one thing, Sumner High School-- the high school that students from those neighboring towns now attend or will attend, and that next year will be in a brand new building that will be a jewel among educational institutions in Downeast Maine-- <u>is in Sullivan</u>. The new high school alone will draw these coastal communities into closer ties than ever before.

And there already is another building in Sullivan that draws these communities together. It's the building on Route 1 that is the office of RSU24, which as you know provides the regional school administration for schools in Gouldsboro and Steuben.

Add to this the fact that all the residents of those neighboring towns have to drive through Sullivan in order to reach Ellsworth and anywhere else down the coast and in southern Maine. Many of these residents are customers of businesses located along Route 1 in Sullivan, for example Dunbar's Store, the Dollar Store, Tracy's Seafood, Schoodic Animal Hospital, and others.

To my mind it makes no sense to isolate Sullivan from its neighboring towns, and I bet that residents of those neighboring towns would agree. Sullivan may not <u>look to you like</u> a coastal community. But Sullivan thinks of itself now and has always thought of itself as a coastal community. If you want proof, take a look at the website of <u>The Sullivan-Sorrento Historical Society</u>.

Dear Chair and Commission Members,

If you have considered and made a negotiated decision to switch Penobscot to HD 16 and Castine to HD 17 to provide better representation since yesterday's 9/23 public hearing, thank you!

If you have not made this switch, please consider the brief summary below that could help clarify any hesitancy or questions for a reasonable move to switch the two towns in the two districts **before** your review and vote on the overall House District maps at your 9/24 meeting.

1<sup>st -</sup> The communities of interest (economic, social, religious, historical, and maritime tradition) are far stronger for Penobscot to be with HD 16 Blue Hill district and Castine to be with HD 17 Orland, Verona Island, and Bucksport district as noted and documented in the written comments and testimony.

2<sup>nd</sup> - The populations of Penobscot - 1,136 and Castine - 1,320 are close in count and keep within the population variance allowed if switched, and in fact, when Penobscot is put with HD 16 and Castine with HD 17 the total populations for EACH HD improves toward the median population goal of 9,022.

3<sup>rd</sup> – Please note on any contiguity basis being used to connect the towns within either district:

A. Penobscot is contiguous by land and roads to Blue Hill, Sedgwick, Orland, and Castine

B. Castine is only contiguous by land and roads to Penobscot

1. if Castine is placed with HD 17, there is only a <u>4-mile</u> section of road that separates Castine from Orland in HD 17 along the Castine Rd.

2. if Castine is placed with HD 16, there is a <u>15-mile</u> section of road that separates, Castine from Blue Hill in HD 16

#### C. Castine is contiguous by water to BOTH HD 16 and HD 17

While Castine is somewhat closer by water at the closest land points in HD 16 (Castine to Brooksville), <u>Castine is also contiguous by water to Orland</u>, the closest land point by just under 4 miles in HD 17.

4<sup>th</sup>- The switch of Penobscot to HD 16 and Castine to HD 17 appears to meet all constitutional requirements, agreements, and desired goals of better representation, AND **the switch will not affect any other towns or districts in the overall proposed House District maps**.

Based on all the factors above, it appears prudent and reasonably possible, to make a move at your Friday, 9/24, 11am, Apportionment Commission meeting to switch these two towns, if you have not already done so, <u>before</u> voting on the overall House District proposed maps. Thank you again for all of the hard work and consideration you have undertaken in this short timeframe to create these maps. My name is Will Hayward, and I am a resident of Portland. I am submitting this final comment today on my own behalf. I am submitting this comment shortly before the deadline for public comment, to ensure that two potential areas of concern are in the public record before maps are finalized:

- District 44, containing correctional facilities located in Warren, contains slightly less than the median House district population. This does not align with the practice recommended by the League of Women Voters of Maine and others of drawing districts with correctional facilities in them above the median district population, which would reduce the impact of prison malapportionment.

- In testimony submitted by Saige Purser on 9/13, she included a community of interest map for the Houlton Band of Maliseets. It appears the community as defined in that submission is split between House District 6 and House District 7.

I am not sure if there is sufficient time to investigate these issues, but I wish to have them noted in the public record. Thank you for your consideration.

To the Members of the Apportionment Commission: Please excuse my late, by a few minutes, submission. I just became aware of some of the comments submitted in today's thread.

My note here is in response to the comments submitted to the Commission yesterday by my colleague and friend, Rep. Grohoski, as well as Trenton Selectboard Member, Rachel Nobel. I understand their argument that Trenton should be part of the proposed District 14, in place of Lamoine. While I appreciate that Trenton does have an educational connection with MDI High School, so does Southwest Harbor and Tremont, and they are not being placed in District 14 either. They are placed (and have been since the last redistricting in 2013) in a District with Deer Isle and Stoninginton, also geographically distant. Lamoine has an even greater connection with Bar Harbor than does Trenton, in that it shares a coastline with Bar Harbor on Frenchman Bay, along with a very large aquaculture community. Just as Mr. Graham Platner argued earlier in this series of comments, this community depends heavily on its relationships with other aquaculturists. While there is aquaculture in Trenton, it is centered more on the Goose Cove area and Union Bay. And Blue Hill is on the other side of that Bay.

These comments are not based on political considerations but rather on keeping communities of interest together. As the two Towns on the westside of Frenchman bay, Lamoine and Bar Harbor should be kept together, just as the Towns on the eastside of the Bay should be kept together.

Dear Commission:

Thank you for your hard work on redistricting the state of Maine.

I understand the many factors you have had to consider in remaking 151 House districts.

If there are any changes to be made, I would ask that you consider two points.

1. The residents of newly created District 16 might be better served by continuing to include Brooklin, rather than Trenton. As a selectman from Brooklin pointed out, most children in Brooklin attend high school in Blue Hill (very few, if any, from Trenton do). Brooklin is already allied with other towns in the newly created District 16 with their broadband coalition and other community efforts. Geography would suggest that Brooklin is a more appropriate choice for District 16 than Trenton. Trenton residents do not shop, bank, use the library, or visit the hospital in Blue Hill.

2. The residents of newly created District 16 might be better served by including Penobscot, rather than Castine. Penobscot shares a significant border with Blue Hill. Many of the children there go to schools in Blue Hill and many shop, bank, use the library, and visit the hospital in Blue Hill. As one Penobscot resident and historian noted, Penobscot and Blue Hill share a common history peopled with the same families for the past 260 years. Castine broke off from Penobscot in 1796 and has aligned itself with other Penobscot Bay towns, primarily Bucksport, over those centuries.
