The Land for Maine's Future (LMF) program administers funds generated from the sale of bonds and other funds to acquire lands for public water access, conservation and recreation, farmland protection, and working waterfront access protection. LMF was recently allocated \$40 million through Public Law 2021, chapter 398 to fulfill its mission and requires the support of a grant management software package to efficiently discharge its duties to the citizens of Maine in accordance with its statutory directives. The LMF Board voted on September 24, 2021 to authorize the use of up to \$90,000 from funds donated to the program for the purpose of procuring a grant management system. Failure to allot these funds will have a detrimental impact on the ability to meet the goals, objectives and requirements of the Land for Maine's Future program.
