**1.** Municipal authority. A municipality may enact an ordinance imposing a fee on vacant residential property.

2. Definitions. As used in this section, unless the context otherwise indicates, the following terms have the following meanings.

<u>A. "Permanent resident" has the same meaning as in Title 36, section 681, subsection 4.</u>

B. "Residential property" means a structure or portion of a structure that is designed for year-round habitation.

C. "Vacant residential property" means residential property that is not occupied by a permanent resident.

3. Use of fee revenue. The fees collected by a municipality pursuant to this section must be used to increase the availability or improve the affordability of residential property within the municipality.'
