9 COMMITTEE AMENDMENT “ ” to H.P. 1512, L.D. 2030, “An Act Regarding
10 Taxation of Energy Storage Facilities and Equipment”

11 Amend the bill by striking out the title and substituting the following:

12 **'Resolve, Directing the Governor's Energy Office To Report Regarding the Role of**
13 **Tax Incentives in Increasing Energy Storage Capacity'**

14 Amend the bill by striking out everything after the title and inserting the following:

15 **'Sec. 1. Governor's Energy Office; energy storage tax incentive report.**
16 **Resolved:** That the Governor's Energy Office shall examine the role of existing and
17 potential tax incentives in achieving the objectives established in the Maine Revised
18 Statutes, Title 35-A, section 3145 and shall provide a report on these matters to the joint
19 standing committee of the Legislature having jurisdiction over energy, utilities and
20 technology matters by March 15, 2023. The report must include a review of tax incentives
21 for energy storage available from the Federal Government and in other states and must
22 include input from interested stakeholders. The report must also be provided to the joint
23 standing committee of the Legislature having jurisdiction over taxation matters if
24 recommendations regarding taxation policy are included. The joint standing committee of
25 the Legislature having jurisdiction over energy, utilities and technology matters is
26 authorized to report out legislation related to the report to the First Regular Session of the
27 131st Legislature. Upon written request, the Public Utilities Commission and the
28 Department of Administrative and Financial Services, Maine Revenue Services shall
29 provide to the office information and assistance requested related to the report.'

30 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section
31 number to read consecutively.

32 SUMMARY

33 This amendment strikes the provisions of the bill and substitutes a resolve directing the
34 Governor's Energy Office to review the role of tax incentives in encouraging growth in
35 energy storage capacity in the State and report the results of its review to the joint standing
