Senator Sanborn, Representative Tepler and honorable members of the Committee on Health Coverage, Insurance, and Financial Services:

Given the recent events regarding Anthem Blue Cross Blue Shield and Maine Health, I am deeply concerned for the people of Maine who rely on both for their health care needs. My main concern is for the people that have doctors within the Maine Health network that encompasses almost all of southern Maine. Here in Bath, we are serviced by Mid-Coast Hospital that is now part of the Maine Health network. Many of these folks could end up having to choose between an insurance they have had for many years or a provider whom they like and trust unless the current dispute between Anthem and Maine Health is resolved before the end of the year. Maine has long grappled with both access to care and the cost of that care. Losing the largest insurer in the state's largest provider network will only exacerbate the problem.

As a former legislator and someone who spent their entire adult life in public service, I understand that resolving these types of disputes is both difficult and not a direct responsibility of the legislature. However, for the 24 years I served, access to health insurance and health care were always priorities of the legislature and it is in the best interest of the people of Maine and the providers to get both sides talking again and find a way to resolve this dispute.

I volunteer with a woman who has had several recent surgeries. She is distraught that she may not be allowed access to Maine Health hospitals and services because her husband's business uses Anthem. In addition, she told me her most recent bill for surgery had a charge for an overnight stay even though it was day surgery and there were several other charges for services she did not receive. If this is true, I can understand why there is a reluctance for Anthem to pay Maine Health. But I realize this is anecdotal which is why it is important for an independent mediator to get involved and figure out where the problems are and how best to correct them. I would suggest an out-of-state expert or someone with knowledge of the Maine system but independent from Maine government. Whatever the outcome, it needs to be beyond reproach by either side.

I hope you will work to ensure both sides are engaged and working to resolve this issue.
