#### Statement of Fact

This financial order transfers All Other to Capital Expenditures in the Water Quality Control Programs General Fund account and increases Capital Expenditures in the Performance Partnership Grant federal account to purchase a new boat and trailer for the Aquatic Toxicology Unit within the Bureau of Water Quality. The unit collects fish and shellfish for the Surface Water Ambient Toxics Monitoring Program (SWAT) and the samples are analyzed for toxic pollutants, such as per- and polyfluoroalkyl substances (PFAS), polychlorinated biphenyls (PCBs) and mercury. The unit's current boat and trailer are aging and are no longer reliable for use. Funds are no longer needed for which they were originally intended in the All Other line category. The department will have sufficient funding in the All Other line category for the remainder of the year. Federal funds are available through an existing grant award through the Environmental Protection Agency. Failure to approve this financial order will prevent the department from collecting samples for analysis to detect possible toxic pollutants in Maine's surface waters and fisheries, which threaten both human and environmental health.

These vessels are strategically placed along the coast of Maine for quick response time which is critical for public safety, resource protection, and security of maritime law enforcement. All Other funds are no longer needed for the purpose in which they were originally intended in the maintenance line category. These boats are needed due to safety issues in the Bureau of Marine Patrol's aging fleet; the boats to be replaced are over 25 years old, unsafe, and beyond repair. The Department will have sufficient funding in the All Other line category for the remainder of this fiscal year.

#### Statement of Fact

This financial order allots a portion of the anticipated unencumbered balance forward to purchase of a 42' Calvin Beal lobster style patrol boat for the Bureau of Marine Patrol (BMP). Funding for this enforcement boat is granted by the Department of Commerce, National Oceanic and Atmospheric Administration, National Marine Fisheries Service, Office of Law Enforcement to be implemented in the Joint Enforcement Agreement for the 2020 award. BMP maintains a fleet of large 35 to 46 foot fiberglass lobster-style patrol vessels used for marine fisheries and boating safety enforcement and for search and rescue. The Maine lobster boat design provides an effective and safe platform for officers to conduct patrol work, including hauling and inspecting lobster fishing gear, along Maine's coastline. Failure to allot these funds will have a detrimental impact to the Bureau of Marine Patrol's enforcement and public safety efforts.

This is the primary boat for the Growing Area West Program and is essential to safely perform federally mandated compliance work including shoreline survey and water quality sampling required by the National Shellfish Sanitation Program and enforced by the US Food and Drug Administration. Financial Order 001926 F2 made funds available for this purchase in fiscal year 2021-22, but supply chain issues prevented the Department from making the purchase. All Other funds are no longer needed for the purpose for which they were originally intended due to the determination that this purchase needs to be a Capital Expenditure.
