That the State Controller transfer \$255,876 from the All Other line category in account 010-18B-0155-02, Information Services, and \$2,764,363 from the All Other line category in account 010-18F-0112-01, Statewide Radio and Network System, to the All Other line category in account 010-18F-Z234-01, Central Administrative Applications; and,  
Be it further ordered,  
that the State Controller increase the allotment in account 010-18F-Z234-01 by \$3,020,239 in the All Other line category, and decrease the allotment in the All Other line category in account 010-18B-0155-02 by \$255,876 and in account 010-18F-0112-01 by \$2,764,363 for the purpose of funding technology application improvements; and,  
Be it further ordered,  
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2022", for which this shall be our sufficient warrant.

**Statement of Fact**

This financial order transfers All Other debt service funds to the Central Administrative Applications account to fund technology application improvements that are essential to maintain day to day operations. Funds are no longer required in the All Other line category for the purpose they were originally intended because debt service is less than budgeted. Failure to approve this financial order will result in the inability to fund technology application improvements and put the State's infrastructure and information at risk.

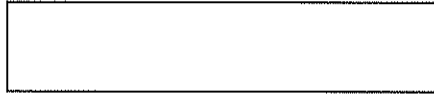
