- Public Water System Supervision Program
- State Revolving Fund for Infrastructure Improvements
- Subsurface Wastewater Septic Systems
- Miscellaneous: Swimming Pools, Cemeteries, Crematoria, Cannabis Testing Facility Certification, Technical Assistance to Private Well Owners, etc.

## **Public Water System Supervision**

Supported by Federal PWSS Grant, Alternative Funding Mechanism Fees & State Revolving Fund Set-Asides

- Public Water System Inspection
- Data Management Inventory & Monitoring
- Technical Assistance
- Compliance & Enforcement
- Engineering Approvals
- Source Water Protection Activities
- Laboratory Accreditation

# **Relevant Regulations**

- Federal Statute:
  - Safe Drinking Water Act (40 CFR 141-143)
- State Statute:
  - Water for Human Consumption Act (Title 22, Chapter 601)
- State Rules:
  - Rules Related to Drinking Water (10-144 CMR Chapter 231)
  - Rules Relating to Bulk Water (10-144 CMR Chapter 235)

## Maine Public Drinking Water Systems

## 1,862 Public Water Systems

- 384 Community Water Systems (60% of Maine residents)
- 374 Non-Transient, Noncommunity Systems (Schools, Childcares, Offices)
- 1,105 Transient Noncommunity Systems (Restaurants, Campgrounds, Hotels)
- 21 Water Bottlers
- 26 Water Vending Systems

40% of Maine Citizens on Private Wells (not regulated by DWP)

Can assist residential well owners with:

- Best practices and construction standards
- Sampling and Water Quality Review
- Treatment/Disinfection
- And more!

## Protection and Regulation of Drinking Water Sources

#### Source Protection more effective & less costly than remediation or new source

### Program Activities:

- Technical assistance to PWS source water protection from contaminants
- Physical security grants available
- Hydrogeological Report Review
- New Well Approvals location, construction, sustainable yield, wellhead protection
- Municipal Comprehensive Plan Reviews to ensure source protection
- Emergency response spills impacting source water
- Annual Filtration Avoidance Waiver Evaluations
- Education/Outreach/Stakeholder Involvement

## **Extraction of Drinking Water**

- Few issues with water quantity at Maine PWSs compared to other parts of the country – isolated or short-lived
- Drinking Water Regulations address groundwater quantity issues by requiring that sufficient volume must be produced to maintain adequate pressure throughout the distribution system.
- "Significant Groundwater Well" does not apply to Public Water System wells, except for those solely bottling water for sale.

## **Bottled Water Systems**

- DEP Permit required if volume exceeds significant quantity designation
- Drinking Water Program Approves/Oversees:
  - Source
  - Treatment
  - Water Quality Requirements
    - Similar monitoring and limits to a Community Water System
  - Inspections every three years
- Oversight of bottling operation performed by DACF (MOU)

Transport of water for commercial purposes by conduit, tanker, or container >10 gallons is prohibited, except for: (Title 22, Chapter 601, §2660-A)

- Water produced by a utility
- Water hauled pursuant to a Bulk Water Permit
- Water withdrawn pursuant to a DEP or LUPC permit
- Other miscellaneous exemptions

No bulk transport permit required if well exceeds significant quantity designation, since DEP permit in place.

Drinking Water Program administers:

- Minor Bulk Water Transport Permit (currently two)
  - Renewal every three years
  - Annual pumpage reports
- Emergency Bulk Water Transport Permit
