that the State Controller increase the allotment in account 010-09A-0538-01, Search and Rescue, by \$11,000 in the Capital Expenditures line category, and decrease the allotment in account 010-09A-0538-01, Search and Rescue, by \$11,000 in the All Other line category for the purpose of funding the purchase of a portion of one aircraft engine; and,

that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2023", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers All Other to Capital Expenditures within the Department of Inland Fisheries and Wildlife Search and Rescue account to be used to fund a portion of the purchase of one aircraft engine for the Maine Warden Service. This engine will replace an existing engine that is reaching the end of its useful life. These funds are no longer required in All Other for the purpose for which they were originally intended this fiscal year due to a reduction in supply purchases.

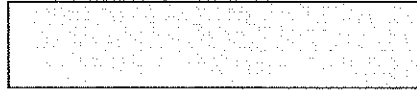

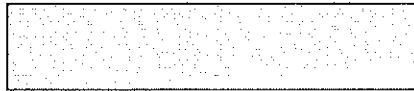

that the State Controller increase allotment in the Capital Expenditures line category and decrease allotment in the All Other line category by \$35,685 in account 010-16A-0291-01, State Police; and increase allotment in the Capital Expenditures line category and decrease allotment in the All Other line category by \$19,215 in account 012-16A-0291-01, State Police, for the purpose of purchasing equipment; and,

that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2023", for which this shall be our sufficient warrant.

Statement of Fact

This financial order transfers allotment from All Other to Capital Expenditures for the purchase of six vision binoculars. The State Police will use the binoculars for low light and no-light situations where lighting conditions are not ideal, but law enforcement response is required. Funds are no longer required in the All Other line category for the purpose for which they were originally intended, and remaining resources will meet existing operational needs.

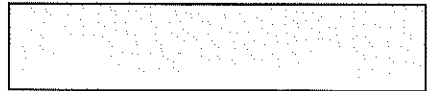
