Representative **CRAFTS**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. It's quite an honor to be able to recognize a local citizen and constituent who has done amazing things.

On March 28th, Hannah was driving humbly to work and noticed a partially submerged car in Davis Stream. While most of us might call 9-1-1 or yell for help, she stripped down and jumped into the freezing water to rescue the 60-year-old driver, Mr. Richard Pauley, thus saving his life. She swam back and forth to the car multiple times trying to open the door and windows, finally smashing the back windshield with a tool provided by a local bystander. Local law enforcement credit Ms. Meneses with the saving of Mr. Pauley's life, and so, for her heroic bravery and demonstrating the ability of, really, everyday citizens to do extraordinary things in our State, I'd like to congratulate and thank Ms. Meneses.

The **SPEAKER**: The Chair recognizes the Representative from Jefferson, Representative Farrin.

Representative **FARRIN**: Yes, I also want to commend Hannah Meneses on her heroic day to save a man's life. After taking an exercise class with her at the YMCA, I know of her relentless energy. I am so glad she was there in Jefferson to save the man. I am also happy that she's allowed me to strategically place two of my campaign signs on her Whitefield home. Also, I commend her by taking her son Remy to the polls to vote, where I met her, she explained to him about what I was running for. She is a remarkable woman. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Caratunk, Representative Caruso, who wishes to address the House on the record.

Representative **CARUSO**: Thank you, Mr. Speaker, and Members of the House. I rise to honor Donald Beane of Moscow, who just retired from; wait for it; 46 years as the First Selectman of the Town of Moscow.

He graduated from Bingham High School, University of Maine Farmington with a Bachelor's in education and from the University of Maine with a Master's in education. He taught at Fairfield schools. He returned to live in Moscow and taught at Caratunk's one-room schoolhouse. He then completed a teaching career of 39 years with teaching in the Moscow and Bingham schools. He was married to the late Camille Ouellette, also a teacher, and they lived in Moscow with their two children, Rebecca Ambrose and Glen Beane.

Just a side note, Donald's father was William S. Beane. He was a State Representative in the 100th and 101st, and he is credited with a 'William Beane Bill' which allowed for the State of Maine to have a picture on the driver's license. So, the story goes that Donald's parents ran Beane's General Store and, unbeknownst to them, some teens came in to purchase beer with falsified identification. After quite an interrogation by law enforcement, not only did Billy Beane keep his liquor license, but he later sponsored legislation to require a photo ID on the Maine driver's license.

Back to Mr. Beane; in 1979, he ran for Moscow's First Selectman as a write-in candidate and followed unopposed for the next 45 years. He serves on the Board of Directors for the Upper Kennebec Valley Ambulance Service. He's active at the Catholic church in Bingham, he sings to this day in the choir, he serves at St. Peter's thrift store and the food pantry. He loves to travel, loves to cook and entertain, and his sister says he can put on a dinner party with the best of them. And he was just elected last month as the Second Selectman to help mentor the new First Selectman.

Over the last 20 years, I, as Caratunk's First Selectman, have had the honor and privilege of serving with Donald Beane in regional efforts, with our two abutting towns coinciding, including where the former US Air Force radar station is located in both Caratunk and Moscow. I can affirm that Donald has always carried sound wisdom, kindness, a calm demeanor and a rational approach that considers all aspects on behalf of his town and his residents. And so, it's an honor here to recognize him and to honor a great civil servant, a respected rural municipal leader, a loyal American and Maine citizen. Thank you.

At that time, the decision was made for us as a county, as a delegation, to put forward a bill and work with any other bills that may come forward. We know that the other bill was passed and what we're asking is that this can also be placed on the Table for consideration if there are not funds to fill the other bill. So, I would encourage you and ask you to support the motion. Thank you.

Representative **LYMAN**: Mr. Speaker and Members of the Chamber, I stand today to express my opposition to this motion.

While some of the provisions may seem straightforward, I have concerns about the potential impacts of this legislation. Specifically, I'm concerned about the potential implications of updating Statutes regarding private schools' receipt of public funds for tuition purposes to reflect the *Carson v. Makin* decision. While I understand the need to align with court decisions, I believe it is crucial to ensure that the use of public funds continues to primarily support our public education system; which serves all students, regardless of background. Any expansion of public funding to private institutions should be carefully considered and include robust accountability measures to ensure taxpayer money is being used effectively and equitably.

Furthermore, while streamlining processes like community school district reorganization may seem efficient, I worry about the potential for reduced public input and transparency if this change can occur without a Private and Special Law. Local control and community engagement are vital to ensuring our schools meet the needs of our students and families. While other provisions in the bill, such as updating the definition of 'homeless student' and clarifying audit procedures, may be beneficial, I urge legislators to carefully consider the potential unintended consequences of changes related to private school funding and community school district reorganization.

Finally, there is not a Fiscal Note attached to this bill, making it fiscally irresponsible to pass legislation without

knowing the commitment to our taxpayers. Mr. Speaker, thank you for considering my position.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Livermore Falls, Representative Lyman.

Representative **LYMAN**: Mr. Speaker, Members of the House, I stand in opposition to this motion.

I believe that no child should be denied access to a public education based on their family's sincerely held religious beliefs. The current situation in Maine forces families to choose between their faith and their child's education; a choice no family should have to make.

We heard compelling testimony from Aaron Siri, the lawyer who successfully argued for the reinstatement of religious exemptions in Missouri. During his testimony, Mr. Siri stated that, in his professional opinion, Maine is currently violating the Maine Human Rights Act, as well as the First and Fourteenth Amendments of the United States Constitution, by not allowing for religious exemptions for school attendance. Furthermore, there is already a case, *Fox v. Makin*, in federal court in Portland, Maine, addressing this very issue. Considering this ongoing legal challenge and the potential constitutional concerns raised by legal experts, it seems only prudent for us to proactively address this by supporting the reinstatement of religious exemptions.

Moreover, recently, this House voted in favor of the ERA Amendment, which also promises to protect religious freedom. This demonstrates a legislative commitment to upholding fundamental rights, including the right to practice one's religion without undue burden.

Given the legal challenges, the constitutional concerns raised by experts and the recent legislative action affirming religious freedom, wouldn't it be prudent for us to support this

bill and reinstate religious exemptions, ensuring that all Maine families can access public education without compromising their deeply held religious beliefs? Thank you, Mr. Speaker, for your time and consideration.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Zager.

Representative **ZAGER**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I respectfully disagree with the balance of various rights that the Good Representatives from Livermore Falls and Milford have advanced with this bill.

The problem that this bill, LD 174, is attempting to address is that kids; and adults; get sick and they miss school and work when they get communicable diseases, infectious diseases that are vaccine preventable. Just a real brief bit of historical context. More than a couple hundred years ago and going back into, you know, going further back, before we apply the scientific method in the Age of Enlightenment, children died at a rate of about 46%. That's an average of about two dozen studies looking back over the centuries. Then, something tremendously valuable happened. It was a series of innovations, vaccines being a key one of them. Over the last couple hundred years, that rate of about one in two children dying before they reach the age of majority dropped, so that in the United States, it's about; it's less than one percent, about 0.7%. That's still too high; I'd like to get to where some of the Nordic countries are at 0.3%, or even zero percent. But vaccines are a cornerstone of what has saved children's lives in incredible numbers over the decades and even the last couple centuries. And this was a point that Dr. Joe Anderson and the American Academy of Pediatrics, Maine Chapter emphasized in his testimony. He called vaccines a cornerstone of that effort to save lives and make lives better. Inadequate vaccine rates put kids at risk. That is another key point.

So, question seems to perennially come up, and I understand why it keeps coming up, because there's various interests at stake and we have to weigh those. The cases in Texas and probably about 19 or 20 other states of measles in inadequately vaccinated communities emphasizes how contagious measles is. A simple cough can spread this virus and that can cause tremendous illness and even death, as we have seen just in the last few months. So, the mechanism in the 129th, in 2019, was to only allow medical exemptions. And Mr. Speaker, medical exemptions are perfectly valid reasons and not especially difficult to obtain. Did it work? The answer is yes. Again, the pediatricians in our State, in their testimony; and folks can look up the graph if they're interested; shows that in every state save four; every state in this country, compared to the pre-pandemic years; every state has decreased its kindergarten vaccination rates, has seen a decrease in the vaccination rates. Why is this significant? Well, on the graph, you see that the 95% vaccination rate; which is the key threshold for measles; most of the states have fallen short of that. And so, it shouldn't be a surprise; it shouldn't be a, you know, grim realization that we are seeing outbreaks of measles. So, the four that had increased include Kansas, Alabama, Connecticut and Maine. And Maine is the only one, the only state that has gone from the at-risk below 95% to now, because of the law that we had passed in the 129th, is now well above the 95%; is at 97% and change. So, a tremendous success in terms of a piece of legislation achieving something that is demonstrably needed for the health and wellness of our children and other community members. In fact, the Maine Council of Churches has pointed out that no major religion says that vaccines are not good. In fact, they encourage vaccinations; that the Maine Council of Churches pointed out; and that some even call it a moral obligation. And I

recognize, Mr. Speaker, that not everyone's going to agree with the Maine Council of Churches, but I think it's worth mentioning.

Is this constitutional? That's another very important question, because sometimes, things that have utility and are good for people might be unconstitutional. And I would hope that everyone in this Chamber would agree that the Constitution is the thing that we took an oath to support and defend, all parts of it. So, it's a pertinent question, and it's something that I think that the sponsor rightly brought up in this debate. The truth is, Mr. Speaker, is that vaccine mandates have stood the constitutional test of time. In 1907, the *Jacobson* case was the first time when the U.S. Supreme Court undeniably said vaccine mandates have a place in American law, they are not unconstitutional. This was affirmed a couple generations later, in the *Prince* decision in 1944, and every single time that a case; and there have been other challenges that could have gone to the Supreme Court; the Supreme Court has said this is not something that we feel we need to rule on, except for a very few examples. For instance, the Chief Executive's requirement that health care workers during the pandemic be vaccinated. This did go to the Supreme Court, because the Supreme Court certainly recognized the urgency and the exigency of a pandemic and thought it was worth weighing in, and they weighed in affirming the validity; the constitutional validity; of a vaccine mandate for health care workers.

Now, we all have our own internal metrics, our own compass of whether something is constitutional or not, and certainly, courts do, that's what they exist for, and certainly the Supreme Court is the chief of those. So, it is possible that the Supreme Court could change its mind, but it hasn't in more than a century, and it has ample opportunity to do so. So, I think that by my own weighing; which is affirmed by decades of consistent court affirmations; this is constitutional. And Mr. Speaker, the current law addresses a real problem affecting the health of children and others. The mechanism works; it's been affirmed constitutional. I would ask you and everyone in the Chamber to please vote to support the pending motion of Ought Not to Pass on LD 174, and I just want to leave you with a couple of paragraphs, because the discussion about vaccines is a difficult one, because it weighs things that we see against things that we don't see.

Now, prevented illness is hard to talk about, because you don't know who is alive today because of the vaccines. We know that from studies, that millions of people are, but we don't know which ones, and so, they can't come to testify on how grateful they are about the vaccine. So, we need to rely on other ways. So, this is a voice from pre-vaccine era, and this is from a rural hospital. "The paramedic solemnly flung open the door and the mother came in, or rather, she seemed to fly in, slithering on her ice-covered felt boots, unmelted snow still on her shawl. In her arms she carried a bundle, from which came a steady hissing, whistling sound. The mother's face was contorted with noiseless weeping. When she had thrown off her coat and shawl and unwrapped the bundle, I saw a little girl of about three years old." This is a physician in a hospital writing. "For a while the sight of her made me forget operative surgery, my loneliness, the load of useless knowledge acquired at university: it was all completely effaced by the beauty of this baby girl. They used to draw angels like that. But in the depths of her eyes was a strange cloudiness and I recognized it as terror; the child could not breathe. 'She'll be dead in an hour,' I thought, with absolute certainty, feeling a sharp twinge of pity for the child. Her throat was contracting into hollows with each breath, her veins were swollen and her face was turning from pink to a pale lilac. I immediately realized what this coloring

meant. 'The little girl has diphtherial croup. Her throat is already choked with membrane and soon it will be blocked completely.'" Mr. Speaker, diphtherial croup is a vaccine-preventable illness. I ask that we vote to ensure that as few people as possible suffer like this girl did in the pre-vaccine era. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Milford, Representative Drinkwater.

Representative **DRINKWATER**: Thank you, Mr. Speaker. Mr. Speaker, my great-grandparents in the 1860s lost three toddlers in two years, and I'm sure it's because of a lack of a vaccination. But I'm not here to talk about vaccinations, Mr. Speaker. I'm here to talk about what we've already enshrined in law. And for the previous speaker, I would encourage him to read the case in Mississippi that had a similar case, a similar law in Mississippi as we have in Maine and the Supreme Court ruled that Mississippi has to have a religious exemption.

Mr. Speaker, at this pivotal moment, we have the opportunity to restore a fundamental right, one guaranteed by the U.S. Constitution, enshrined and protected under the Maine Human Rights Act, by ending the exclusion of children from public education based on their religious beliefs. The Maine Department of Education sent out a priority notice to all schools, immunization requirements for schools, and I want to quote from that memo: "Considerations for special populations under federal law; children, regardless of their citizenship or residency status, are entitled to a public education. School Administrative Units may not prohibit nor discourage children from enrolling in schools because they or their parents are undocumented immigrants." And that was quoting the *Plyler v. Doe* Supreme Court decision, which states; Supreme Court decision states; oh, that's the Supreme Court of the United States; states may not deny access to a basic public education to any child residing in the state, whether present in the United States legally or otherwise. That is the law.

On August 16th of 2023, Portland, Maine, the federal case, *Fox v. Makin*, marked an important development. The Court denied the State's request for summary judgment for the following reasons. Remember, a federal judge denied the State's motion. The Court found there is a plausible claim for violation of the Free Exercise Clause, and this is a quote from that decision: "A law is not neutral 'if it singles out religion or religious practices' and is 'not generally applicable if it treats any comparable secular activity more favorably than religious exercise,' or it 'prohibits religious conduct while permitting secular conduct that undermines the government's asserted interest in a similar way.'" It's Section 3355, that is the law that is being challenged, a 90-day grace period is an additional example. "The Commissioner;" that would be Commissioner Makin; "conceded that although a new student would be given 90 days to obtain vaccination before being excluded from school, 'a religious family that moved into town and needed 90 days to find alternative schooling for that child;" now listen to this, Mr. Speaker, this is the Commissioner; "would not be afforded the same 90-day grace period." The Commissioner conceded that new students on day one do not present any different risk in that classroom compared to unvaccinated students who claim religious exemptions. Again, that's the judge's ruling on this case. "Maine continues to permit multiple nonreligious exemptions;" again, this is the Judge's words; "including a 90-day grace period for non-religious students, a medical exemption and the IEP sunset provision, all of which arguably undermine its students' health and safety interest while restricting religious exemptions that may pose compatible risks." Section 3355 does not require teachers who share the same classroom and other school facilities as students to be

vaccinated at all. "For these reasons, the Court declines to dismiss plaintiff's free exercise claim for failure to state a claim."

Count II of the amended complaint states a plausible claim for a violation of the Equal Protection Clause. The "Plaintiffs allege that defendants have violated their right to the free exercise of religion, which is a fundamental right. 'Unquestionably, the free exercise of religion is a fundamental institutional right.' Accordingly, the Court must apply strict scrutiny." And as the previous speaker has mentioned about the case, *Jacobson*, back in, I think it was 1903, the Court did not use strict scrutiny at that time. "For the reasons delineated above with respect to Plaintiffs' free exercise claim, the Court finds it plausible that Section 3355 does not survive strict scrutiny and therefore declines to dismiss" the Equal Protection Clause. "Accordingly, this case shall proceed against the Commissioner Porter, and Munsey, for injunctive and declaratory relief in their official capacities as to both Counts I and II." Mr. Speaker, the Court has ruled that the case may proceed. The State's position is untenable.

Mr. Speaker, on February 21, '25, the Chief Executive of our State, Chief Executive Mills, responded to President Trump's inquiry regarding Maine's compliance with Title IX by stating, and I quote, 'we're going to follow the law.' I wholeheartedly agree. I'm sure this Body agrees. We must uphold the law and ensure the restoration of religious exemption as guaranteed by both the U.S. Constitution and Maine's Human Rights Act. And I want to quote from that Human Rights Act: "Right to freedom from discrimination in education. The opportunity for an individual at an educational institution to participate in all educational, counseling and vocational guidance programs without discrimination, because religion is recognized and declared to be a civil right." Our own laws declare it to be a civil right, but we're denying children an education if they're not completely vaccinated. If they're a religious family and asking for that 90-day exemption, the Commissioner is on record saying we won't give it to them. That just defiles all logic. Title 5, Chapter 337, "Unlawful educational discrimination. It is unlawful educational discrimination and violation of this Act on the basis of religion to: Exclude a person from participation in, deny a person the benefits of, or subject a person to, discrimination in any academic, extracurricular, research, occupational training or other program or activity." Also, this Body in the 126th and 127th passed An Act to Protect Religious Freedom and An Act to Preserve Religious Freedom, two separate sessions, both passed similar laws.

But let me be clear; there are lines that we will not cross when it comes to civil rights, fundamental freedoms and the basic dignity of every person in this State. We will stand firm. These are not matters of partisan debate; they are the foundation of who we are as a people and as a nation. Protecting these principles is our moral obligation and is what ensures a place where everyone can live with fairness, respect and opportunity of these values. There is no complacency, "because remember, every decision here affects the lives of real people." Mr. Speaker, these are your words from December 4th of 2024. I ask you now; are they your true convictions or merely words read from a script? Mr. Speaker, show us the strength of your convictions. Stand firm in defending what is right, even when it's difficult. The time for empty words have passed. We need to get these 7,000 kids, approximately, that have been removed from Maine schools the opportunity; if they so desire; to return to public education. It is now time for action that reflects the values we were elected to uphold. The Court has agreed with you that there are lines we will not cross when it comes to civil rights, fundamental freedoms such as religious freedom.

This Body has a choice. We can do the right thing and restore the rights to a religious exemption, or we can take the easy way out and leave it to the courts to decide. But we were not elected to take the easy way out. Sometimes, we must make difficult decisions.

In this case, the courts have already ruled that a religious exemption is a constitutional right. When one person's constitutional rights are taken away, it is an attack on the rights of all of us. We cannot allow the erosion of these fundamental freedoms for any individual, as it threatens the rights of all of us. And in conclusion, Mr. Speaker, the State's professional witness on herd immunity was put under oath, and in the deposition, the good doctor agreed that her methodology did not recognize natural immunity when she came up with her herd immunity numbers. Again, she did not recognize natural immunity; she spoke that under oath in a deposition. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Cimino.

Representative **CIMINO**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. When the First Amendment was passed in the 1700s, the first freedom was that of the freedom of religion. Obviously, this was a tantamount concern for our Founding Fathers. Right now, in Maine, Maine is only one of six states without religious exemptions from school vaccines. Our failure to have a religious exemption is discrimination against our children by failing to provide equal protection to our children. It's requiring that people who live in Maine actually have to move out of state if they want to be able to have a religious exemption. So, their children are being deprived from living in the State of Maine. Some are going to New Hampshire, where they can practice religious freedom and not have to be vaccinated. This is clearly discrimination against our children. These are Maine children, and they deserve the right to be able to stay in their communities, be educated and not be discriminated against because their parents cannot make that decision and have them exempted for religious reasons from vaccines.

So, please oppose this motion and please restore religious exemptions in the State of Maine and restore parental rights to our parents and please protect Maine children. Thank you.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Underwood.

Representative **UNDERWOOD**: Thank you, Mr. Speaker. What this particular question that needs to be answered, and that question basically is it's my body, and I'll do with it what I want. Thanks.

The SPEAKER: The Chair recognizes the Representative from Scarborough, Representative Murphy.

Representative **MURPHY**: Thank you, Mr. Speaker. In 2020, there was a statewide referendum held where 72% of Mainers voted to uphold the law allowing for exemptions from immunization requirements for medical purposes only.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Turner, Representative Morris.

Representative **MORRIS**: Thank you, Mr. Speaker. I rise in opposition to the pending motion.

The goal of this legislation is simple: We need more mental health care providers, we need more substance use disorder services in this State. This has been well documented over the last few years, I think; it's something that certainly multiple Committees have been working on, trying to find solutions. There's been a lot of bipartisan work on this issue. This seeks to find a way by repealing the Certificate of Need requirement. The way Certificate of Need works is it is effectively allowing your competition to weigh in on whether or not you need the services needed and whether or not a new facility can be built. This would remove that requirement for these two very important issues, two issues that have really arisen and been a pressure point in Maine and in our health care system the last few years. By removing a Certificate of Need, that's another barrier that people that are looking to address the issue of mental health care, as well as substance use disorder, would not have to go through an additional barrier, additional steps, to be able to build facilities and be able to offer services without having to seek permission from the government, as well as their competitors. So, I would encourage this Body to vote against this motion and let's pass this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Mathieson.

Representative **MATHIESON**: Thank you, Mr. Speaker. This bill would exempt psychiatric and behavioral health hospitals from the Certificate of Need review for projects that exceed the \$14 million threshold. For behavioral health providers, I agree, we need an increase in behavioral health providers in Maine. But this bill represents large psychiatric hospital projects, like the recent hospital construction renovation with Northern Light Acadia Hospital. The non-hospital-based behavioral health and substance use disorder services are not capital-intensive organizations. In general, they are outpatient service locations with ambulatory populations that enter and leave the building, receiving counseling and group therapy. Eliminating the Certificate of Need requirements for this type of service will have no effect on community-based behavioral health services, since this type of provider doesn't meet the threshold for project review. But there is a real risk to eliminating the Certificate of Need for inpatient-based care, as national for-profit behavioral health substance use disorder hospitals can

enter into Maine's health care market with the sole purpose for caring for commercially insured patients, refusing to serve our MaineCare patients and the uninsured, destabilizing our already fragile system. For this reason, I ask you to support the motion on the floor.

Representative MATHIESON of Kittery moved that the House **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Turner, Representative Morris.

Representative **MORRIS**: Thank you, Mr. Speaker. This bill is before us as a repeal of a provision of law that requires every single Mainer to buy a towing insurance policy, even if all they seek is the State limits for a liability policy. The reality of what this has done is it has fallen hardest on some of our poorest residents that now have to pay, according to the Bureau of Insurance in their testimony, upwards of 100 extra dollars a year for an insurance policy to cover the cost of the new towing mandate.

The Bureau of Insurance testified in favor of this bill in Committee. In part, what they said is that the idea of a policy around liability only is to protect other motorists in the event of an accident to make sure that their costs are covered if they are not at fault. This is attempting to ensure that it does not protect accident victims, but rather guarantees that commercial service providers will be paid. Indeed, the Bureau pointed out that there are other opportunities for towing insurance companies to seek a remedy to ensure that they are paid for their services, including being able to hold onto the vehicle and sell the vehicle if it is abandoned. This is requiring motorists; all motorists; to pay for an insurance policy, an additional coverage that they do not need, that they do not want, is, I think, irresponsible. We have seen again, some of our citizens that have the least, that are trying to comply with the laws around having to have auto insurance policy; that is in all of our best interest; that every single Mainer has an auto insurance policy, at least their liability limits, so that if someone does damage to my property, that there's an avenue for me to get paid and ensure that we don't have those types of issues. To now be required to single out one industry to ensure that they get paid, as opposed to other; there's no other place in law, to my knowledge, where that is done.

Furthermore, we are the only state in the country that is currently requiring this type of policy in our auto insurance policies. I think we should, as the Bureau said, restore the liability policies to where they were meant to be, where it is there to ensure that any property damage done to other motorists is taken care of, and there are other remedies available for towing companies. It should also be noted that in many cases, they ask to be asked to come to these accident scenes, ask to be put on the list, knowing full well what the current landscape is of that. And just passing a law saying that now there is a guarantee that every single Mainer has to buy an extra \$500 worth of insurance

that, in many cases, they will never use or never need, it is causing people to pay more for insurance. And we don't know, because they don't have; they're just guessing right now; we don't know and we won't know for a few years what the actual experience is of this. Once we start getting claims, we will. I would argue it's time, we should just end this experiment, we should repeal this law and pass this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Mathieson.

Representative **MATHIESON**: Thank you, Mr. Speaker. This bill does repeal the law that requires motor vehicle liability coverage in the amount of up to \$500 per accident for towing and storing charges, incurred as a result of an accident involving an insured vehicle, if the vehicle is towed at the request of law enforcement officers. This law was phased in as of July of 2024. The first report that the Committee heard from the Bureau of Insurance indicated the premium impacts would be estimated as an impact of 0.5 to 2.6 percent. The Committee felt that this was a new law and we needed to see more information and more data.

The Committee heard from many towing companies who work with public safety, that they were not being paid for towing and storage of abandoned accident vehicles, and this process could take an average of 60 to 75 days for a title to be issued. These companies have limited storage space and indicated they would likely not continue to tow for police, fire and rescue if they were not reimbursed. We felt that we needed to continue to support our Maine small businesses getting out of bed at 3:00 a.m. when they are called by their city police, Sheriffs' Departments and State Police for assistance along the roadside in keeping our roads safe. Please support the motion Ought Not to Pass.

The SPEAKER: The Chair recognizes the Representative from Skowhegan, Representative Poirier.

Representative **POIRIER**: Thank you, Mr. Speaker. Mr. Speaker, for five years now, I've stood before this Body on behalf of the Kineo Tribe. For more than a decade; actually, about 13 years now; they've been pleading with the State for recognition of who they are; a Native American tribe. They've been denied time and again, with reasons like the timing isn't right, they'll compete for funding, they should use the federal recognition process or we have no process for this.

One thing that hasn't been objected to is the fact that the Kineo are indeed Native Americans. In fact, some of them have even been issued lifetime Native American fishing licenses by our State, even though they're not enrolled in a current Maine tribe. Through the hearings and work sessions, it was actually found that some of the Kineo actually shared very close ancestors with members of the current tribes. We were talking about it in the hallway.

Federal recognition can take years and 10s of thousands of dollars to go through the process. In fact, the tribes here in Maine currently did not follow a singular path to gain federal recognition. Some gained recognition through court rulings while others gained their recognition through Acts of Congress. None of them went through the federal process that we see

today. Mr. Speaker, LD 813 creates a process for State recognition of tribes in Maine. A fair process that includes documented lineage and would be well vetted and provides a clear criteria.

Mr. Speaker, it's not uncommon for recognized tribes to oppose new recognition due to concerns over funding and shared resources. We've seen this in our State, back when the Maliseet and Mi'kmaq Tribes were trying to gain recognition, the other two tribes vehemently opposed.

Mr. Speaker, I ask you to join me and support the creation of a path forward. I don't know of any other group in Maine claiming Native American tribal status other than the Kineo that will use this process. Who are we to deny an opportunity for these people to be seen for who they are, to be recognized; who are we to deny them? Mr. Speaker, it's a shame that they have to ask us in the first place for simple validation of who they are, so, I ask you to join me in at least giving the opportunity for this bill to pass and give them a path forward. They're a small tribe of under a hundred, I believe it's 86 or 87 people, who just want to be seen for who they are. Thank you.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Kuhn.

Representative **KUHN**: Thank you, Mr. Speaker. And with due respect, of course, for the Good Representative and the individuals who came seeking recognition, the Committee opposed this bill for two reasons.

First, there was concern that legislative recognition of a tribe may exceed State authority, and to that point, I'll read from testimony we received: "The Wabanaki Nations have been engaged in a very public effort to repair the relationship the nations have with the State of Maine, working to restore the recognition of that sovereignty and the right to self-determination. The power to recognize and give this status is not and should not be in the hands of the State as they do not have the authority to designate who counts as a tribal nation." The reason for that is because there is a process and criteria for how nations are recognized federally, and it's especially salient here when the standards are so different. Under the proposed State recognition process, it is really focusing on establishing an affinity group based on history or ancestry, whereas the federal recognition rests on the recognition of a governmental entity. The tribe must have been operating as an entity on a substantially continuing basis since 1900 and no member can be a member of a federally recognized tribe. These criteria demonstrate that this recognition is based on citizenship and a continuous form of self-government, not affinity or ethnicity.

Finally, there was a concern that a separate recognition process could deter or undermine the federal process and the Wabanaki Nations that have achieved recognition through it. So, for these reasons, the Committee; the majority of the Committee; voted Ought Not to Pass.

The SPEAKER: The Chair recognizes the Representative from Skowhegan, Representative Poirier.

Representative **POIRIER**: Thank you, Mr. Speaker, for letting me rise again. I just want to make a quick note that, though there are over 570 federally recognized tribes in the United States, 13 states do have state recognition, recognizing over 100 tribes. So, let's think about that, and I ask again, who are we to deny these people? Thank you.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Lee.

Representative **LEE**: Thank you, Mr. Speaker. The process for determining what comprises a tribe in this bill differs substantially from what both the federal government in the United States as well as the Canadian government consider a tribe or a First Nation. For anyone who thinks that doesn't matter, I'd encourage you to take a look at what's happened in Vermont. They've recognized several groups as tribes and two Abenaki tribes have virulently opposed that recognition to the point of saying that the recognition, that the State of Vermont by accepting and promoting those unfounded claims, Vermont authorities contribute to legitimizing cultural and identity fraud which harms the true descendants and guardians of this heritage. This is an active and contentious issue in the State of Vermont, one that has harmed the state's relationship with its federally recognized tribes.

I, like many of my colleagues across the aisle, am very interested in improving the State of Maine's relationship with our federally recognized tribes. Each of those tribes opposes this bill, I'll be joining them.

Each suggested reference appearing upon the Advance Journal and Calendar of each chamber must contain a recommendation for the printing of the document being referred and may contain a recommendation on the number of copies of that document to be printed.

Any member may move for reconsideration of a committee reference on the floor. Notwithstanding Joint Rule 103, a majority vote is necessary to overturn the original committee of reference.

If there is not a majority agreement among the chairs and leads regarding reference of that bill, the bill is designated for discussion by the committee for a possible committee report of "refer to another committee" under Joint Rule 310, subsection 2. Any bill that undergoes a reference determination pursuant to this subsection that is retained by the committee must be scheduled for a public hearing.

**JOINT RESOLUTION RECOGNIZING MAY 2025 AS MENTAL HEALTH AWARENESS MONTH**

WHEREAS, the mental health and well-being of all children, youth, adults and families in the State are of fundamental importance to the Legislature; and

WHEREAS, since 1999, the national suicide rate has increased more than 36%, with more than 13.2 million individuals experiencing suicidal thoughts and 1.6 million individuals attempting suicide annually in the United States; and

WHEREAS, over 49,000 people died by suicide in 2022, which is about one death every 11 minutes; and

WHEREAS, suicide, opioid misuse and addiction and children's mental health issues are areas of concern in the State; and

WHEREAS, there are approximately 61,000 adults in the State who are living with a serious mental illness, including, but not limited to, bipolar disorder, severe depression and schizophrenia, and 14,000 children 12 to 17 years of age in the State have depression; and

WHEREAS, over 260,000 people in the State live in a community that does not have enough mental health professionals; and

WHEREAS, the effective treatment of mental health conditions is critical to reducing the number of individuals and families who find themselves in mental health crises, to breaking individual and generational cycles of mental illness and to promoting healing; and

WHEREAS, recovery from a mental illness requires access to professional services and involves families and caregivers as allies in recovery and as critical members of the care delivery team; and

WHEREAS, maintaining an open dialogue regarding mental health conditions encourages individuals struggling with mental illness to seek help and is an essential component to fighting the stigma associated with mental illness; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize May 2025 as Mental Health Awareness Month in order to raise awareness of mental health conditions and services and to break the stigma surrounding mental illness in the State.

Representative **GRAMLICH:** Thank you, Mr. Speaker, colleagues. I rise today in strong support of the "Joint Resolution Recognizing May 2025 as Mental Health Awareness Month."

Mental health affects every community, every family and far too many of our constituents. It is no longer a silent issue, nor should it be. As we stand here today, more than 13 million Americans are grappling with serious thoughts of suicide. In 2022 alone, we lost over 49,000 lives to suicide. That's roughly one every 11 minutes. These are not just numbers, Mr. Speaker; these are our friends, our neighbors, our coworkers and children. In our State, the need is urgent. Sixty-one

thousand adults are living with a serious mental illness. Fourteen thousand young people between the ages of 12 and 17 are suffering from depression, and over a quarter of a million of our residents live in areas without adequate access to mental health professionals.

Mr. Speaker, as you know, I'm a social worker with nearly four decades of experience working to ensure that all Mainers have access to the mental and behavioral health care that they need. I am proud and deeply grateful for the many advocates for mental health; who I have been honored to work with alongside over these years; as well as many of my colleagues within this Body. I also know that what progress we have made is simply not enough and Maine families deserve better. This Resolution is not just about one month on the calendar; it is about confronting the crisis of untreated mental illness. It is about reducing stigma, promoting recovery and ensuring that families and individuals know that they are not alone. It is about reminding ourselves that mental health is health, and mental health care is health care. This Resolution affirms that the people of our State deserve access to treatment, dignity in care and hope in recovery. It calls upon all of us, Mr. Speaker; legislators, families, educators, providers and community leaders; to open the door to wider compassion, to services and to action. By recognizing May as Mental Health Awareness Month, we take one small but meaningful step toward building a culture where it's okay to ask for help and where that help is truly available. Thank you, Mr. Speaker.

**JOINT RESOLUTION HONORING  
THE MEMORY OF POPE FRANCIS**

WHEREAS, the members of the 132nd Maine State Legislature were greatly saddened to hear of the passing of Pope Francis on Monday, April 21, 2025; and

WHEREAS, born on December 17, 1936, in Buenos Aires, Argentina, as Jorge Mario Bergoglio, Pope Francis entered the Society of Jesus at age 21 and was ordained as a Jesuit priest in 1969. He was appointed auxiliary bishop of Buenos Aires in 1992 by Saint John Paul II, became archbishop of the Argentine capital in 1998 and was created cardinal in 2001; and

WHEREAS, Pope Francis ascended to the papacy on March 13, 2013, upon the retirement of his predecessor Pope Benedict XVI, becoming the first pontiff from Latin America; and

WHEREAS, Pope Francis dedicated his entire life to the service of God and His Church and teaching the values of the Gospel with fidelity, courage and universal love, especially for the poorest and most marginalized; and

WHEREAS, during his almost 13-year pontificate, Pope Francis focused on mercy, care for creation and attention to those on the "peripheries of both the Church and society"; and

WHEREAS, Pope Francis canonized 942 saints during his papacy; and

WHEREAS, Pope Francis published 4 encyclicals, *Dilexit Nos* ("He Loved Us"), *Fratelli Tutti* ("All Brothers"), *Laudato Si* ("Praise be to You") and *Lumen Fidei* ("The Light of Faith"), as well as 7 apostolic exhortations and 75 *motu proprio* documents; and

WHEREAS, just hours before his death, Pope Francis reminded the faithful of the dignity of all persons, but most especially the vulnerable, the marginalized and migrants, and encouraged all of us "to hope anew and revive our trust in others, including those who are different from ourselves, or who come from distant lands, bringing unfamiliar customs, ways of life and ideas"; and

WHEREAS, Pope Francis led a holy life focused on humility, simplicity, poverty of spirit and a radical devotion to Christ's call of charity to the least among us; and

WHEREAS, it is fitting that we should remember the abundant life of this human being and successor to Saint Peter; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to honor the memory of Pope Francis, reflecting fondly upon his immense holiness and his legacy of service to those most in need.

**READ.**

The SPEAKER: The Chair recognizes the Representative from Carmel, Representative Thorne.

Representative **THORNE**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. It is with great respect and deep admiration that I rise today to introduce this Joint Resolution honoring His Holiness, Pope Francis. Not only is he the spiritual leader of millions across the world and a beacon of compassion, humility and peace, he's representative of Christianity throughout the world. Since his election as the 266th Pope of the Roman Catholic Church in 2013, Pope Francis has exemplified the values of service, love and unity up until hours of his passing, when he presented an Easter service on the balcony.

Mr. Speaker, there have been five popes in my lifetime, and today, on the eve of the conclave where 90 cardinals will gather in the Sistine Chapel to elect the next pope. Before this happens, I find it important that we recognize not only Pope Francis's remarkable leadership, but also reflect on the enduring legacy he continues to build through his actions, teachings and commitment to faith.

Many times, during eulogies and funerals, we've all experienced these words, and I'd like to share them with you today: "The Lord is my shepherd; I shall not want. He maketh me to lie down in green pastures: he leadeth me beside the still waters. He restoreth my soul: he leadeth me into the paths of righteousness for his name's sake. Yea, though I walk through the valley of the shadow of death, I will fear no evil: for thou art with me; thy rod and thy staff they comfort me. Thou preparest a table before me in the presence of mine enemies: thou anointest my head with oil; my cup runneth over. Surely goodness and mercy shall follow me all the days of my life: and I will dwell in the house of the Lord forever."

Mr. Speaker, I ask for your support in adopting this Resolution to honor Pope Francis for his lifetime of service to humanity, his commitment to peace, his tireless efforts to inspire and uplift us all and his dedication to our Lord and Savior. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Blue Hill, Representative Milliken.

Representative **MILLIKEN**: Thank you, Mr. Speaker. *Me pone un poco nerviosa de hablar en español en este piso pero aquí vamos.*

*Hace dos semanas, el mundo perdió a un líder y a un hombre muy especial, el Papa Francisco. Dado que el Papa Francisco fue el primer Papa de las Américas, y específicamente de una nación hispanohablante, me parece apropiado ofrecer unas palabras en español y en el inglés.*

*Aunque no soy una católica, creo que el Papa Francisco fue un gran hombre. Él amaba a todas las personas del mundo. Él creó un espacio; un espacio real y significativo; para miembros de diferentes comunidades, incluyendo comunidades de inmigrantes, lésbianas, gays, transtérminos y bisexuales. Ese espacio estuvo en el corazón de la Iglesia católica donde por muchos años esos grupos no se sentían bienvenidos. No solamente los toleraba. Los acogía, con un corazón que entendía que el amor no puede ser condicional. Nos recordó que cada ser humano merece respeto y amor.*

*Él cuidaba a quienes no creían en Dios, incluyendo a los ateos como yo. No necesitaba que fuera católico ni cristiano. Solo necesitaba que fuera humano y que intentara hacer el bien. Que llevara amor y bondad en su corazón. Y si lo hacía, él vería a Dios en sí mismo.*

*Hay un video del Papa Francisco que nunca olvidaré. Un niño pequeño, tal vez de unos siete años, se acercó para hacerle una pregunta frente de una gran audiencia. El niño estaba llorando y no podía articular sus palabras. El Papa Francisco le pidió que se acercara. El niño lo abrazó, llorando fuertemente, el Papa lo calmó y le secó a sus las lágrimas y habló con él en voz muy baja.*

*Entonces el Papa Francisco se volvió al público. Explicó a ellos que el padre del niño murió recientemente. El padre había sido ateo, pero un hombre bueno. El Papa Francisco les dijo, "debía haber sido un hombre bueno para haber criado a un niño que pueda llorar delante de toda esta gente al hablar de la bondad de su padre. El corazón de un padre. Dios también tiene el corazón de un padre." Y luego preguntó al público, "¿Abandonaría Dios a un hombre bueno, a un buen papá?" La audiencia gritó, "¡No!" Y el Papa volvió al niño y le dijo, "Ahí tienes tu respuesta. Dios está orgulloso de tu padre."*

*Ese momento me tocó profundamente. Mi abuelo fue un pastor durante toda su carrera. Y aunque nunca compartí realmente su fe, el Dios del que me hablaba; el Dios de la justicia, de la merced, de la acogida; era el mismo Dios que vivía a través del Papa Francisco. A pesar de mi falta de creencia, ese Dios es el espíritu que intento llevar por toda mi vida*

*también: ver lo bueno en todas las personas, honrar a cada alma, y nunca permitir que una creencia, un crimen, una nacionalidad o un pecado sean barreras para la compasión.*

*El Papa Francisco vivió ese espíritu hasta sus últimos días. Incluso en sus últimos días, llamaba a las personas en Gaza para asegurarse de que estuvieran a salvo. Pero no solamente se preocupaba por los cristianos; sintió tristeza profundamente por el sufrimiento de toda la gente de Gaza. Yo comparto su dolor, tanto por los niños de Gaza como por las masas pobres y amontonadas gimiendo por respirar libre en este país. Como el Papa Francisco, sigo su ejemplo de tener un profundo amor y respeto por todos los inmigrantes aquí en El Estado de Maine. Descansa en paz, Papa Francisco.*

Being that Pope Francis was the first pope from the Americas and specifically from a Spanish-speaking nation, it feels fitting that I provide my statements both in English and in Spanish.

I am not Catholic, but I believe Pope Francis was a great man. He loved all people. He made space; real, meaningful space; for members of the lesbian, gay, transgender and bisexual communities in the heart of a church that had for a long time made many of them feel unwelcome. He didn't simply tolerate them; he welcomed them with a heart that understood that love cannot be conditional. He reminded us that every human being deserves respect and deserves love.

He even cared for those who did not believe in God at all, including atheists like myself. He didn't need you to be a Catholic or a Christian; he just needed you to be human and to try to do good, to carry love and kindness in your heart, and if you did, he saw God in you.

There is a video of Pope Francis that I will never forget; a little boy, maybe seven years old, came to him to ask a question in front of a big audience. The boy was crying and couldn't get his words out. Pope Francis asked the boy to come to him. The boy hugged him, weeping. Pope Francis calmed him, wiped his tears and spoke softly to him. Then Pope Francis turned to the audience. He explained that the boy's father had recently died. The father had been an atheist, but a good man, and Pope Francis said to the audience, 'He must have been a good man to raise a child who could cry in front of all of these people to speak of his father's goodness. The heart of a father. God also has the heart of a father.' And then he asked the audience, 'Would God abandon a good man, a good father?' The audience shouted, 'No!' He turned back to the boy, and he said, 'There's your answer. God is proud of your father.'

That moment touched me. My grandfather was a minister for his entire career, and though I never really shared his faith, the God that he taught me about; the God of justice, of mercy and of welcome; was the same God that lived through Pope Francis. Despite my lack of belief, this God is the spirit that I try to carry with me every day to see the good in all people, to honor every soul and to never let a belief system, a crime, a nationality or a sin be a barrier to compassion.

Pope Francis lived that spirit until his final days. Even in his final days, he was calling friends in Gaza to make sure that they were safe. But he didn't only care about Christians. He was deeply saddened by the suffering of all of the people of Gaza. And I share his sorrow, both for the people of Gaza, and for the poor, huddled masses yearning to be free in this nation. Like Pope Francis, I follow his example and care deeply and have profound love for every immigrant in this State and in this country. Rest in peace, Pope Francis. Thank you.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Lemelin.

Representative **LEMELIN**: Thank you, Mr. Speaker. Pope Francis was a pope for everyone. I had the distinct honor and pleasure of having an audience with His Holiness, Pope Francis. In talking with the Holy Father, one thing I learned was that he was the most misinterpreted pope in my lifetime. An example is when President Obama visited with Pope Francis, he said, 'Your Holiness, you and I have a lot in common,' and Pope Francis responded, 'Mr. President, you and I have nothing in common.' Pope Francis wasn't being unkind or rude. He did this in private. He was just making it clear that President Obama's thinking is not in line with the Church and that President Obama, like many people, have misinterpreted his words.

Pope Francis was a man of humility, simplicity and poverty, and he did care deeply for every human being. He was a very devout man of God, and may he rest in peace. Amen.

The SPEAKER: The Chair recognizes the Representative from Buxton, Representative Carlow.

Representative **CARLOW**: Thank you, Mr. Speaker. Mr. Speaker, our Lord descended from His throne and, concealing His deity, kingship and priesthood, He entered mortal time and space; appearing to us as an infant wrapped in swaddling cloth; sent with divine charge to reclaim humanity from the snares of Satan, to renew, to transform, to invite his faithful flock to life everlasting. Indeed, the humble, reckless, eternal love of God is the greatest mystery of the Christian religion. At the center of our souls, in the quiet of our hearts, we can never fully, never truly comprehend the profound and deeply personal romance between our Creator and His creation. We need a teacher. We need a friend. We need a counselor. We need a pope to unravel this great mystery of the faith.

On Saturday, April 26th, the Supreme Roman Pontiff was interred in the Papal Basilica of Saint Mary Major; the first of the Western churches devoted to the Blessed Virgin. And it strikes me that the Vicar of Christ, the *Episcopus Romanus*, the Servant of the Servants of God laying down his papal titles, refusing the fanfare, refusing to be grand, surrendered himself to the arms of our Mother in Christ, freely given to all at the foot of the Cross. This final act of humility is an extraordinary promise to the Church that the love and mercy of God is not for a powerful or privileged few, but are poured out ceaselessly, intentionally, recklessly, upon all those who dare to seek them. Pope Francis showed us in both word and deed that we are children of mercy, that we are, indeed, pilgrims of hope. Facing eternity with fear and trembling, with joy and gladness and with conviction, confidence and courage, we must truly know we are sons and daughters of a loving Father.

Francis dedicated his pontificate and his earthly mission to revealing the incomprehensible truth of God's love to a broken and restless world. With humility undaunted, he did battle with great forces of darkness that seek to engulf and destroy. He fulfilled his priestly vows until his last breath, given just a day; just a day; after he stood before the world and professed the resurrection of Christ one final time. Across leagues of oceans and continents, by the power and grace of God, he touched the lives of billions of people, not just the Catholic faithful, but all people, all creeds, all religions and all corners of this rock.

Mr. Speaker, that's the power of love. That is the power of service. That is the life and the legacy of Pope Francis, the Pope of the People. "Eternal rest grant unto him, O Lord, and let perpetual light shine upon him. May his soul and the souls of all the faithful departed, through the mercy of God, rest in peace." Amen.

Representative **ROEDER**: Thank you, Mr. Speaker. Mr. Speaker, this Lutheran found a lot of inspiration in the late Pope's words on refugees, migrants and the incarcerated. I just want to share this with everyone: "The Church without frontiers, Mother to all, spreads throughout the world a culture of acceptance and solidarity, in which no one is seen as useless, out of place or disposable." Thank you.
