Motion by Representative BRIDGEO of Augusta, that Representative CARLOW of Buxton, Representative FOLEY of Wells, Representative POIRIER of Skowhegan, Representative SATO of Gorham, Representative RIELLY of Westbrook and Representative ABDI of Lewiston were appointed a Committee to receive, sort and count votes for the Speaker.

The CLERK: The Chair recognizes the Representative from Eliot, Representative Meyer.

Representative **MEYER**: Mr. Clerk, I move that the name of Ryan D. Fecteau of Biddeford be placed in nomination for Speaker of the House and wish to speak to my motion.

The CLERK: The Representative may proceed.

Representative **MEYER**: Women and Men of the House, it is with great respect for the honorable institution we serve that I rise today to place the name of Ryan Fecteau into nomination for the position of Speaker of the House.

I have had the honor serving with Ryan and under his leadership as both Assistant Majority Leader and as Speaker in the 129th and the 130th Legislatures, respectively. Colleagues, many of you seated here today have served under Speaker Fecteau. Ryan has built relationships with many more of you as a senior policy advisor to the Chief Executive. We have, in his previous service, benefitted directly from his steady leadership, strong work ethic, quiet confidence, his insight, intelligence, procedural knowledge and expert management of this Chamber, and for his ability to unite us in our valuable service to the people of Maine. As Speaker, Ryan deftly navigated an ongoing pandemic with the skill and the agility needed to lead us from our temporary home at the Civic Center back to this Chamber to continue and conclude the work of the 130th. Keeping those of us working and serving under the State House dome safe and productive was no small feat, and required collaboration with fellow leadership, focus, vision, common sense and compassion; all traits Ryan embodies in his work as a legislative leader and as a human being. Our legislative achievements under Speaker Fecteau and under those circumstances were nothing short of extraordinary.

My friends, the times have found us. We are a big Chamber tasked with addressing big issues, complex and urgent. We will convene the 132nd Legislature as our nation begins a new chapter, at a time of heightened polarization. The Maine people have honored us with our seats here and look to us to work diligently on their behalf to improve lives, to promote policies that reflect Maine values and to safeguard their fundamental rights. That requires real leadership, tested and proven. The work is hard under the best of circumstances and will only benefit from Ryan's ability to relationship-build, to work across the aisle, to support this Body with leadership we can depend on, that we can trust and that we can be proud of.

Ryan is a good person; warm and engaging, passionate about improving lives through good, sound policy. He has a disarming sense of humor, often self-effacing, and he is generous with his time and willingness to listen to our ideas, discuss our viewpoints and position us to do the best work for the people we serve. His respect for this institution and the citizen legislators serving here will be reflected in the way this House is run; orderly, with decorum, propriety, respect for your lives outside of this Chamber, respect for your service within it, respect for your time.

The manner in which he conducted the work of Speaker of the House received high praise from his Republican counterpart, Minority Leader Dillingham, upon the conclusion of their work together in the 130th. From this House Floor, she noted his negotiation skills, his honesty and fairness, his integrity, his

ability to find common ground on behalf of the Maine people we serve. High praise, indeed. That's aspirational leadership.

My friends, the people whose trust and vote you earned expect you to make right and reasoned choices here, choices that will position this Legislature to best protect and improve their lives. For that, the right leadership is imperative. That begins with your vote for Speaker of the House, and I ask for your vote for Ryan Fecteau.

Representative MEYER of Eliot moved that the name of RYAN D. FECTEAU of Biddeford be placed in nomination for the Speaker of the House.

The CLERK: The Chair recognizes the Representative from Camden, Representative Doudera.

Representative **DOUDERA**: I second the nomination of Ryan D. Fecteau for Speaker of the House and wish to speak to my motion.

The CLERK: The Member may proceed.

Representative **DOUDERA**: Thank you. Good afternoon, fellow Members of the Maine House of Representatives, and congratulations. I'm Vickie Doudera, starting my fourth term representing District 41, the people of Camden and Rockport, and I'm looking forward to serving with all of you.

Last week, we celebrated a day set aside for gratitude and, as we feasted on turkey and all of the trimmings, many of us paused to give thanks for this beautiful State and the hardworking, resilient, creative, amazing Mainers who call it home. Today, I find that feeling of gratitude welling up again, because one of these amazing Mainers, an outstanding man who many of you already know, has stepped forward to fill a critical role in this Chamber at a critical time in Maine's history.

Ladies and Gentlemen, Men and Women of the House, it's my honor and privilege to second the nomination of Ryan D. Fecteau for Speaker of the Maine House of Representatives. That the Good Representative from Biddeford is before us today is nothing short of serendipity. After serving four terms in the House from 2014 to 2022, Ryan experienced what will happen to all of us if we hang around long enough; he termed out. Even though he capped off his final term as Speaker and was the youngest presiding officer in the nation and the first openly gay Speaker in Maine's history, he was at the mercy of term limits, just like the rest of us. He got a job in the real world, continuing his passion for housing in our State, but then fate intervened; a seat opened up and Representative Fecteau came back to the House.

In the two years Ryan served as Speaker, we made incredible progress despite overwhelming odds. He led us through an unprecedented period of pandemic legislating, lighting the way in a dark time with strength, calm, good humor and compassion. He was respected by everyone in this building; yes, everyone; because he was fair and disciplined. He communicated with us and respected our time. He was inspiring and unflappable. Ryan knows what he's doing in this role and that really matters, because when a leader has mastery of the procedures, he or she can focus on other things, like managing the flow of legislation and committee assignments or smoothing ruffled feathers and egos. When a leader is skilled coming into this job, when he knows that rostrum like the back of his hand, he can then create a spirit of unity and common purpose among us; perhaps even start our sessions on time.

Lee Hamilton, a member of the U.S. House for 34 years, once said the Speaker's role is to make the Chamber work in spite of itself. With Ryan Fecteau's unique combination of experience and skill, we will do more than just make this Chamber work. We will make it a place where transformative things happen for the people of Maine; all the people of Maine.

A place of hope, healing and good health for our children and our woods, waters and wildlife. We are going to do great things with the right leadership, and I give thanks today that Ryan Fecteau has once again stepped up to be that leader. Thank you.

Representative DOUDERA of Camden seconded the motion.

The CLERK: The Chair recognizes the Representative from Skowhegan, Representative Poirier.

Representative **POIRIER**: Mr. Clerk, I move that the name of Billy Bob Faulkingham of Winter Harbor be placed in nomination for Speaker of the House, and I wish to speak briefly to my motion, please.

The CLERK: The Representative may proceed.

Representative **POIRIER**: Thank you, Mr. Clerk. Ladies and Gentlemen of the House, it is a great honor to offer the nomination of Billy Bob Faulkingham as Speaker of the House. I've had the privilege of working with Billy Bob for the past four years, and I know that he's a man of strong ethics and great integrity and faith. He embodies all of the characteristics of a strong and effective leader, including his ability and willingness to work with and, perhaps even more importantly, to listen to all of us, regardless of our political affiliation. This is what the people of Maine desire in a Speaker of the House; somebody willing to listen. Please join me and cast your vote for my leader, my colleague, my friend, Billy Bob Faulkingham, for Speaker of the House. Thank you.

Representative **POIRIER** of Skowhegan moved that the name of BILLY BOB FAULKINGHAM of Winter Harbor be placed in nomination for the Speaker of the House.

The CLERK: The Clerk recognizes the Representative from Monticello, Representative Ardell.

Representative **ARDELL**: Thank you, Mr. Clerk. I second the nomination of Billy Bob Faulkingham for Speaker of the House and wish to speak very briefly to my motion.

The CLERK: The Member may proceed.

Representative **ARDELL**: Through the 131st Legislature, in his role as Minority Leader, I observed Representative Billy Bob Faulkingham to be a grounded and pragmatic leader. Representative Faulkingham was able to respectfully listen to different viewpoints before reaching a course of action that kept all parties in mind, excluding none. Representative Faulkingham would continue to manage this Body with a spirit of goal-oriented, mutual respectfulness and help represent not only all members, but all Mainers. I'm certain that Representative Faulkingham's track record of thoughtful, steady and inclusive leadership would continue as leader of this Body. Thank you.

Representative **ARDELL** of Monticello seconded the motion.

Representative **MOONEN** of Portland moved that nominations cease.

Subsequently, the Committee reported that it had attended to its duties and that the Representative from Biddeford, RYAN D. FECTEAU, having received a majority of the votes cast, had been elected Speaker of the House for the 132nd Maine Legislature.

The Sergeant-at-Arms escorted Speaker-elect Fecteau to his chair.

The Honorable ROBERT B. HUNT, Clerk of the House of the 131st Maine Legislature, administered the necessary oath of office to qualify the Speaker of the House to enter upon the discharge of his official duties.

The House was called to order by Speaker Ryan D. Fecteau of Biddeford.

---

At this point, pursuant to his authority under House Rule 201, the Chair addressed the House.

Speaker **FECTEAU**: Good afternoon. Good morning; oh, yeah, not quite yet. I guess we did start somewhat on time today.

It is with great pride and humility that I stand before you today to once again serve this institution and our State as Speaker of the Maine House of Representatives. Just as I did four years ago, I want to begin by congratulating each of you. Whether you are returning or newly elected, you're here because of your commitment to the people of Maine. The effort it takes to run for office to represent your communities and to dedicate yourself to public service is no small feat, and it takes even more from your families, friends and supporters who stand behind you every step of the way. Let's take a moment to thank them.

My Mom, Grammy, Dad and his wife are here cheering me on today, and so is my husband, Dylan. Dylan, I'm blessed by our partnership and love, and I'm endlessly grateful for your support.

For those of you who may not know me, my name is Ryan Fecteau, and I'm proud to represent the City of Biddeford, the community where I was born and raised. My *Meme* and *Pepe* moved to Maine from Quebec in 1964, seeking a better life. Like many who came before them, they worked hard in Biddeford's textile mills and they had a vision of a brighter future. My mom is, to this day, a caregiver, and for many years, my dad worked in the dyehouse in those same mills. My parents instilled in me when I was young the value of hard work and perseverance. But it was not always easy to make ends meet; sometimes food wasn't always plentiful or nutritious, our car wasn't always reliable, but we always had a safe place to call home and a public education that lifted us up. When you're living on the edge, like my family was back then, it seemed like every financial crisis that could happen, did happen. For too many Maine people, this struggle is still a daily reality; when every month feels like a balancing act, figuring out which bills can be delayed just to put food on the table for one more week; when a car repair or a trip to the doctor can devastate an entire monthly budget and the worry of how to make it to the next paycheck never fully fades.

Everyone in this room has heard loud and clear that rising costs are top of mind for just about every Mainer. And that is what drives me to fight for policies that support working families. I don't want families to merely scrape by, I want them to have financial security and opportunity. No matter the district you represent or whether you're a Republican, Democrat or Independent, I'm certain that's what you all want as well. I believe that every single one of you here and serving in this role is doing so to make life better for the people in this State. I think each of you have incredibly important experiences and backgrounds that will impact our work, and I pledge to listen and learn from your stories, just as you have mine.

This day marks an opportunity like no other. It's a moment to set aside the divisions that too often define our political landscape and instead focus on common purpose; the common purpose that brought all of us here today, to make life better for the people of Maine. I know that politics in America today can feel bitter and divisive. We see it on the news, we hear it in our communities and, too often, we feel it in our hearts. Closer to home, even my own family, we have differences of political opinion that can feel difficult to bridge sometimes. But I also know that we right here in this room have the power to show that the government can work, that compromise is possible and that progress is within our reach. I will not stand up here and pretend that this work will be easy. Yes, the challenges we face are complex and sometimes daunting. The debates we can have will be spirited, sometimes even contentious. But in this Chamber, under my tenure, they will be conducted with respect and civility. I believe the strength of our democracy lies not in uniformity, but in the diversity of voices, perspectives and ideas that we all bring to the table. Let us use this session to prove what Maine has already known; that we are stronger when we work together; that solutions are found not in digging trenches, but in building bridges.

We have critical work ahead of us. Housing remains one of the greatest challenges our State faces. I've spent my public and professional life working on that very issue. The fact is, and we all know this, too many families are struggling to find an affordable place to live. We must work together to ensure that every Mainer has access to safe, stable and affordable housing. Because a home is more than just four walls, it's the foundation for opportunity, stability and dignity.

Education and health care and child care, too, must be at the forefront of our efforts. Maine's children deserve the best possible start in life, with safe, predictable, affordable care and schools that prepare them for success and opportunities that inspire their dreams. We owe it to our kids and to the future of this State to invest in our public schools, support our educators and expand pathways to higher education and career and technical training.

We must ensure our natural resources remain protected for years and decades to come. Our environment is not just a part of Maine's identity, it's a key driver of our economy and the heart of our way of life. From our working forests and heritage industries like fishing and farming, Maine's natural resources sustain our communities, drive key industries like tourism, outdoor recreation and renewable energy. This isn't just about conservation, it's about preserving jobs, supporting families and ensuring that future generations can thrive here just as we have.

There will be many opportunities for compromise in this Chamber, and we should embrace those moments when they arise. In fact, while it may not make the headlines, it will be the majority of the work that we do here. But let me be clear, there are lines that we will not cross. When it comes to civil rights, fundamental freedoms and the basic dignity of every person in this State, we will stand firm. These are not matters of partisan debate; they are the foundation of who we are as a people and as a nation. Protecting these principles is our moral obligation and is what ensures Maine remains a place where everyone can live with fairness, respect and opportunity. On these values, there is no compromise. Because remember, every decision here affects the lives of real people. People who may look or think just like we do, and also people who don't, but all equally deserving of representation and fairness. Families struggling to make ends meet, seniors trying to age with dignity, kids striving for a better, more secure future; we owe it to all of them to lead with courage, compassion and integrity.

The President of the Senate, the Honorable Matthea Elisabeth Larsen Daughtry, in the Chair.

The Convention was called to order by the Chair.

The CHAIR: Nominations are now in order for the office of Secretary of State for the political years 2025 and 2026. The Chair recognizes the Representative from Boothbay, Representative Stover.

Representative **STOVER**: Madam Chair, I nominate Shenna Bellows of Manchester for the Office of the Secretary of State for the political years 2025 and 2026 and wish to speak to my motion.

The CHAIR: The Member may proceed.

Representative **STOVER**: Congratulations to everyone gathered here today. Serving in this esteemed Body is both an honor and a sacrifice, reflecting your unwavering commitment to Maine and her people. Your dedication embodies the spirit of our State motto; *Dirigo*, I lead.

It is with profound honor and enthusiasm that I rise today to nominate Secretary of State Shenna Bellows for a third term. Shenna Bellows truly exemplifies the spirit of *Dirigo*, demonstrating leadership grounded in the highest standards of public service, innovative, responsive, and deeply attuned to the needs of Maine people. I have had the privilege of knowing and working alongside Shenna Bellows for nearly 20 years, from her time leading the ACLU of Maine to her current role as Secretary of State, her dedication to civil rights and voting rights has been unwavering. Together, we partnered on legislation to establish Maine's first-ever Executive Director of the Permanent Commission on the Status of Women, providing long overdue full-time support to a Commission I once served on when it was entirely volunteer driven.

This collaborative spirit defined Shenna's leadership, but it is her ability to respond with compassion and efficiency in times of crisis that truly sets her apart. In late October, two of my constituents faced unimaginable loss when a devastating fire destroyed their home and belongings, including their driver's licenses. As they struggled to rebuild their lives, I reached out to Secretary Bellows late on a Friday night. By Monday morning, her team had processed same-day replacement licenses, ensuring my constituents could access critical services. This is the essence of Shenna's leadership. She works tirelessly and brings extraordinary expertise to every aspect of her job. As the House Chair of the State and Local Government Committee during the 131st Legislature, I had the honor of working closely with Secretary Bellows on initiatives supporting the Maine State Archives and the Board of Corporations, Elections and Commissions. Time and time again, she has proven to be an invaluable legislative partner; deliberative, accessible and transparent. When questions arise, Shenna does not evade them; she provides honest and timely answers. For example, when space constraints in the Bureau of Corporations became a concern, Shenna just didn't present data, she invited legislators to see the problem firsthand, fostering bipartisan collaboration and building trust across the aisle. This commitment to partnership and practical problem-solving is a hallmark of her leadership.

Shenna's vision extends far beyond legislative collaboration. Under her leadership, Maine's achieved the highest voter turnout in the nation in 2022 and set new records for participation in the most recent elections. These accomplishments are no accident; they reflect her relentless pursuit of innovation, from implementing automatic voter registration at the Bureau of Motor Vehicles to launching online voter registration and expanding voter education statewide. Four years ago, Secretary Bellows promised modernization and she delivered. Across every bureau she oversees, Shenna has driven changes that make government smarter, more efficient and more accessible for the people of Maine, from pioneering a state-of-the-art digital record system at the State Archives to enhancing identity security at the Bureau of Motor Vehicles and modernizing corporate filing and notarization systems. She has redefined what it means to lead with a vision and results.

For these reasons and more, I am honored to nominate Shenna Bellows of Manchester for a third term as Maine's Secretary of State. Her record speaks for itself and her dedication inspires all of us. I urge you to join me in re-electing Shenna Bellows as Maine's Secretary of State. Thank you.

On motion of Representative STOVER of Boothbay, the Honorable Shenna Bellows of Manchester was placed in nomination for the office of Secretary of State for the political years 2025 and 2026.

The CHAIR: The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Madam Chair, I second the nomination of Shenna Bellows of Manchester and wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **GROHOSKI**: Good afternoon, Esteemed Colleagues of the Maine House and Senate. It is truly a pleasure to be with you here today, after having all of us just been duly sworn in to this important role and this important responsibility that we all share and will carry together.

As the Senator for Hancock County, it is a pleasure to second the nomination of Shenna Bellows, also originally from Hancock County, to her third term as Maine's Secretary of State. Not only are we both from Hancock County and graduates of Middlebury College, but we are also the daughters of businessmen who made a living in the trades. Indeed, our fathers; hers, a carpenter and mine, an electrician; worked on the same job site a number of times. When you grow up as we did in Downeast Maine, you gain an important understanding of the challenges, opportunities and culture of rural Maine. That's one reason why I appreciate the work Secretary Bellows has done over the last four years to strengthen and modernize elections, to improve services at the Bureau of Motor Vehicles, to make historical records at the Maine State Archives accessible to people statewide and to celebrate small businesses and institutions through her work in corporations. These efforts benefit urban and rural Mainers alike.

A couple of years ago, Secretary Bellows invited me to join her at an American Legion event in Bar Harbor. It was a great honor to award four local World War II veterans with Sentiments and flags that had been flown over the State House, including one gentleman who had served on the USS Missouri, the same battleship my *Pepe* served on. Celebrating milestones like the service of our veterans and the centennial commemorations of businesses and nonprofits across the State is something that Secretary Bellows prioritizes, because she understands that our work includes lifting up our constituents and connecting them with State government.

Her customer service on behalf of our constituents is excellent. Earlier this year, a small business owner in my district who sells antique cars was deeply concerned about a policy change regarding dealer license plates; something I really did not know anything about. Secretary Bellows reassured me that she would personally see to it that he got what he needed, and she certainly did. To say that he was grateful to have the plates back that he had had for the nearly 50 years he had been in business would be an understatement. I think I hope someday, he might ride us around in a parade in one of those antique vehicles; my personal goal.

This same experience reminds me of a constituent that Representative Milliken and I share. He had a license plate that was deemed inappropriate under recent law by the Secretary of State's office; and no, I'm not going to read it out loud here, don't get your hopes up. This constituent, unfortunately, has ALS, and the plate featured an expletive that made it clear how he felt about this disease. Secretary Bellows called him personally to talk through a few options. She hand-delivered him a new license plate that reads "IH8ALS," with cool-like eight in it, and in exchange, he gave her a bumper sticker replica of his old license plate, which was one of the options that she had suggested to him, and she still has that on her refrigerator to this day.

As I hope these examples illustrate, Secretary Bellows understands that the work of her Department is really about making government work for Maine. She brought online appointments to the BMV, so that working people could get in and out very quickly. She deployed an electronic lien and titling solution which supports banks, credit unions, car dealers and customers. She implemented remote online notarization to help Realtors facilitate transactions between remote buyers and sellers. These are just examples of a few of the modernizations that she's overseen that have especially benefitted rural Mainers. I for one have benefitted from and appreciated that it only took me 10 minutes last summer to renew my driver's license at the Ellsworth BMV, because I had made an appointment first. So, please, do tell all your constituents about this great service.

In my experience, when Secretary Bellows makes a promise, she follows through. When she talks about her vision over her next term for mobile BMV units and BMV kiosks and a new central voter registration system to improve efficiency and security for election officials, I know she will deliver. I have firsthand experience working with her to make a policy proposal a reality. Three years ago, Maine was one of the last states without a post-election audit program, and Secretary Bellows worked with me on a bipartisan law to implement post-election audits to strengthen our integrity of our elections and to improve voter confidence.

Secretary Bellows is an honest and courageous leader and an independent thinker. I'm not the only legislator in this room who has been on the opposite side of her in an issue. Indeed, I'm not even the only legislator in this room who has been on the opposite side of her in a lawsuit. These experiences have made it crystal clear to me that she is exactly who we need as Secretary of State, because she approaches every issue for what it is and not who is presenting it. We need leaders who are thoughtful, independent thinkers and willing to work with all of us in our work for Maine people. I think that's who Secretary Bellows is, and it's why I encourage you to vote yes to re-elect Shenna Bellows as our Secretary of State. Thank you all.

Senator GROHOSKI of Hancock seconded the motion.

The CHAIR: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: I nominate Sawin Millett and would like to speak to my nomination.

The CHAIR: The Member now may proceed.

Representative **FAULKINGHAM**: Thank you. I am honored to nominate Sawin Millett for the Constitutional office of Secretary of State for the 132nd Legislature. Following years of partisan division and acrimony, the Maine people deserve a Secretary of State who embodies impeccable ethics and is held in the highest regard for their trustworthiness and transparency. Sawin Millett, who is known by most of us in this Body, embraces the qualities that we value most as public servants.

Sawin Millett, Jr., was born in Waterford, Maine, in Oxford County, and his family settled on a farm in Dixmont in Penobscot County when he was in the fourth grade. To this day, Sawin Millett is an active farmer. He graduated from Carmel High School in 1955 and, like his father before him, attended Bates College. After graduating, he returned to Penobscot County and began teaching at Hermon High School and continued teaching there until 1971.

Sawin spent decades serving as a trusted advisor to Maine's Chief Executives. He served in the administrations of four previous Chief Executives; Longley, McKernan, King and LePage; with two different political affiliations, two Independents and two Republicans. He was Commissioner of Education for Maine's first Independent Chief Executive, James Longley. He was Commissioner of the State Finance Department for Chief Executive John McKernan. He served as Associate Commissioner on the Department of Mental Health for Independent Chief Executive Angus King and, most recently, he served as the Commissioner of Administrative and Financial Services in the administration of Paul LePage.

Sawin also served honorably in the Maine Legislature. He first served in '69, '72 and in 2002, he once again won the seat in the Maine House of Representatives. In 2018, he served for a third time in the Maine House until the 131st Legislature.

Sawin is Maine's foremost budget expert. As a longtime Republican Lead on the Joint Committee of Appropriations and Financial Affairs, he has worked on Maine's budget, taxation and financial affairs. Ryan Low, who served as the Commissioner of Finance under Democrat Chief Executive John Baldacci, said of Sawin, I would do just about anything for him. There's no one more of an expert on budgeting and legislative process, but even more than that, he's a genuinely nice person.

Regardless of party affiliation, Sawin earned the trust of this legislative Body and the Maine people during his decades of service to the State. Sawin is a magnificent choice. As Secretary of State, he would represent the Body well and serve the Maine people with complete trust, confidence and provide fairness in our electoral process. Please join me in voting for Sawin Millett as Maine's next Secretary of State.

On motion of Representative **FAULKINGHAM** of Winter Harbor, the Honorable Sawin Millett of Waterford was placed in nomination for the office of Secretary of State for the political years 2025 and 2026.

The CHAIR: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madam Chair. I rise to second the nomination of H. Sawin Millett, Jr., to the position of Secretary of State and wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **BENNETT**: Thank you. With thanks to Leader Moonen for his hospitality. Fellow Members of the 132nd Maine Legislature, I am so pleased to offer a few words to recognize

and congratulate Sawin Millett on decades of service to this State and to put his name in nomination for this important post. As you've heard, Sawin Millett has dedicated his life to serving his community and our State, and Maine is much better off because of his service.

Sawin began his career in the Legislature, as mentioned, by getting elected to the House in 1966. He served for two terms and then returned home to serve in the position of Principal and Assistant Superintendent in his home school district. He then became the first Executive Director of the Maine School Management Association. An incredible analytical mind, Sawin has worked for and with people from all ideological and political backgrounds. In 1975, he was appointed by Chief Executive Jim Longley to be Maine's Commissioner of Education. Chief Executive 'Jock' McKernan placed Sawin in charge of school finances, and then the Commissioner of DAFS. He served in that role for two terms, and then served Chief Executive Angus King as legislative director and then as finance director for the Mental Health Department. In 2002, during Chief Executive Baldacci's administration, he returned to the Legislature and served a full two terms. As mentioned, he also served as DAFS Commissioner for Chief Executive LePage's first term. When he left that job, he actually joined the staff of Senate President Mike Thibodeau and the Senate Republicans to help them tackle the budget, and he came back to the Legislature after winning election in 2018 and served until yesterday.

Throughout all of that service, all those many decades, Sawin returned home every night to the mountains of western Maine, his home of Waterford, to tend to his cows the following morning before coming back to Augusta. Through all of that, he maintained a great deal of demeanor, patience, calmness and taught many of us how to be not only better at the budget and finances, but how to be better legislators. He always explained things slowly and methodically, which I personally appreciated a lot. He carefully considers incredibly complex budgetary matters, all policy issues. It's simply a marvel watching Sawin's brain work.

He has served at every level of government. In fact, he was just recently elected unopposed by acclamation to the Oxford County Commission. So, it is with that in mind that I ask you all to think about voting for this incredible man for this important post and I hope you will do so in joining me, because simply put, Sawin Millett is the best Maine public servant I have ever had the privilege of knowing. Thank you, Madam Chair.

Senator BENNETT of Oxford seconded the motion.

Representative MOONEN of Portland moved that nominations cease.

The CHAIR: The nominees are the Honorable Shenna Bellows of Manchester and the Honorable Sawin Millett of Waterford for the office of Secretary of State for the political years 2025 and 2026. The Chair will appoint a committee to receive, sort and count votes for the office of Secretary of State for the political years 2025 and 2026.

The Chair announced the result. 181 votes having been cast, 91 votes necessary for choice, the Honorable Shenna Bellows of Manchester having received a majority of all votes cast, the Chair declared the Honorable Shenna Bellows of Manchester duly elected to the office of Secretary of State for the political years 2025 and 2026.

The CHAIR: Nominations are now in order for the office of State Treasurer for the political years 2025 and 2026. The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACCI**: Thank you, Madam Chair. I nominate Joseph Perry of Bangor for the office of State Treasurer for the political years 2025 and 2026 and wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **BALDACCI**: Thank you, Madam Chair, and congratulations to everyone here. It's an honor for me to be able to address you in the House, a very high privilege.

You know Joe Perry, so, do I need to say more? But I've known him for almost 50 years, as incredible as it may seem. We were in CCD together and he was able to convince the nuns that he was a good student while Baldacci was not a good student. So, our relationship goes back many, many decades. But I have served with him on the City Council, I have worked with him on a number of community projects, he's served 14 years on Taxation, he's served six years on Business and Insurance, he has a great knowledge and experience in terms of financial issues and, I think, he also has the honesty and integrity and I've known him almost his entire life; honesty, integrity and hard work. And he will work for everybody in this Legislature; Republican, Democrat, Independent; that is the way Joe Perry is, that is the way Joe Perry has always been. He operates a small business and has for 30 years in Bangor, and in the neighborhood which we both grew up in, he is really an important lifeline for many people. I don't like to say this often in front of him, but he is one of the kindest, nicest people. There are people that have needed some genuine emergency assistance and he's not been afraid to help out, and I think that's made him; obviously, it's made him a good politician, but it's also made him a really decent and honorable public servant, and I think he will serve us well and I ask you to consider him. Thank you.

On motion of Senator BALDACCI of Penobscot, the Honorable Joseph Perry of Bangor was placed in nomination for the office of State Treasurer for the political years 2025 and 2026.

The PRESIDENT: The Chair recognizes the Representative from Bangor, Representative Rana.

Representative **RANA**: Madam Chair, I second the nomination of Joseph Perry of Bangor, and I wish to speak to my motion.

The PRESIDENT: The Member may proceed.

Representative **RANA**: Congratulations to my Esteemed Colleagues for being sworn in to office today. I am delighted to be rising today to second the nomination of Joseph Perry of Bangor to the position of State Treasurer. Joe has over two decades of experience in this building. That experience has been vital in supporting his colleagues make sound and informed judgments with every piece of legislation that we analyze. The institutional knowledge that he holds and his deep understanding of complex policy areas will serve us well in the Treasurer's role. As many of you know and have experienced, Representative Perry is; or Joseph Perry, I should have said; is a friend to everyone regardless of political party or background.

This extends to our constituents, who I know he will help whenever we ask him to. This is exactly what we need in a Constitutional Officer; someone who is able to work with everyone and get the job done. He's qualified and knowledgeable and absolutely fit for this position. I hope you will all join me in supporting him for this role. Thank you.

Representative RANA of Bangor seconded the motion.

Representative MOONEN of Portland moved that nominations cease.

On further motion of the same Representative, one vote was cast, on part of the Convention, for the Honorable Joseph Perry of Bangor for the office of State Treasurer for the political years 2025 and 2026.

The Chair declared the Honorable Joseph Perry of Bangor duly elected to the office of State Treasurer for the political years 2025 and 2026.

The CHAIR: Nominations are now in order for the office of Attorney General for the political years 2025 and 2026. The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE**: Thank you, Madam Chair. I nominate Aaron Frey of Bangor for the office of Attorney General for the political years 2025 and 2026 and wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **LAWRENCE**: Thank you. And I'm kind of at a loss here, because the person that was going to nominate Aaron Frey for Attorney General, Senator Brenner, had to leave and so, she gave me all her notes. I'm still trying to figure out how Joe Perry got elected as State Treasurer and then re-elected three seconds later. That, to me, is the most amazing thing I've ever seen in the Legislature.

Senator Brenner gave me wonderful remarks about Aaron Frey, none of which I'm going to read. I told Aaron if he dropped this on me, I was going to do a roast of him rather than nomination. But I do want to talk a little bit about the Aaron Frey that I know and why I support him so strongly for the position.

I came back to the Legislature; I was elected back to the House several years ago and I sat where the Good Representative from Portland, Representative Brennan, is sitting, where they put, you know, all former lawyers and presidents, so they can keep their eye on them, so they don't get up to any mischief, and behind me was Speaker Martin and Representative Aaron Frey, who were on the Appropriations Committee. And so, I had both of them yacking in my ears that first session. But I got to know Aaron pretty well because he, like me, was a small-town attorney, ran an office himself and he had tons of questions for me about how I ever served in the Legislature and ran a law office back home and how I survived. And Aaron did a lot of, if you know, the court-appointed work, which was the most difficult work to do because it paid hardly anything, it was very demanding work, but a very critical and essential part of our legal system and I understood it, because I had been both a court-appointed attorney for criminal defendants as well as a District Attorney and I knew things don't work unless those two positions work very well. So, Aaron and I talked a long time.

You know, Maine has a tradition that no other state does; we elect the Attorney General by the Legislature. Other states have Chief Executives appoint them, one has the Supreme Court appoint it, others are elected popularly at large. But one of the unique things about Maine is because it's elected by the

Legislature, we have a tendency to select very pragmatic and practical people for that office. We have a great tradition, going all the way back to Jim Erwin, who was a Republican from down my way who got elected as Attorney General, all the way up through Jim Tierney and others. And the reason why is we don't choose, always, you know, people have served in government service for a long time, we don't choose people who graduated at the top of their law school or the best law school; we elect people who understand how our legal system works. And that's why I support Aaron Frey so much. The work he did in private practice is something you cannot experience if you're in the Attorney General's Office or a DA's office or any other place. It's a practical understanding of what happens to people in our legal system in this country.

The Attorney General is our top law enforcement officer in the State of Maine and it's essential they have an understanding not only of representing the State of Maine, but representing the people of the State of Maine in the legal system and understanding how to protect their rights. And that's what Aaron Frey has done; I'm very impressed in the six years he's been Attorney General, he has grown into the position. Somehow, he has lost weight. For a minute, you know, I almost thought about running for Attorney General because if it meant I'd lose 50 pounds, you know, that was a good thing. But I still haven't found out from him how he did it, but he's done an excellent job and has an excellent staff there. But the key to why he does such a great job is unlike anybody else in the office, he understands what it's like to run a small law firm. He understands what it's like to represent average citizens in the legal system and that's a key essential element to understanding how to be the top law enforcement officer in the State of Maine. So, I hope you will join with me in supporting Aaron Frey for reelection as Attorney General. Thank you.

On motion of Senator LAWRENCE of York, the Honorable Aaron Frey of Bangor was placed in nomination for the office of Attorney General for the political years 2025 and 2026.

The CHAIR: The Chair recognizes the Representative from Falmouth, Representative Kuhn.

Representative **KUHN**: Madam Chair, I second the nomination of Aaron Frey of Bangor and wish to speak to my motion.

The CHAIR: The Member may proceed.

Representative **KUHN**: Thank you. Esteemed Colleagues, it's my honor to second the nomination of Aaron Frey to continue to serve as Maine's Attorney General. Attorney General Frey brings a strong background of professional experience to this nomination, having served 10 years as an attorney in private practice, six years as a legislator on the Appropriations Committee and six years as Maine's Attorney General.

During his time as Attorney General, AG Frey has helped to advance a number of important policies. I will name just a few. First, Attorney General Frey has been a strong partner in addressing the opioid crisis, securing settlement funds that will support a wide range of prevention and treatment programs over the next 18 years. He has also promoted more humane drug policy by supporting a number of legislative efforts to reduce the criminalization of individuals with substance use disorder. Second, Attorney General Frey has initiated and supported important litigation to hold corporations accountable for damage to our environment and our human health, including contamination from PFAS and PCBs and the role of fossil fuel products in causing climate change. Third, as a member of the Judiciary Committee, I can speak to Attorney General Frey's efforts to advance important bills towards greater tribal

sovereignty. This includes expansion of the tribal criminal court jurisdiction, preparation of the Maine version of the Indian Child Welfare Act and support for an amendment to the Maine Constitution to publish Maine's treaty obligations.

In addition to these important policy areas, I can also speak to Attorney General Frey's accessibility, collaboration and support for legislators, so that we can do our jobs well. As an example, for several months, Attorney General Frey has made himself and his office available to help consider emerging law in other states on data privacy. This is a complex and technical area of law; having access to expertise is greatly beneficial in ensuring that proposed legislation is brought to this Body that is thoughtfully considered and carefully drafted. Attorney General Frey arrives at this moment with years of experience on the job, a strong team here in Maine and a network of Attorneys General across the country, all ready to do the work. I ask that you join me in supporting Aaron Frey for Attorney General. Thank you.

Representative KUHN of Falmouth seconded the motion.

The CHAIR: The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART**: Thank you, Madam Chair. It is my honor to nominate the Honorable William Schneider of Durham for the office of the Attorney General for the political years 2025 and 2026 and I wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **STEWART**: Thank you, Madam Chair, Ladies and Gentlemen of the newly sworn-in Maine Legislature. First, I'd echo my congratulations to you all as we embark on this two-year journey together. And it strikes me that we do so much of the important work right out of the gate in the Legislature. You may not know who or have even had the chance to meet some of the people who you are voting on today. But it's my honor to introduce to some of you this man known as the Honorable William Schneider, and Maine's former Attorney General.

I think this is incredibly important because what you need to know is that Bill is not a partisan guy. And as we look at this Body of people collected here to make some of these really important decisions on behalf of the people of the State of Maine, you have a choice to make. And some of you, for my friends on the left, do you follow someone and vote for them just because of the letter next to their name, or because you feel that they are most qualified? I hope it's the latter. And if it is the latter today, we will have a new Attorney General who will lead our State's law enforcement and be our advocate in the judicial system for law enforcement.

Bill has the most amount of experience that one can hope to have in this position. Not only was he a practicing attorney, he was also a member of the Special Forces in the United States Army. He has prosecuted terrorists on behalf of this country. He has engaged in drug enforcement efforts against those who bring illegal narcotics into our State and into our country. He served in this Body with some of you who are still here today. He served as a judge in the State of Maine. He serves, and some of you might be familiar with him, on the Ethics Commission in the State of Maine. He is regarded with the utmost integrity of perhaps anybody I know in Maine politics. He's not going to be an Attorney General for Republicans or Attorney General for Democrats; he's the Attorney General for the State of Maine. His rapport even within the Office of the Attorney General is so high, I had Democrats that work there now saying he would be a good choice, he would be one you could be proud of, he could be one that we can all be proud of.

I hope sincerely that, right out of the gate, we make the right decision in this Legislature to truly set partisanship aside and do what is, without question, the best thing that we can do for the people of the State of Maine, the Office of the Attorney General and for our future. I hope you'll join me in selecting the Honorable William Schneider as Maine's next Attorney General. Thank you.

On motion of Senator STEWART of Aroostook, the Honorable William Schneider of Durham was placed in nomination for the office of Attorney General for the political years 2025 and 2026.

The CHAIR: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Chair, Ladies and Gentlemen of the House, Ladies and Gentlemen of the Senate. I second the nomination of William Schneider of Durham and wish to speak to my motion.

The CHAIR: The Member may proceed.

Representative **FREDETTE**: Madam Chair, as most of you are aware, Mr. Schneider was here today or yesterday briefing us on ethics and briefing us on our responsibilities from an ethical point of view in regards to our responsibilities as Representatives in this Body. So, I must begin by apologizing in telling the good William Schneider that in voting for him, I'm voting against myself, because the good candidate on the Democratic side practices in my court in Newport. And so, if we elect him, he's going to come back and take all those clients back and I'm going to be losing all those clients. And so, I don't know if that's a conflict of interest or not, Mr. Schneider, but I can only tell you that Mr. Schneider has been an honorable servant for the State of Maine. I think that the Good Senator from Presque Isle spoke to his attributes as being appointed both in this Body as a former Republican Leader, as someone appointed to the judgeship, and I think he would be an honorable person and I second his nomination and ask for you to vote for him.

Representative **FREDETTE** of Newport seconded the motion.

Representative **MOONEN** of Portland moved that nominations cease.

The Chair announced the result. 181 votes having been cast, 91 votes necessary for choice, the Honorable Aaron Frey of Bangor having received the majority of all votes cast, the Chair declared the Honorable Aaron Frey of Bangor duly elected to the office of Attorney General for the political years 2025 and 2026.

The CHAIR: Nominations are now in order for the office of State Auditor for the political years 2025 through 2028. The Chair recognizes the Senator from York, Senator Ingwersen.

Senator **INGWERSEN**: Thank you, Madam Chair. Madam Chair, I nominate Matthew Dunlap of Old Town for the office of State Auditor for the political years 2025 through 2028, and I wish to speak to my motion.

The CHAIR: The Member may proceed.

Senator **INGWERSEN**: I'm honored to stand before you all here today to nominate Matt Dunlap as State Auditor. I've only known Matt for a little over six years, when I first came here, but Matt has been here 30, and his qualities as a human being make me wish that I had been here far longer just to know him.

Matt began his 30-year career here at the State House when he was elected in 1996 as State Representative from Old Town, where he served until 2004. In 2004, Dunlap was elected to serve as Maine's 47th Secretary of State, for the first of what became seven terms; the second-longest serving Secretary in Maine's history. He was the first person since 1880 to serve non-consecutive terms as Maine's Secretary of State. He then took up his present job as our State Auditor.

Matt's reputation here around these halls centers on the incredible service that he's always provided to us as Members and to our constituents. It's what has made his time as State Auditor just as successful; he focuses on helping people, and this success shows. One of the requirements in Audit that I didn't know about is that they have to pass a national peer review; you could call it an audit for Audit; of their work every three years. The last review team from Missouri, South Carolina and Virginia gave Maine its highest-ever rating for the quality of their work. The folks at Audit will tell you that it's due in no small part to the good humor and support Matt brings to that office every day and the special dishes he cooks for the staff as well. That is Matt through and through.

Most of all, what I love about Matt Dunlap is the same thing that many of you who have known him for a while love about him; it's his dedication to serving the public, his curiosity, his sense of humor, his deep historical knowledge and his absolute, absolute generosity. When I first met him as a very busy Secretary of State, I found him sitting under one of the more obscure State House portraits that he had given me a long historical monologue about. In a brief bout of inspiration, and with no understanding at all of how busy the Secretary of State job was, I asked him if he would host a group of fourth graders coming up for a tour of my district. Without hesitation, he looked at me and said, sure. That is, in essence, Matt Dunlap. To whatever service that he has given to Maine, he's not just brought intelligence and hard work there, he's also brought with him what we need so very much these days; kindness, caring and good humor. And that is why I hope you will all join me in enthusiastically re-elect that man as our State Auditor. So, thank you all very much.

On motion of Senator **INGWERSEN** of York, the Honorable Matthew Dunlap of Old Town was placed in nomination for the office of State Auditor for the political years 2025 through 2028.

The CHAIR: The Chair recognizes the Representative from York, the incredible Representative Sargent.

Representative **SARGENT**: Thank you, Madam Chair. I'm delighted and proud to rise to second the nomination of Matthew Dunlap of Old Town to continue to be our State Auditor. I echo everything my good friend and the esteemed Senator from York has said already, and I am painfully aware that I am the final speaker of this Convention, so, I will hit only on some highlights

of what could be a very long salute to this very incredible man. But let me say a few things that I find incredibly striking.

Number one, Matt Dunlap is a hopeless overachiever. From the time that he says he was the section leader of both the concert band and the marching band of Mount Desert Island High School, to the two constitutional offices he has held for Maine. He is only one of five people in Maine's history to have held two constitutional offices, and he does it because of his relentless commitment to excellence and his hunger to learn and climb every mountain. He's also what I would call an indefatigable and skilled public servant. As the Senator mentioned, eight years in the Legislature, 14 years as Secretary of State, two years as State Auditor; I also went through his extensive resume and found that he has served on nearly 70; 7-0; committees and boards of Maine NGOs and national committees regarding electoral integrity. He also has been recognized with citations and honors from over 30 organizations at home and across the country for his excellence in government service. Among those was, of course, he was elected President of the National Association of Secretaries of State.

Another point is that Matt is a passionate champion of Maine. He loves everything about Maine. He loves our deer, he loves our salmon, he loves our trees and he loves all of our people, particularly the Native tribes, all the way through new Mainers. He also, of course, is a ferocious protector of our State, and he will continue to protect us by dotting all the I's and crossing the T's for all of our accounts, for all of our evaluations on federal grants, so that we can optimize what we can get for our State.

My final thing I love about Matt is; because I share it; is that he is a zealous historian. He just loves it. He will happily recount tales of varied Civil War Maine regiments who saved the Union. Those stories relayed how those men from rural Maine rose to the challenge and demonstrated the best versions of themselves.

My friends and colleagues on both sides of the aisle, this is our turn to demonstrate the best versions of ourselves, for the good of our State. I believe that Matt Dunlap of Old Town sets the example for us to follow. I hope you'll join me in supporting him.

Representative **SARGENT** of York seconded the motion.

Representative **MOONEN** of Portland moved that nominations cease.

On further motion of the same Representative, one vote was cast, on part of the Convention, for the Honorable Matthew Dunlap of Old Town for the office of State Auditor for the political years 2025 through 2028.

The Chair declared the Honorable Matthew Dunlap of Old Town duly elected to the office of State Auditor for the political years 2025 through 2028.

The House was called to order by the Speaker.

---

The SPEAKER: The Chair recognizes the Representative from Carmel, Representative Thorne, who wishes to address the House on the record.

Representative **THORNE**: Thank you, Mr. Speaker. For those that don't know me here in the House, my name is Representative Jim Thorne from Carmel, and I'm retired from the United States Air Force. I've talked to a lot of Representatives here over the years. Even though they may not have spent time in the military, they have relatives, parents, brothers, sisters, cousins that have spent time in the military, and if you'll please indulge me, I would like to share something with you.

In 2007, my father passed away. A couple months before he passed away, I sat him down at my camp and I interviewed him on a video recorder. I talked to him about many things. One of the things that I talked to him about is, does he remember Pearl Harbor Day? He said, yes. He says that was a very difficult time and period for everybody. It was not long after the Depression, they did a ration on everything. They rationed sugar, they rationed rubber tires, they rationed gasoline. Everybody pitched in to do what they could to win that war.

Today, we stand together to honor the memory of the men and women who gave their lives on December 7, 1941, an ordinary day that became extraordinary in its sorrow and its call to action. At 7:55 a.m. that morning, the quiet of Pearl Harbor was shattered by the sounds of explosions, the roar of planes overhead and the tragic realization that our nation was under attack. The surprise assault left 2,403 of our fellow citizens dead and nearly 1,200 more wounded. Ships sank, aircraft were destroyed, but most importantly, the sense of security in the United States was shaken. The attack on Pearl Harbor was not just an assault on a military base, it was an assault on our very way of life.

However, in the darkest hours of that day, we witnessed the unbreakable resolve of the American people; those who survived, those who rushed to the aid of their comrades, those who knew the fight ahead and the fight would be long and hard. They chose to stand tall and fight back. It was not fear that they saw in the eyes, but courage. It was not despair, but the relentless pursuit of justice and freedom. In the days that followed Pearl Harbor, Americans from every walk of life, every corner of this great land answered the call of arms. In the years that followed, the legacy of Pearl Harbor was not just one of loss, but one of triumph. We rose from the ashes of that tragedy to defeat the forces of fascism and imperialism. We rebuilt our nation and our alliances, securing a peace that would endure for generations to come, to this day. We did all of this, not because we were forced into it, but because we believed that freedom was worth fighting for. We believed in a world where justice would prevail.

As we reflect on Pearl Harbor today, we must not only remember the sacrifices of those who served and gave their lives, we must also renew our commitment to the values they fought to defend. We must remember that the strength of our nation lies not just in the might of our military, but in the resilience of our people and our ability to unite in the face of challenges. On this solemn anniversary, I ask you to join me in a moment of reflection to honor the bravery of those who fought and to renew our resolve to protect the freedoms that make this

country and this world a beacon of hope. May God bless the souls of those who fell at Pearl Harbor, and may God continue to bless the State of Maine and the United States of America. Thank you, Mr. Speaker.
