**JOINT RESOLUTION RECOGNIZING APRIL 2, 2019 AS NATIONAL SERVICE RECOGNITION DAY**

WHEREAS, service to others is a hallmark of the American character and is central to how we meet our challenges; and

WHEREAS, elected leaders are increasingly turning to national service and volunteerism as a cost-effective strategy to meet their needs; and

WHEREAS, AmeriCorps and Senior Corps participants address the most pressing challenges facing our communities, including educating students for the jobs of the 21st century, fighting the opioid epidemic, responding to natural disasters and supporting veterans and military families; and

WHEREAS, national service expands economic opportunity by creating more sustainable, resilient communities and providing education, career skills and leadership pathways for those who serve; and

WHEREAS, AmeriCorps and Senior Corps participants serve in more than 50,000 locations across the country, bolstering the civic, neighborhood and faith-based organizations that are so vital to our economic and social well-being; and

WHEREAS, national service participants increase the effectiveness of the organizations they serve, through both their direct service and their management of millions of additional volunteers; and

**READ.**

Representative SYLVESTER of Portland moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

Representative STEWART of Presque Isle **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Vassalboro, Representative Bradstreet.

Representative **BRADSTREET**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I rise today in opposition to the pending motion.

Violation of the Maine Human Rights Act is serious matters and we do take them seriously. Passage of this bill will dilute the true meaning and its original purpose. It's supposed to address acts that are considered egregious committed by a person or a group against another person or group, something that's demeaning to their value as a human being.

What this bill calls for is controlling an employer, a mom and pop employer to be included, from asking ahead of time what a person, a potential employee's pay was before they came to his place seeking employment. It may be a violation of a labor standard, if you will, but not of the Maine Human Rights Act. This is a bad bill. I hope you vote according to my light and defeat it. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Harpswell, Representative McCreight.

Representative **McCREIGHT**: Thank you, Madam Speaker. Madam Speaker, today is Equal Pay Day. A day I would really rather not have to celebrate. It marks the day when women will have earned the same amount as their male counterparts earned in the previous year. That means it took 15 months for a woman to earn what men did in 12 months. Nationally, white women earn about 82 cents for every dollar that white men earn. This disparity increases when comparing the earnings of white men and women of color. This bill would help change that. If you earned less than you were worth in

one job and then your next employer asks for your salary history, it's likely they will underpay you again.

Studies show that when employees are not allowed to talk to their colleagues about salary, they are unable to identify pay gaps and are underpaid. This bill prevents employers from using previous salaries as a basis of consideration for new workers and reaffirms that workers are allowed to discuss their wages. This helps workers find out if any of them are facing pay discrimination and prevents one act of pay discrimination from following a person through their entire career.

When Maine institutes this law and more states follow, we'll be a step closer to eliminating Equal Pay Day because we'll be able to celebrate women making the same salary as men all year long. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Bickford.

Representative **BICKFORD**: Thank you, Madam Speaker. Ladies and Gentlemen of the House, I didn't plan to speak to this but looking back on my career, when I hired employees, I wanted their pay history because I wanted to see what kind of employees they were in their past jobs, what did they start at and what did they end at? If they ended very close to what they started at, they may not have been a top performer. I paid my employees never based on their gender or their race or anything, I paid them based on their performance. Only on their performance. If they were an outstanding performer, they were going to make more money. And it was not fair for them to have their salary or their hourly wage known by other employees because they aren't equal; whether they're male, female, black, white, Indian, it doesn't matter. They are not equal except by the rate of their performance only. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Peoples.

Representative **PEOPLES**: Thank you, Madam Speaker. Madam Speaker, I rise to support the pending motion because all people deserve equal pay for equal work. We've heard about the pay gap between men and women and it's more severe for African-American women and Native American women and Hispanic women.

My whole career was spent in mostly male-dominated industries. I wish that I could say that employers always made choices about what to pay women based on experience, education, and credentials. But the truth is, more often than not, an employer will ask previous salary. How much did you make in your last job? And that's the question employers use to determine how much they'll pay the new employee. For women, people of color, and people with disabilities, it becomes almost impossible to break free from this discrimination. The housing and -- the Labor and Housing Committee listened carefully to the concerns from the employer community and we made changes to the legislation to address some of what we heard.

For example, the legislation is narrowly tailored. This is not a ban on free speech. After the employer has made an offer to the prospective employee and the compensation level has been set, they are free to ask questions about compensation history. Additionally, there is an explicit exemption for employers who are required to ask questions due to a specific federal or state law. For example, an economic development program or tax credit tied to hiring low-income people. In other words, the bill before you is narrowly tailored to achieve a compelling government interest. That is the government's interest in ensuring that all people are paid equal pay for equal work. This is a matter of basic fairness.

Our neighboring states, including Vermont, Massachusetts, Rhode Island, and Connecticut, have already passed similar laws. It is a fitting way to observe Equal Pay Day and it is my fervent hope that our granddaughters and great-granddaughters someday will receive equal pay for equal work, even though our generation and our daughter's generation have not. I hope that you will follow my light by voting green and passing this. Thank you.

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Rudnicki.

Representative RUDNICKI: Thank you, Madam Speaker. I didn't have any intention of rising today, but I do want to speak in opposition.

I want to tell a brief story and it happened recently. My own daughter is working in Massachusetts and she's working for a large company. She's at her year review and she recently -- she's sending me a text message last week going mom, they're at my review, they're offering me a 5% raise. I think I should get 10%. I go, go ask for it. You're a strong woman and if you're a strong woman, you're going to stand up and ask for what you think you deserve. And she -- but then she goes well, if I have to go to the president of the company and ask, you know, what should I do? I go, go ask for 15%. You're worth at least that much. She didn't even have to go speak with him. She asked for 15%, they gave it to her.

My thing is as a woman, as a strong woman, this isn't about equal pay, it's about doing your job, getting it done right, and getting paid what you deserve and asking for what you deserve. And as women, and that's what I rise about, as women we need to ask for that. So, it's not about equal pay, this is about small businesses and businesses taking care of themselves and paying people what they need to work. And for people to know what each other are making, it can cause hardship in a workplace. So, with that, I would thank you and ask you to oppose this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Sylvester.

Representative SYLVESTER: Thank you, Madam Speaker. I just wanted to clarify a few things for everybody, Madam Speaker. What this bill does is it prohibits employers from inquiring about compensation history until after an employment offer has been made and in terms of compensation for the prospective employee. And it does amend the Human Rights Act to provide that having asked compensation history can be used as a piece of evidence in an employment's discrimination claim and that would be a claim that would be persistent and ongoing.

This bill is, in my opinion, Madam Speaker, about equal pay for equal work, and one of the reasons is that pay inequality starts right out of college. 2016 data shows that one year out of college, women with a college degree working full-time make 18% less than men. The pay gap starts right away, so that even if an employer does not intend to discriminate, by basing a woman's pay on her prior pay, that initial gender gap is perpetuated so that even if everybody received a 15%, if you're starting lower right out of college and that's being used - that inquiry is being used to create your new pay rate, the gap is going to exist for the rest of a woman's career.

Similar laws exist in California, Connecticut, Delaware, Hawaii, Massachusetts, Oregon, Rhode Island, and Vermont. And, most importantly, is that it's not that you can never ask that question once a compensation offer has been put forward, you know, then that can certainly happen, it's just at that very beginning point to make sure that everybody starts on the same level and where, in many corporate climates, flat

percentages are moving through the -- as the new trend in compensation so everybody receives X; if you start behind, you're always going to be behind. Thank you, Madam Speaker.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

Representative **CROCKETT**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, I am honored to speak on behalf of the Portland and Yarmouth delegations about the life of John Menario.

My wife, Martha, and her siblings grew up with the Menario family in Portland's North Deering neighborhood. We count them as dear friends today. John was born in Portland, Maine, and lived his entire life in the State of Maine, only leaving to serve his country in the Army during the Korean Conflict, and going to the Wharton Graduate School at the University of Pennsylvania where he earned a Master's of Government Administration from the Fels Institute.

John spent his life as an independent, unenrolled voter, and strongly believed those working in city government should be nonpartisan. He was best known for being the city manager of Portland from 1967 through 1976, but he also had a rich history of serving the State of Maine.

He was appointed by Governor Longley to be a state labor mediator, where he traveled the counties, mediating municipal and state labor disputes. Under Governor Jock McKernan he served as chair of the Main Street 90 initiative. He served as a board member for the Maine Community Foundation from 1987 to 1989. With Bill Troubh, Harvey DeVane, and others, he worked to set up the first cabinet administration for Governor Joseph Brennan. And, finally, he was a good friend to Governor Baldacci, whose parents hired John as a bartender at their family restaurant in the late-1950s while he was an undergraduate at the University of Maine Orono.

Mr. Menario's wife and three children still reside in Maine, as do most of his grandchildren. Thank you, Mr. Speaker.

Representative **STROM**: Thank you, Mr. Speaker. I rise in objection to this pending motion because I truly believe that tax policy is the most complex legislation we do here and I don't feel like we should be giving that responsibility away. It is a great responsibility to -- for us to decide, because everything that we choose to spend the State's money on, we first have to take from somebody else, and that is a great responsibility and we don't always get it right the first time, that's why we amend bills along the way in committees and that on a referendum that is just something that you don't have the ability to do. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Monmouth, Representative Ackley.

Representative **ACKLEY**: Thank you, Mr. Speaker, my friends of the House. The testimony in this bill essentially inferred that we just can't trust the Maine voters with the level of understanding to make reasonable decisions on the complex issue of raising taxes in Maine, that somehow the voters just aren't up to this task. I'm confused, Mr. Speaker, because if Maine voters are truly of such limited capacity of understanding, then why does this bill allow voters to make decisions to lower taxes? It seems that if the premise is true, it should be true in both directions.

What was also said during testimony in committee is -- what's not being said, I should say, is that this piece of legislation if it were to succeed would prevent any citizen's initiatives costing money whatsoever from finding their way onto a ballot, effectively removing this check and balance, this constitutional check and balance, on the tyranny of future legislatures that refuse to act on issues that a majority of Mainers think is important policy.

There is actually one place where I believe both opponents and proponents of this measure agree that there is too much outside money in politics today. That is true, too much money coming into the State of Maine to influence policy decisions. But the question should be, would this solution, air quotes around solution, if that's okay with the rules, would this solution make this problem worse or better? We've got all sorts of fancy graphs and charts that show us that all the Citizens United money that comes in for initiatives, there's a lot of it. It seems, though, we have ignored what no one has been willing to ask, which is how much money is coming in from outside sources into the State of Maine to directly influence elections and the lobby? Because if we put a cork in the bottle of citizens initiatives, that's where the money will flow. If -- as our U.S. Supreme Court says, money is speech, if we must have unlimited political donations, then I personally would much prefer to have all this outside spending directly in front of the Maine voters who have a track record of showing that they are smart enough to know when they are being hoodwinked, whether it's Shady Shawn or Bloomberg's backgrounds or PETA's bear baiting or a 3% surtax for elder care, Maine citizens have shown how to say thanks but no thanks.

And so, for all of these reasons, Mr. Speaker, I'll be voting Ought Not to Pass today.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Auburn, Representative Bickford.

The bill is about two types of busses, school busses, and the ability for the local districts who own their own busses to make decisions about purchasing and managing their bus fleet. The first type of bus is type C and those can carry about 70 kids, versus type D, which are the transit busses, those are the ones driving around without a nose, and they can carry 85 students. Now, these cost about \$10,000 more but under the current policy these are the ones that are hard to come by. However, they do provide the larger capacity and can be more efficient and cost effective, especially in light of the bus driver shortage. Larger busses can eliminate the need for extra busses and specifically bus runs. So, I ask that you vote against this motion and allow the local control of purchasing and managing their bus fleet to go forward. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Oakland, Representative Perkins.

Representative **PERKINS**: Thank you, Mr. Speaker. I rise in opposition to this bill also.

This would enable the superintendents, the school districts -- of each and every school district, the managers of the school bus garage, to take and hire or -- not hire, I apologize, to buy and purchase their own busses acquired -- needed by them. This is the way it's set up right now, that the state mandates what busses you can have, what busses you can't have. There's a software program that they tell each and every school district what they have to use. It might not be as workable as the certain software that they do use. As we all know, there's a large shortage of bus drivers out here. The type C, which they call transit busses, will hold up to 85 passengers, as the Good Representative from Alfred said, and the type C busses would only hold about 74. Realizing yes, they do cost a little bit more, but this would allow the school

districts to do this. If they bought five busses, that would be one less school bus driver to have.

This would also take and help the districts in transporting the kids safe, efficiently, and effectively back and forth to home by using one less route. The software programs are, to say the least, cumbersome, and also, it's dictated by the state what program they're going to use and what program they're not going to use, which can be costly to each and every last one of our districts. This would help all of our constituents here, so I'd ask that you oppose this. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Bangor, Representative Kornfield.

Representative **KORNFIELD**: Thank you, Mr. Speaker. This bill wants to establish in statute the criteria for bus replacement and prohibit the Department of Education from using a specific brand of software for routing and transportation management. The Majority Ought Not to Pass Report was because the replacement of busses for transportation have been updated to match federal code, and the use of transportation software package or brand is a local choice.
