William Deering, of Bangor. Dr. Deering was a veteran of the United States Navy, having enlisted during World War II. He later became a psychologist and served as Chief Psychologist and Director of Psychological Services at Bangor State Hospital, leading the Program Directors for State and Federal Psychologists. After his retirement, he continued in private clinical practice for a few decades. He also served as a medic in the Army National Guard and retired as a colonel. He served as President of the Maine State Retarded Children Association and as President of the James A. Taylor Hospital Board of Trustees and was a founder of the New England College of Osteopathic Medicine. He was an active member of multiple charitable and other groups, including East Orrington Congregational Church and EOO's Ladies Aid, and organized many local Veterans Day and Memorial Day parades. More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Representative from Augusta may proceed.

Representative **FECTEAU**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I rise in opposition to the pending motion. In doing so, it's important for me to state my appreciation for those hardworking educators in the trenches everyday and those helping to make our standards better. These specific changes, as positive as they may be, thrust hundreds of hours of work on our local districts. Anyone who's put together a curriculum map that's mapped to standards feels that pain. Curriculum maps referencing these old standards will no longer be pointing to something that exists.

While teachers do their very best to give our students the skills they need, they are being failed when there is no legitimate K through 16 plan, no strategic plan for vertical integration, and no list of tangible outcomes. In committee, I asked where could I find a white paper, a statute, a strategic plan that states the 20, 30 or even 40 outcomes a Maine high school graduate has achieved. If one doesn't exist, from where are these standards arising? More importantly, where are they heading? Do the ending 12th grade standards line up with postsecondary paths of our Maine graduates? If so, from which postsecondary institutions were these standards taken? Where may I reference these standards and suggestions for vertical alignment from K through 16, K through 14 and K through career? Somewhere in our strategic plan, it should state something to the effect of beyond instruction in the content areas and essential instruction in Section 6209 and 4722, a successful high school graduate can, and then it would list our outcomes that we can see, outcomes that our students and parents can visualize, our teachers can vertically align, our business partners can expect, and our postsecondary institutions know because it's their work and also their beginning standards. Then, and only then, can we chip away at our current 40% of students entering the community college system that require remedial math instruction before they can even begin their collegiate journey. Thank you.

While specific reporting exemptions exist for palliative care, hospice and end-of-life care, the Department of Health and Human Services should create a specific exemption reporting code for prescriptions written and dispensed in compliance with Public Law 2019, Chapter 217, the Maine Death with Dignity Act. Prescriptions for self-administration to end a qualified patient's life are very different from prescriptions written and dispensed for comfort care. I have many other concerns, but in respect for our time today, I will refer you to the testimony of Northern Light Health, Lisa McPherson. Personally, I don't want my fingers on anything that I feel embraces the culture of death. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from York, Representative Hymanson.

Representative **HYMANSON**: Thank you. I wanted to address that concern because there is no code that's needed. This is end-of-life care. There is an end-of-life code in the PMP. That sounds too wonky; I'm sorry about that. But the code is in there for end-of-life care and this is end-of-life care. So, I wanted to talk about that. The other is that this law was signed in on June 12th by the Chief Executive, and then she very smartly put in data reporting that started so that the law went into effect on September 19th would have the proper data that was being recorded. So, this emergency rule is really just about data, it is not about the bill itself, and the CDC has collected information looking at research from the same laws in Vermont and Oregon. Oregon has had this law for 25 years and they have done their due diligence with creating the appropriate forms, they're online on the website, and Maine Health, the large medical system that has a process in place, has no operational issues with this rule for data reporting. These data reporting requirements duplicate the existing emergency rule and I look for your support. Thank you, Madam Speaker.
